The Federal Bureau of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Bureau does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Federal Bureau of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act  
Interstate transportation of stolen property valued at \$5,000 or more  
National Bankruptcy Act  
Interstate flight to avoid prosecution or testifying in certain cases  
White Slave Traffic Act  
Impersonation of Government Officials  
Larceny of Goods in Interstate Commerce  
Killing or Assaulting Federal Officer  
Cases involving transportation in interstate or foreign commerce of  
any persons who have been kidnaped  
Extortion cases in which interstate commerce or interstate communication  
is an element  
Theft, Embezzlement or Illegal Possession of Government Property  
Antitrust Laws  
Robbery of National Banks and Member Banks of Federal Reserve System  
National Bank and Federal Reserve Act Violations, such as embezzlement,  
abstraction or misapplication of funds  
Crimes on any kind of Government reservation, including Indian Reserva-  
tions or in any Government building or other Government property  
Neutrality violations, including the shipment of arms to friendly nations  
Frauds against the Government  
Crimes in connection with Federal Penal and Correctional Institutions  
Perjury, embezzlement, or bribery in connection with Federal Statutes or  
officials  
Crimes on the high seas  
Federal Anti-Racketeering Statute  
The location of persons who are fugitives from justice by reason of vio-  
lations of the Federal Laws over which the Bureau has jurisdiction,  
of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforce-  
ment officials concerning the above listed violations is promptly forwarded  
to the Special Agent in Charge of the nearest field office of the Federal Bu-  
reau of Investigation, U. S. Department of Justice. If the information indi-  
cates that immediate action is necessary, telegrams marked "Government Rate Col-  
lect" or telephone calls will be accepted. The address of each of the Field Of-  
fices of this Bureau appears on the inside back cover of this bulletin.



I desire at this time to invite the attention of law enforcement officials to the increased use of air mail facilities to expedite the receipt of information desired in any case.

The Bureau recently has adopted the practice of using air mail in answering fingerprints in which identifications have been made on fingerprint cards forwarded from the more distant points, and particularly by officers west of the Mississippi River. The air mail is used in these cases even though the prints are not received by air mail. However, only "arrest" prints are answered in this manner, i. e., prints taken at the time of any arrest and not in the case of "prison" prints, which are taken when a person is received in a penal institution or transferred from one institution to another. The air mail postage on these records is paid by the Bureau and the practice outlined has been adopted because of the Bureau's desire to afford prompt service in the case of identified "arrest" fingerprint records submitted by interested officials.

I desire also to point out at this time the fact that air mail receipts of fingerprints have increased tremendously within recent months and I would like to invite the attention of those departments which are not now using the air mail to the possible desirability of forwarding certain records of an emergency nature to the Bureau in this manner. The transmittal of prints by the air mail expedites their arrival in Washington. Further, the use of special delivery postage insures delivery by the Post Office Department at night, on Saturday afternoons, on Sundays, and on holidays. Air mail postage without special delivery postage does not guarantee delivery after regular postal service hours. It is noted in this connection that all fingerprints received in the Identification Division, regardless of their point of origin, are answered by the Identification Division in the same manner in which they are received, i. e., prints received by air mail are answered by air mail and those received by special delivery are answered by special delivery. The Bureau in each instance provides for the return postage. It is felt that it would be desirable to forward any special matters by special mail to the Bureau. Such action with the aid of the reply in like manner would insure the most expeditious handling.

It is hoped that through this expansion of the air mail service, more effective attention can be given to records and requests for information forwarded to the Bureau by law enforcement officials.

## WALTER MATHIS

ESCAPED LIFE TERMER FOR FIRST DEGREE MURDER, UNDER ARREST  
FOR INVESTIGATION, IDENTIFIED AS FUGITIVE BY NOTICE  
IN FUGITIVE BULLETIN

A wanted circular was received in the Federal Bureau of Investigation from the State Penitentiary at Boise, Idaho, on October 8, 1934, containing information that Walter Mathis was wanted as an escape from that institution. This person had been received at the Idaho State Penitentiary in April, 1928, to serve a life term for first degree murder. The wanted circular issued by the Idaho authorities stated that he had effected his escape on September 30, 1934. On the receipt of this information a wanted notice was posted in the fingerprint files of the Bureau against the record of Mathis. Moreover, a notice of his fugitive status was published in the December, 1934 issue of the bulletin, "Fugitives Wanted by Police".

A fingerprint card was received in the Bureau on January 16, 1935, from the Sheriff's Office at Phoenix, Arizona, whereon it appeared that George Walter Madison had been arrested by that office on January 10, 1935, on a charge of investigation. Information accompanied this fingerprint card to the effect that when Madison's fingerprints were taken, after his arrest by that office, they were compared with finger impressions appearing in the Fugitive Bulletin. On this comparison, they were found to be identical with those of Walter Mathis, the escaped life termers from the Idaho Penitentiary.

When the fingerprints from the Sheriff's Office at Phoenix, Arizona, were searched against the fingerprint files of the Bureau, the identification referred to above was confirmed and the Sheriff's Office at Phoenix, Arizona, was, of course, notified of this fact. Moreover, the authorities of the Idaho State Penitentiary were advised of the arrest of this person at Phoenix.

The above case is but one of many that have come to the attention of the Bureau wherein notices in the Fugitive Bulletin have been instrumental in identifying persons under arrest as being wanted. Identification Officers and law enforcement agencies throughout the country, in constantly increasing numbers, are making complete use of the data appearing in this bulletin. Such cases as the one set out above are exemplary instances of the value of this bulletin when arrests are made for investigation and the officers desire to know immediately whether the person under arrest is wanted.

## INTERESTING IDENTIFICATION

CLAUDE S. OWENS

NOTICE IN FUGITIVE BULLETIN INSTRUMENTAL  
IN IDENTIFYING ESCAPED LIFE TERMER

The files of the Identification Division of the Federal Bureau of Investigation reflect that Claude S. Owens was arrested by the Police Department at Birmingham, Alabama, on July 10, 1919, on a charge of highway robbery, and on October 1, 1919, was sentenced to serve a term of life and one hundred years in three cases of robbery. A wanted circular was received in the Identification Division from the State Convict Department, Montgomery, Alabama, on February 20, 1933, containing information that Owens had effected his escape from prison on February 6, 1933. Accordingly, a notice of the fugitive status of this individual was posted in the fingerprint files of this Bureau. Moreover, a notice of the fact that this person was wanted by the Alabama authorities was published in the April, 1933, issue of the bulletin entitled "Fugitives Wanted by Police".

A fingerprint card was received in the Bureau from the Police Department at Kansas City, Missouri, on January 18, 1935, whereon it appeared that Claude Stanston Owens, whose finger impressions appeared on this card, had been arrested by that department on January 10, 1935, on a charge of investigation. This card contained a notation that by means of a notice appearing in the Fugitive Bulletin this person had been found to be identical with Claude S. Owens, the escaped life termmer from Alabama. This fingerprint card was searched against the files of the Identification Division of the Federal Bureau of Investigation and the identification of this individual with the fugitive from Alabama was confirmed. Subsequent information has been received that Owens was returned to the Alabama authorities on January 14, 1935.

The above case is an interesting illustration of the results that may be obtained by systematic use of data appearing in the Fugitive Bulletin. In cases where law enforcement authorities have persons under arrest on minor charges and desire to ascertain immediately whether or not such persons are wanted the Fugitive Bulletin is practically an indispensable means of making such determinations. The Federal Bureau of Investigation heartily encourages the use of this bulletin and solicits any suggestions as to how it may be improved so as to be of more value to Peace Officers.

OFFENSES KNOWN TO THE POLICE  
January and February, 1935

There is presented in the following table the number of offenses reported for January and February, 1935, by the police departments of 76 cities with a combined population of 24,836,512. The figures are also presented in the form of daily averages. In view of the difference in the number of days in those two months, it is recommended that the daily averages be used in making comparisons of the amount of crime reported for those two months.

The compilation discloses moderate increases in the daily average number of offenses of murder and aggravated assault during February and slight increases in the figures for burglary, larceny, and auto theft. Rather substantial decreases are shown for the remaining offense classes.

It should be observed that for offenses of manslaughter by negligence and larceny, the figures are based on the reports from the number of cities indicated in the footnotes to the table.



## CRIMINAL IDENTIFICATION WITH RELATION TO PLASTIC SURGERY

The circumstances surrounding the final arrest of Dillinger raise the question of the possibility of hampering criminal identification by means of plastic surgery. It is worthwhile for police officers and physicians to consider to what extent reconstructive surgery can alter the appearance, to learn the tell-tale marks such alterations leave and to attempt to devise measures to prevent the performance of surgery in order to frustrate the law.

Each human being is supplied by nature, several months before birth, with an elaborate identification tag, absolutely individual to himself and impossible to duplicate, which he carries throughout life and even for some time after death. This is the system of epidermic ridges that covers the entire palmar surface of the hands and the soles of the feet. The character of these friction ridges is strongest on the balls of the fingers, where they form a strong pattern of loops, whorls and arches. The design is different, not only for each person but for each digit of the same person; and the evidence of a single finger tip is sufficient to establish an absolute identification.

The finger prints cannot be destroyed by linear scars or by any burns of less than third degree. It is not feasible to replace the skin on the finger tips with grafts from any other part of the body as the skin on the palms and soles has a unique structure and the substitution would be too apparent. Besides, ten separate grafts would have to be performed. It is true that a suspect in a capital case, with fingerprints the principal evidence against him, might subject himself to a third degree burn on each finger tip. Such devices to prevent identification would be avoided by taking the imprint of the whole palm instead of just the last phalanx of each digit.

While the friction ridges are the most absolute method of establishing identity, their evidence cannot be put to practical use unless the suspect is apprehended. Even after the identity of a criminal has been established by fingerprints, the police must usually rely on sight recognition to make the arrest.

The difficulties of sight recognition are many and varied. The same person may look different at various times or there may be strange and baffling resemblances between totally unrelated people. The difficulties of sight recognition are intensified today by the fact that plastic surgery can permanently and painlessly alter most of the features of the face. Fortunately each change is accompanied by some scarring, no matter how cleverly concealed; and in suspicious cases detectives should be trained to look for those scars.

The topography of the forehead can easily be changed by the insertion of a cartilaginous or dermo-fat graft beneath the skin, through an inconspicuous incision above the hairline. The thin scar and a palpable mass beneath the surface indicate that reconstructive surgery has been performed.

Any type of nose can be strikingly changed by the endonasal route. The dimensions of the nose can be changed in all its diameters; the bridge can be raised or flattened; the contour of the nostrils can be altered. When extensive changes are made there are corresponding alterations in the contour of the adjoining parts. However, a thorough search of the mucous membrane by

someone experienced in this type of work will reveal a linear scar, flat or thickened. Removal of osteocartilaginous tissue results in callous formation over the bridge which can be felt through the skin. The presence of a bony or cartilaginous graft, or of any implant, is also easily detected.

Hypertrophic lips due to excessive development of the red of the lip may be reduced by the excision of crescent shaped fragments from the mucous membrane. The scar is plainly visible on the inside of the mouth. An under-developed jaw can be enlarged by the insertion of a dermo-fat graft and a prognathic chin can be reduced by sawing off crescentic fragments of the jawbone. In either case the scar is concealed in the fold beneath the chin.

The ear, which is one of the most important features of the face from the point of view of identification, can be changed in all its most characteristic points. Its size can be altered symmetrically by excising fragments of skin and cartilage; the lobes can be joined to or detached from the cheeks. Scars must be hunted for very painstakingly as they can be cleverly concealed in the numerous grooves and depressions of the auricle.

"Face-lifting" makes identification more difficult by eradicating characteristic bags, folds and wrinkles and by imparting a fictitious air of youth; but it can hardly be said to conceal identity for it leaves the features untouched. Furthermore, the hairline scar can always be traced.

Scars, birthmarks, tattooing, etc., once prominent features of the Bertillon system of identification, can now be almost completely eradicated, and for the most part without conspicuous scarring. The deformity is excised and the surrounding skin undermined and stretched to cover the defect.

There can be no doubt of the possibility of effectively disguising the appearance by means of plastic surgery and the police should cooperate with reputable plastic surgeons to prevent the use of this specialty for such purposes. In suspicious cases the surgeon should be on file with both local police and the Department of Justice. When a dangerous criminal is being hunted, particularly if he has a striking facial trait whose obliteration would make sight recognition difficult, the descriptive circular issued by the police could be sent to plastic surgeons to put them on their guard.
