The Federal Bureau of Investigation, United States Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act
Interstate transportation of stolen property valued at \$5,000 or more
National Bankruptcy Act
Interstate flight to avoid prosecution or testifying in certain cases
White Slave Traffic Act
Impersonation of Government Officials
Larceny of Goods in Interstate Commerce
Killing or Assaulting Federal Officer
Cases involving transportation in interstate or foreign commerce of any persons who have been kidnaped
Extortion cases in which interstate commerce or interstate communication is an element
Theft, Embezzlement or Illegal Possession of Government Property
Antitrust Laws
Robbery of National Banks, insured banks of the Federal Deposit Insurance Corporation and Member Banks of Federal Reserve System
National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds
Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property
Neutrality violations, including the shipment of arms to friendly nations
Frauds against the Government
Crimes in connection with the Federal Penal and Correctional Institutions
Perjury, embezzlement, or bribery in connection with Federal Statutes or officials
Crimes on the high seas
Federal Anti-Racketeering Statute
The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

The Bureau does not have investigative jurisdiction over the violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

Law enforcement officials possessing information concerning violations over which the Bureau has investigative jurisdiction are requested to promptly forward the same to the Special Agent in Charge of the nearest field division of the Federal Bureau of Investigation, United States Department of Justice. The address of each field division of this Bureau appears on the inside back cover of this bulletin. Government Rate Collect telegrams or telephone calls will be accepted if information indicates that immediate action is necessary.

A definite movement toward the police laboratory is under way. This movement which had its beginning only a few years ago has continued to grow, and now it is gratifying to observe the increasing appreciation on the part of the criminal investigators and prosecutors of the need for scientific examination of physical evidence to make audible in court the perjury-proof testimony of otherwise mute matters.


The modern scientific methods which police officials have employed keep abreast of the times. The investigator applies to criminal investigations those developments of modern civilization which may be of assistance in determining the facts in his case.

Scientific crime detection has developed extensively during the last five years. Scientific aids were used prior to this time, but there had been no definite attempt to organize science in relation to crime detection agencies until recently. As its importance grew, it was found advisable to make available to American law enforcement, without charge, a crime detection laboratory manned by qualified efficient technicians.

Acting to meet this need, the FBI established a technical and research laboratory to assist in the current criminal investigations conducted by the Bureau's special agents, and to aid police and law enforcement officers generally, in matters involving the scientific examination of evidence.

This laboratory is used without cost by local, state, and municipal law enforcement organizations. During the 1937 fiscal year the laboratory examined 33,785 specimens of evidence, lending assistance to local and state law enforcement organizations in 897 instances.

The future will witness an ever-increasing efficiency in scientific crime detection and establishment of proof through similar methods. As the police sciences are better organized, procedures now in the experimental stage will become established practices. Additional research will continue to advance the cause of justice.

THE POLICE AND THE PUBLIC

Police organizations, in these days of continuous and universal public interest in the progress of law enforcement activities, must perforce devote increasing attention to the vitally important factor of relations with the citizens of their communities. Upon the maintenance of appropriate relations with the public depends the question as to whether there shall develop a real respect and admiration for and cooperative spirit with the members of a police organization, or on the contrary, dislike, antagonism and criticism, with the evils that follow public disapproval.

What is the primary characteristic or quality that a police officer must reflect in order to win the proper degree of approval, admiration and respect from the public? Obviously, he must be efficient. There is no surer way of continuing permanent public approval than by the demonstration of efficient service. A police officer is the guardian of the public welfare, the protector of the property and of the lives of the members of his community. It is necessary that the public possess a vital and lasting confidence in the ability of its police defenders and protectors to apply the principles of modern law enforcement in an effectively efficient manner. No preaching of courtesy, no ingratiating manner of approach, individually or collectively, can be substituted in modern law enforcement for a real detailed, comprehensive knowledge of law enforcement methods and policies, in order that the respect of an individual community may be won and maintained.

It necessarily follows that a police officer, therefore, should avail himself of every possible opportunity to become acquainted with the fundamental rules and policies of the law enforcement profession, should maintain a continuing interest in his work, should seek to know all new, approved modern methods that may be evolved from time to time, should keep abreast of any and everything that would appear to be of service to him in the practice of his profession, and should look upon himself as a scientific specialist who is cognizant of and who will practice in the most approved scientific fashion the principles of crime detection.

No law enforcement officer can rely upon the reputation that he may have merited and attained in the past. He must be increasingly efficient in order to sell himself and his organization to the public.

Granted that efficiency is attained and maintained--what next? Even efficiency must be sold to the public. Efficiency may be of a type that may render its possessor unpopular. Efficiency, lacking the human, social qualities, is almost sure to make the possessor unpopular. It has been noted that in many law enforcement organizations there have been courtesy drives. The necessity for unfailing, uniform courtesy in the relations of the members of these organizations with the public has been emphasized. The quality of tact has also received due recognition along these lines.

It is felt, however, that these considerations may be regarded as somewhat superficial. Qualities such as these tend to become strained and often vanish in the storm and stress of sudden emergencies, and a law

enforcement officer's life consists of one emergency after the other. We would rather emphasize the necessity for the possession of a fundamentally sympathetic attitude on the part of a law enforcement officer toward his fellow men, and particularly toward those with whom he comes in official contact. To this fundamental sympathetic attitude should be joined the development of a strictly judicial manner of passing upon all experiences. The two balancing and supplementing characteristics or qualities should be the dominating factors in rendering the relations of a law enforcement officer with the public efficiently, sympathetically, attractively effective. Without sympathy human relations become formal and mechanized, and tend to develop that egotism which is the fundamental cause of all the friction in human relations. The police officer who is sympathetic is the best judge of human nature, inasmuch as in order to properly understand human nature one must view it sympathetically with due regard to underlying motives, as well as superficial functioning. No man who does not sympathize with his fellows can ever hope to understand them.

Sympathy permitted to run wild, of course, becomes weakness. After all, it is the duty of a law enforcement officer to aid in the enforcement of law, and he should never forget that basically he is a servant of justice and that he should be judicially minded in accordance with the age-old ideal of justice.

Negatively, a police officer should never be egotistical. He should never be in any manner consumed with a sense of his official importance. He has no official importance. Upon him devolves the privilege and responsibility of serving the public, as well as defending the public. It is as a public servant and as a public defender that his vocation or profession becomes of definite importance.

Let us endeavor to apply the foregoing along practical lines. Probably one of the greatest, most prevailing, causes of police or law enforcement unpopularity arises from the enforcement of the traffic laws. The position of any law enforcement officer or law enforcement organization is peculiarly difficult in the proper enforcement of traffic regulations so that the members of the public may be properly protected from the carelessness, criminal and otherwise, of those possessing and driving these modern implements of death, and at the same time so that those who violate these regulations may be impressed, not with the ill temper or arrogance of the traffic officer, but with his kindly, unprejudiced, judicial, quietly effective functioning.

Many of our citizens are for some reason inclined in many instances to feel aggrieved at what they often characterize as an entirely over-personalized form of arrogance on the part of some law enforcement officers in correcting traffic violations and in handling traffic violators. As a law enforcement organization, we, of course, recognize not only the difficulty of the situation but the unfairness of the public.

Law enforcement officers know the universality of the tendency on the part of otherwise law abiding and law respecting individuals to vio-

late traffic laws, and there is something about sitting at the wheel of an automobile that renders the individual impervious to considerations, not only of law observance, but of the ordinary decencies which require proper consideration for the safety of the men, women and children who must use our public highways. Men and women who would never think of violating laws which they recognize do continuously flout, whenever and wherever they think the flouting is without danger to themselves, any and every traffic law or regulation.

The proper handling of this problem requires a degree of sympathy with weak, erring, egotistical human nature that a law enforcement officer must develop. It requires firmness, but a quiet, unostentatious, diplomatic, judicial firmness which will impress upon the violator the necessity for observing the regulations and instructions of the officer, and at the same time leave no room for personal resentment either at the officer's unfairness or the personal manner of the latter. It is the manner in which traffic violations are enforced by the individual officer which causes by far the greater part of the resentment felt by the average citizen to the police.

Probably the phase of law enforcement which is second in importance with regard to its effect upon the public and the public's opinion of the intelligence and fairness of the police is that which deals with the testimony in court of law enforcement officers. Here we come in contact with the public as represented by the judge, a highly influential member of the community, the jury, a cross-section of every phase of local activity, the courtroom spectators, and functioning attorneys. Too often has opportunity been afforded for charges of favoritism and prejudice on the part of a few law enforcement officers. Happily these conditions have been ameliorated during the past decade.

It is on the witness stand that a law enforcement officer may exemplify the best in law enforcement. Here again he should be efficient, and efficiency on the witness stand consists, first, in possessing the benefit of a comprehensively thorough, detailed and accurate investigation. Based thereon the law enforcement officer should have so absorbed all the details of the matter concerning which he must testify as to be able to relate these essentials in reply to examination and cross-examination in such a manner as to avoid any possible hesitation, obscurity or inaccuracy. He should have reviewed and know thoroughly not only every detail of the case before the court, but should be conversant with practically any and every inference that might be drawn therefrom, in order to properly place the facts before the jury and avoid any effort on the part of inimically inclined counsel to place undue emphasis upon the facts as related by him. In addition thereto he must reflect a dispassionate poise and an absolutely judicial mentality in his testimony. It cannot be stated too emphatically that the police officer in this instance is a witness. As such he is serving the court and the jury by testifying to facts within his knowledge. He is not a prosecutor, nor is he concerned with the prosecution to any greater extent than is implied by a simple, fair and accurate narration of the facts as he knows them. He should not indicate to the court or the jury that he is in any manner prejudiced, even though, from a law enforcement standpoint,

it might seem that the case is one which would warrant a natural prejudice. He should be concerned with affording to the defense any information which may be due it, even though these facts or the inferences to be drawn therefrom may harm the prosecution. He is while testifying a judicial officer, part of the judicial system, and is as much concerned with seeing that justice is afforded the defense as that the interests of the prosecution are served by his proper testimony. He should display no eagerness to place before the jury facts condemnatory of the defendant. He should be fair, impartial, clear, decisive, accurate. There is probably no better or greater opportunity for a modern law enforcement officer to demonstrate the high character of the law enforcement profession and the intelligence and standing of modern law enforcement officers than on the witness stand.

We can display the same attitude, comprising the elements of sympathy and judicial impartiality intelligently applied, in connection with the officer's dealings with criminals themselves and with those connected with them. Criminals should be punished. Those committing crimes should be speedily apprehended and the courts should be supplied with the information requisite to such continued incarceration as the law requires. There need not however, be any definitely personal antagonism displayed by the modern police officer in the performance of his duties. He should be firm, of course. He need not be personally unsympathetic. If it is possible to afford any courtesies to a defendant criminal's family which will not in any manner hinder proper law enforcement, these courtesies should, of course, be shown. Many criminals who come in contact with the punishing arm of the law are fortunately saved to society by the knowledge of the law's efficacy, and such individuals will bear witness all through their lives to the fairness and courtesy shown them by efficient law enforcement officers. There is nothing, too, that will so convince the unfortunate relatives of malefactors of the judicial impartiality and kind personal sympathy of the police as the display of these characteristics in their time of need. These men and women are constituent parts of our individual communities and their favorable opinion may be and often is of definite value to law enforcement organizations.

The opportunities for contact with the public on the part of the modern law enforcement officer are far more numerous today than ever before in the history of our profession. Contact is effected with schools and various institutions of learning in such a manner that the younger children themselves soon learn to look upon the police officer not only as a protector but a friend. This contact should, of course, be extensively developed. The connection of police officers with boys clubs and kindred organizations in various sections of the country is a highly important and beneficial sign of the development of law enforcement itself into a phase of activity that will make it second to none in importance in our individual communities. The appearance of law enforcement officers before groups interested in civic development and betterment is also a phase of modern law enforcement that possesses unlimited opportunities for good.

Space does not permit of further detailed analysis of opportunities such as these. The characteristics outlined, however, of efficiency,

sympathy, and judicial, intelligent fairness, applied to any and all contacts of the police officer with the public, will serve to win personal approval, public respect, and universal acclaim for our modern police.

FBI PLEDGE FOR LAW ENFORCEMENT OFFICERS

In the December, 1937, issue of the FBI Law Enforcement Bulletin there was the announcement of the FBI Pledge for Law Enforcement Officers. Since that date hundreds of the unsigned Pledges have been distributed to law enforcement officers throughout the United States who returned them only a few days later fully signed so they might be filed with like Pledges of hundreds of other officers who seek to maintain the same high ideals in their chosen profession.

One Chief of Police advised that: "All members of this Police Department voluntarily signed this Pledge and were very happy to do so. In my opinion, this Pledge will do much to bring about more efficiency in police departments and a better understanding of the duties which police officers have to perform. It is the finest pledge which I have read and we appreciate the opportunity of submitting to your office the signed Pledges."

A member of a western Police Department advised that: "I am interested in signing the Pledge for law enforcement officers as published in the December, 1937, issue of the FBI Law Enforcement Bulletin. Other officers of this organization have made it known that they, too, would like to sign it. Would you be so kind as to send about ten copies to this department." From the west coast a wire was received at the FBI Headquarters as follows: "Pleased to inform voluntary enrollment hundred forty two members in Police Academy at the close of first week sessions. . . All Academy members have signed FBI Pledge for Law Enforcement December issue Bulletin."

A desk Sergeant in one of our eastern cities wrote: "I look upon this pledge as something very near and dear to myself and my department, and I can pledge myself and the five men here in my department, who constitute the Bureau of Investigation, to its ideals. Though we have never had the opportunity of seeing or reading this FBI Pledge, we have lived up to its principles in each and every instance in the performance of our duties. And it is our desire to place in your hands these pledges whereby you may have the opportunity at any time of knowing that there lives in this vicinity a group of men willing to accept the Pledge of the Department of Justice -- that you might personally know them as servants of the public; and that you and your Agents may feel that we, as members of the Bureau of Investigation, stand ready and willing at all times to render the services based upon the principles of our chosen profession as described in the FBI Pledge."

These statements give some indication of the wholehearted reception with which this Pledge was met. A copy of it is reproduced on the accompanying page. There are additional copies of the Pledge available to law enforcement organizations whose members desire to sign them.



THE FBI PLEDGE FOR LAW ENFORCEMENT OFFICERS

HUMBLY RECOGNIZING THE RESPONSIBILITIES ENTRUSTED TO ME, I DO VOW THAT I SHALL ALWAYS CONSIDER THE HIGH CALLING OF LAW ENFORCEMENT TO BE AN HONORABLE PROFESSION, THE DUTIES OF WHICH ARE RECOGNIZED BY ME AS BOTH AN ART AND A SCIENCE. I RECOGNIZE FULLY MY RESPONSIBILITIES TO DEFEND THE RIGHT, TO PROTECT THE WEAK, TO AID THE DISTRESSED, AND TO UPHOLD THE LAW IN PUBLIC DUTY AND IN PRIVATE LIVING. I ACCEPT THE OBLIGATION IN CONNECTION WITH MY ASSIGNMENTS TO REPORT FACTS AND TO TESTIFY WITHOUT BIAS OR DISPLAY OF EMOTION, AND TO CONSIDER THE INFORMATION, COMING TO MY KNOWLEDGE BY VIRTUE OF MY POSITION, AS A SACRED TRUST, TO BE USED SOLELY FOR OFFICIAL PURPOSES. TO THE RESPONSIBILITIES ENTRUSTED TO ME OF SEEKING TO PREVENT CRIME, OF FINDING THE FACTS OF LAW VIOLATIONS AND OF APPREHENDING FUGITIVES AND CRIMINALS, I SHALL GIVE MY LOYAL AND FAITHFUL ATTENTION AND SHALL ALWAYS BE EQUALLY ALERT IN STRIVING TO ACQUIT THE INNOCENT AND TO CONVICT THE GUILTY. IN THE PERFORMANCE OF MY DUTIES AND ASSIGNMENTS, I SHALL NOT ENGAGE IN UNLAWFUL AND UNETHICAL PRACTICES BUT SHALL PERFORM THE FUNCTIONS OF MY OFFICE WITHOUT FEAR, WITHOUT FAVOR, AND WITHOUT PREJUDICE. AT NO TIME SHALL I DISCLOSE TO AN UNAUTHORIZED PERSON ANY FACT, TESTIMONY, OR INFORMATION IN ANY PENDING MATTER COMING TO MY OFFICIAL KNOWLEDGE WHICH MAY BE CALCULATED TO PREJUDICE THE MINDS OF EXISTING OR PROSPECTIVE JUDICIAL BODIES EITHER TO FAVOR OR TO DISFAVOR ANY PERSON OR ISSUE. WHILE OCCUPYING THE STATUS OF A LAW ENFORCEMENT OFFICER OR AT ANY OTHER TIME SUBSEQUENT THERETO, I SHALL NOT SEEK TO BENEFIT PERSONALLY BECAUSE OF MY KNOWLEDGE OF ANY CONFIDENTIAL MATTER WHICH HAS COME TO MY ATTENTION. I AM AWARE OF THE SERIOUS RESPONSIBILITIES OF MY OFFICE AND IN THE PERFORMANCE OF MY DUTIES I SHALL, AS A MINISTER, SEEK TO SUPPLY COMFORT, ADVICE AND AID TO THOSE WHO MAY BE IN NEED OF SUCH BENEFITS; AS A SOLDIER, I SHALL WAGE VIGOROUS WARFARE AGAINST THE ENEMIES OF MY COUNTRY; OF ITS LAWS, AND OF ITS PRINCIPLES; AND AS A PHYSICIAN, I SHALL SEEK TO ELIMINATE THE CRIMINAL PARASITE WHICH PREYS UPON OUR SOCIAL ORDER AND TO STRENGTHEN THE LAWFUL PROCESSES OF OUR BODY POLITIC. I SHALL STRIVE TO BE BOTH A TEACHER AND A PUPIL IN THE ART AND SCIENCE OF LAW ENFORCEMENT. AS A LAWYER, I SHALL ACQUIRE DUE KNOWLEDGE OF THE LAWS OF MY DOMAIN AND SEEK TO PRESERVE AND MAINTAIN THE MAJESTY AND DIGNITY OF THE LAW; AS A SCIENTIST IT WILL BE MY ENDEAVOR TO LEARN ALL PERTINENT TRUTH ABOUT ACCUSATIONS AND COMPLAINTS WHICH COME TO MY LAWFUL KNOWLEDGE; AS AN ARTIST, I SHALL SEEK TO USE MY SKILL FOR THE PURPOSE OF MAKING EACH ASSIGNMENT A MASTERPIECE; AS A NEIGHBOR, I SHALL BEAR AN ATTITUDE OF TRUE FRIENDSHIP AND COURTEOUS RESPECT TO ALL CITIZENS; AND AS AN OFFICER, I SHALL ALWAYS BE LOYAL TO MY DUTY, MY ORGANIZATION, AND MY COUNTRY. I WILL SUPPORT AND DEFEND THE CONSTITUTION OF THE UNITED STATES AGAINST ALL ENEMIES, FOREIGN AND DOMESTIC; I WILL BEAR TRUE FAITH AND ALLEGIANCE TO THE SAME, AND WILL CONSTANTLY STRIVE TO COOPERATE WITH AND PROMOTE COOPERATION BETWEEN ALL REGULARLY CONSTITUTED LAW ENFORCEMENT AGENCIES AND OFFICERS IN THE PERFORMANCE OF DUTIES OF MUTUAL INTEREST AND OBLIGATION.

TRANSMISSION OF BLOOD STAINED EVIDENCE TO THE LABORATORY FOR EXAMINATION

The duty of collecting and preserving evidence imposes upon the investigating officer a serious responsibility, particularly in those instances where blood stained evidence is found. The prompt and proper transmission of such material to the laboratory will greatly increase the possibility of a successful and helpful examination being made.

Upon finding a piece of evidence, the investigating officer should mark it so that he can positively identify it at any future time. In the case of clothing this is usually done by attaching to each piece a tag containing the necessary information. It is desirable to put all available information on the tag concerning the nature of the article, the ownership, the place and time found, the finder, and the name of the investigator handling the matter. These data may then be supplemented by recording the same in even greater detail in the investigating officer's notes. In order to obviate difficulties which may arise if these tags should be accidentally detached, it may sometimes be desirable for the investigating officer to place his initials on the clothing itself. The identification of such articles as axes, knives, hammers, steel bars, pieces of wood, et cetera, may also be satisfactorily handled by means of tags, and here again it is sometimes desirable for the officer to place his initials on the instrument in some inconspicuous place.

When a number of specimens suspected of containing stains, especially blood stains, are involved, it is of the utmost importance that care be taken to see that the stains are not transferred from one piece of evidence to another. Each piece should be handled separately. Whenever it is necessary to send material of this nature to a laboratory or preserve it for future reference, the specimen should be thoroughly and naturally dried in the air. No artificial heat should be used, nor should fans be employed. The application of artificial heat is undesirable due to the fact that it has a tendency to fix blood stains in the fabric, and if the temperature is sufficiently high it may completely ruin them for laboratory analysis. It is undesirable to dry material such as this in a current of air due to the possibility that valuable evidence such as dust, burned or unburned gunpowder residues and hair or textile fibers may be blown away. There is also the possibility that foreign dust and debris may be blown onto the material.

In forwarding evidence to the laboratory, each specimen should be separately wrapped in clean wrapping paper. Newspaper or thin wrapping paper is not desirable because of the possibility of tearing and the subsequent loss of loosely adhering blood stains or debris. Where the clothing and personal property of the victim are to be submitted to the laboratory along with the clothing of suspects it is even more necessary to keep these specimens separate and it may even be desirable after wrapping individually, to forward each specimen to the laboratory in a separate container.

If the evidence is not to be delivered personally to a laboratory examiner, the container used to forward the evidence should be sealed in order that no question may subsequently arise as to whether the contents were tampered with in transit.

The transmission of such articles as ax handles, long bladed knives, iron rods or bars may be most effectively handled by constructing a box the approximate size of the article and securing it within by means of cleats. This method is also an effective way of forwarding specimens which are to be treated for latent fingerprints.

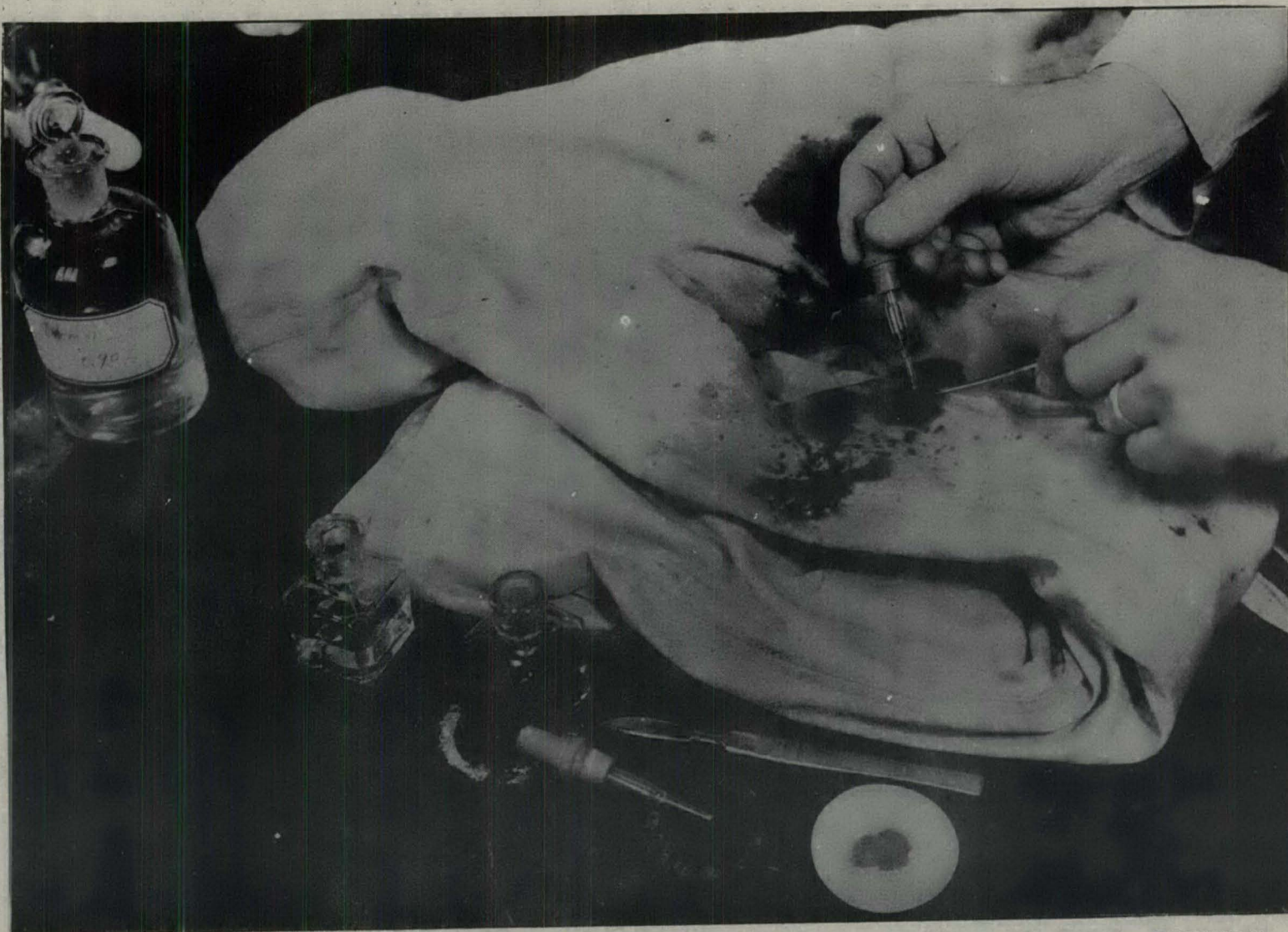
Where blood stains are found on articles which cannot be shipped as a unit, it is necessary to remove the stains. The method used will vary, depending on whether they appear on wood, steel, glass, stone, fabric, et cetera. Stains on wood may best be removed by cutting beneath the stain, taking some of the wood with the cutting. Stains on a wooden floor may be removed with a carpenter's plane or with a wood finisher's scraper. If stains are found on loose earth, sufficient earth should be removed to insure getting the entire stain without mixing in an unnecessary amount of unstained material. If the blood stains appear on fabrics such as furniture or automobile upholstery, or on heavy rugs or carpets and it is not possible to transmit the whole to the laboratory, part of the stained material may be removed for analysis. This is accomplished by placing a chemically clean white blotting paper beneath the material and saturating the stained area with a physiological salt solution which can be obtained at any drug store. The salt solution is applied to the fabric with a clean glass rod or eye dropper and the stained fabric manipulated with the glass rod until the blotting paper has absorbed a good portion of it. The blotter is then allowed to dry and may be transmitted to the laboratory with a description of the procedure used to extract the stain and of the material upon which the stain was originally found.

After removal, the stained residue should be placed in a clean test tube with a stopper and this identified with a gummed label on the outside. The use of envelopes and paper to transmit scrapings to the laboratory is undesirable due to the risk of losing the specimen through the corners of the envelope and from the folds of the paper. Furthermore, if the specimen is very small and slightly moist it may stick to the paper, making it extremely difficult to remove after it is received in the laboratory. For all ordinary purposes, suitable glass vials may be purchased in nearly all drug stores and in the absence of such glass vials, cardboard pill boxes of the round type may be used.

All specimens completely and suitably wrapped, placed in a large container, should be addressed to the Director of the Federal Bureau of Investigation at Washington, D. C., for the attention of the Technical Laboratory.

METHODS FOR DETERMINING INTOXICATION*

Four general methods are now used, either singly or in combination, for determining when a driver of a car is under the influence of liquor. These are:

1. General observations by officers and witnesses. These are made by police officers and witnesses at the scene of the accident or violation and at the police station. These persons appear in court and testify by giving their opinion as to whether the accused was under the influence of liquor.

2. Special examination by officers with a written report. The officers supplement the general observations by noting specific actions such as ability to walk, ability to stand, speech, odor of breath, tremor of hands, condition of hair, condition of eyes, color of face, marks or injuries, and unusual acts. Specific questions are asked and general coordination is measured by observing the ability to perform simple tests. Generally, the answers to questions and results of observation and tests are recorded on a special examination report form.

3. Clinical examination by police surgeon or other physician. Special examinations are made by police surgeons or other physicians. These generally include the detailed examination listed above and, in addition, a general clinical examination for the purpose of distinguishing genuine illness from intoxication. A physician's certificate usually is prepared stating the results of various tests and certifying whether or not the person is under the influence of liquor.

4. Chemical tests of body fluids or breath. Chemical tests are made for determining the percentage of alcohol in the body fluids or breath. By showing specifically the amount of alcohol present in the body fluids, these tests establish the fact that alcohol was present in a quantity sufficient to cause the impairment indicated in the physical examination. Test results also protect the innocent person who may be suffering from some illness or injury.

METHODS NOW IN USE

The result of a questionnaire study, undertaken to learn of methods now in use in various cities and states . . . indicates that over half of the city and state departments still rely upon the general observations of officers and witnesses in securing evidence of intoxication. There is a

definite trend toward the use of more scientific methods. Many departments recently have adopted special examination forms for use by officers in recording answers to questions, and results of physical examinations and coordination tests. Many of the large cities reporting to the committee have police surgeons that make clinical examinations. . .

Dr. Herman A. Heise pioneered in the use of urine tests in Western Pennsylvania several years ago. . . In addition to obtaining excellent results in the securing of convictions for driving while under the influence of liquor he found evidence of a very close correlation between chemical test results and physical symptoms as observed by trained examiners.

Dr. Herman M. Gunn of Ashland, Ohio, has used results of urine tests in a large number of medico-legal cases in the northern part of Ohio. . . After the first few cases, Doctor Gunn found that it was rarely necessary to make a personal appearance in court because pleas were changed to guilty and his certificate was accepted in court as evidence.

CHEMICAL TESTS

Scientific investigators have pointed out and repeatedly verified the fact that the concentration of alcohol in the body fluids is one of the most reliable and objective criteria of intoxication. Many of these investigators have determined the relationship between brain alcohol concentrations and concentrations in spinal fluid, blood, urine, saliva, and breath, so that the degree of alcoholic influence can be evaluated closely when the concentration of alcohol in breath or in the body fluids is known.

Blood-alcohol concentrations closely parallel brain-alcohol concentrations and are one of the best criteria of intoxication. Urine-alcohol concentrations are sufficiently significant for practical purposes since there is a fairly definite relationship between concentrations of alcohol in the blood and in the urine. This relationship is fairly constant one to two hours after drinking, with approximately 1.35 parts of alcohol in the urine to 1 part in the blood. Recent tests by Dr. R. N. Harger have shown that the relationships between concentrations in the breath and in the blood and urine also are sufficiently definite for practical purposes.

The Committee is studying the relationship between impairment and alcoholic concentration so as to permit the fixing of definite borderline limits in terms of alcoholic concentrations in the body fluids and breath. The Committee suggests the use of two limits; (1) a top limit above which a person should be considered as definitely under the influence of liquor from the standpoint of impairment of ability to operate a motor vehicle, and (2) a lower limit below which a person should be exonerated from the standpoint of such impairment. The guilt of persons with concentrations between the two limits could be determined by considering external evidences of intoxication.

Until more data are available, the Committee suggests an alcoholic concentration of 0.15% by weight in urine (0.11% in blood or equivalent

in saliva or breath) as the top limit, and a concentration of approximately 0.10 per cent in the urine or equivalent as the lower limit. Later, the Committee may find it desirable to recommend lower limits as additional information is revealed through further study.

The preliminary report of the American Medical Association's Committee that is studying problems of motor vehicle accidents states that it is important that chemical observations of alcohol in the blood, urine, saliva or breath be used to confirm obvious intoxication. The report also points out that levels of alcoholic concentrations even less than 0.15 per cent by weight in body fluids are associated with definite impairment of judgment. . .

RECOMMENDED PROCEDURE FOR DETERMINING INTOXICATION

Until additional data are collected to determine the effectiveness of the various test methods, the following is suggested as a procedure in obtaining and presenting admissible evidence.

A. Part by Enforcement Officers

1. Establish by means of questions in the presence of witnesses, with signed statements of witnesses when possible, that:
 - (a) The person was operating a motor vehicle on a public highway when arrested.
 - (b) The accused is not a sick man nor is he under the immediate care of a doctor.
 - (c) He has not been drinking since the accident or the arrest.
 - (d) His actions are not the result of injuries in an accident.
 - (e) He does not have diabetes and has not been using insulin.
 - (f) He has not been to a dentist nor has he been using an alcoholic mouthwash recently.
2. Establish, by means of general observations and physical tests of coordination, that the accused is not in possession of his normal faculties. Do not make coordination tests unless subject is willing.
3. Record answers to questions, observations or physical conditions, and results of coordination tests on an examination report form. In addition, secure signed statements of witnesses when possible.
4. Furnish the prosecutor with a copy of the examination report so that he can direct questions from it. Have the officers use the information on this form to refresh their memory when appearing in court.

B. Clinical Examination

When the services of a police surgeon or other physician are available and local conditions are satisfactory, the clinical observations of these physicians as a supplement to general observations of officers and witnesses may be desirable, especially for cases of injury, illness and other questionable cases. A certificate, signed by the physician, certifying whether or not the person is under the influence of liquor should be prepared. In many cases, the physician's certificate will result in pleas being changed to guilty and it will be accepted in court as evidence. In others, the physician necessarily will have to make personal appearance. Physicians' examinations will generally not be necessary when chemical tests are made.

C. Chemical Tests

1. When the services of an expert chemist and physician are available, chemical analyses of urine, blood or breath may be desirable for cases of illness and injury and other difficult cases or in localities where it is difficult to secure convictions by other methods. Secure samples of urine, breath, saliva or blood for a chemical test, seal in the container, and be able to prove that the sample came from the accused. These should be secured as soon as possible after the arrest, after advising the suspect of his constitutional rights. In many localities samples may be mailed to a central laboratory for analysis.

2. Follow a reliable procedure in determining the alcoholic content of the sample, and be able to interpret the test results in terms of alcoholic concentration in the brain. Have reliable information available to interpret the percentage found in terms of the average number of drinks.

3. The evidence obtained from chemical tests may be presented in court by personal appearance, explaining in simple terms just what is meant by the various percentages of concentration of alcohol. After the procedure has developed to a sufficient extent, certificates, stating the percentage of alcohol, may be instrumental in having many pleas changed to guilty and may be accepted as evidence in court.

The information obtained by enforcement officers should be sufficient in those cases where definite impairment was shown and the persons did not complain of illness or injury.

When the person has been injured or complains of illness, clinical examinations by a physician or chemical tests of body fluids are a desirable supplement to the officer's examination to distinguish between the effects of alcohol and those of illness or injury. In some localities, physicians' examinations or chemical tests may be needed for all cases.

CHEMICAL TESTS FOR DETERMINING INTOXICATION

1. The Heise Test--Urine. This method for testing the amount of alcohol in urine is a modification of one used by Nicloux and depends upon the fact that alcohol reduces an acid solution of potassium bichromate, changing the color from orange to blue. The percentage of alcohol is determined by matching the resulting color with color standards. The method also can be used for blood-alcohol determinations.

Distillation equipment and a boiling water bath are used in the test. Urine samples of 10 c.c. are generally used. Color standards are available commercially. The alcoholic content can be preserved almost indefinitely when a preservative is used in the mailing containers. In this way, the sample may be sent to an expert or main laboratory and the police officer is assured protection.

The method has been used by Dr. Herman A. Heise in over 300 medico-legal cases in Pennsylvania, and Dr. Herman Gunn has used the method in more than 150 such cases in northern Ohio.

2. Bogen's Method--Urine. The analysis consists essentially of distilling alcohol from a measured sample of urine into a measured amount of chromic acid solution. The resulting shade of color is compared with standards to determine the amount of alcohol in the urine. The procedure is so simple that persons with no chemical training can obtain good results with it. When standards have been prepared in advance, an analysis can be made with as little as 1/3 teaspoon of urine and the entire test completed in 15 minutes. It is not as accurate as the more precise methods, but is an excellent objective method for making a semi-quantitative observation.

When a man not trained in chemical procedure is to make the test and the results may possibly be used in court procedure, it is recommended that a duplicate sample be taken, sealed and delivered to an expert chemist so that the chemist can be called upon for expert testimony in the event of a trial.

3. Harger's Micro-Method--Urine or blood. This is a method for determining alcohol in extremely small samples of urine or blood. The procedure is a modified bichromate method, the excess of bichromate being titrated directly with a mixture of ferrous sulphate and menthyl orange. Distillation equipment is needed for preliminary distillation of the diluted samples. Titration equipment is very simple. The method is rapid and gives results that check closely the actual concentrations of alcohol.

4. The Widmark Micro-Method--Blood. This method for the analysis of blood has been official in Sweden and was recently adopted in Germany as a mandatory test in traffic accident cases. One or two drops of blood are drawn from the ear lobe or finger tip into specially prepared glass tubes and the percentage of alcohol is determined by a bichromate-iodide method. Since the alcoholic content can be preserved for weeks in the especially prepared glass tubes, the possibility of central examination in a main laboratory is assured the police officer.

5. Bogen's Breath Test. In this method two liters of expired air, collected in a football bladder, are bubbled through an acid solution of potassium bichromate. The percentage of alcohol is determined by comparing the color with previously prepared standards. The test is simple and rapid and can be performed by an untrained person provided the apparatus and reagents are made up by a chemist and furnished him and that control tests are made each time. According to Doctor Bogen, the results are sufficiently accurate for clinical or medico-legal use.

6. Harger's Breath Test. This simple, rapid method for determining the alcoholic content of a person's breath can be used in the field for a quick determination of the presence of sufficient alcohol to warrant an arrest. In addition it is a method that can be used for a more precise determination. A person's breath is drawn through a measured amount of an acid solution of permanganate until the solution changes color. The amount of air used is determined from the weight of the carbon dioxide absorbed in a special absorption tube.

Advantages of this method include its simplicity and the fact that tests can be made at room temperature. Also, the sample can be obtained without touching the prospect, thus not violating any constitutional right when persons will not cooperate by giving samples. The equipment is easily portable, being enclosed in a box 4" x 4" x 8". The carbon dioxide tube is removable so that weighings can be made at a central laboratory. The equipment is available commercially. . .

7. Friedemann's Micro-Method -- Saliva, Blood, and Urine. The distillate from a small sample (0.1 to 1.0 c.c.) is oxidized by potassium permanganate in a boiling water bath, the end point being determined iodometrically. Dr. Friedemann states that the method is more sensitive than chromic acid methods, has a sharp color change from blue to colorless in the titration, and has a permanent end point. He recommends the analysis of saliva as an index of blood alcohol concentration since the method for collecting saliva is extremely simple. . .

SPECIAL TEST METHODS

Visual Tests. Tests of vision already have been used to some extent as a means for demonstrating the effects of alcoholic influence. . . Tests are made while a person is under the influence and results are compared with results of control tests that are made at a later time. It generally has been found that alcohol affects eye coordination and not visual acuity or refractive error.

Sound Motion Pictures. Sound motion pictures, although not being a method for measuring the influence of liquor, are useful in recording evidence so that it can be presented in court. Pictures taken at the time the driver was apprehended will demonstrate effectively the actions that vary from the normal.

Psychological Tests. Psychological testing equipment now is used to a limited extent in traffic clinics of a few cities. Such equipment has been used primarily for measuring the characteristics of drivers in their normal condition. There is a possibility, however, that it can be used in evaluating impairment resulting from influence of alcohol, provided control tests are made later for comparison.

Psychological tests include those for reaction time, visual acuity, depth perception, peripheral vision, eye-hand coordination, speed and distance judgment, and vigilance. Some experiments have been made on intoxicated persons with such equipment, but more data are needed.

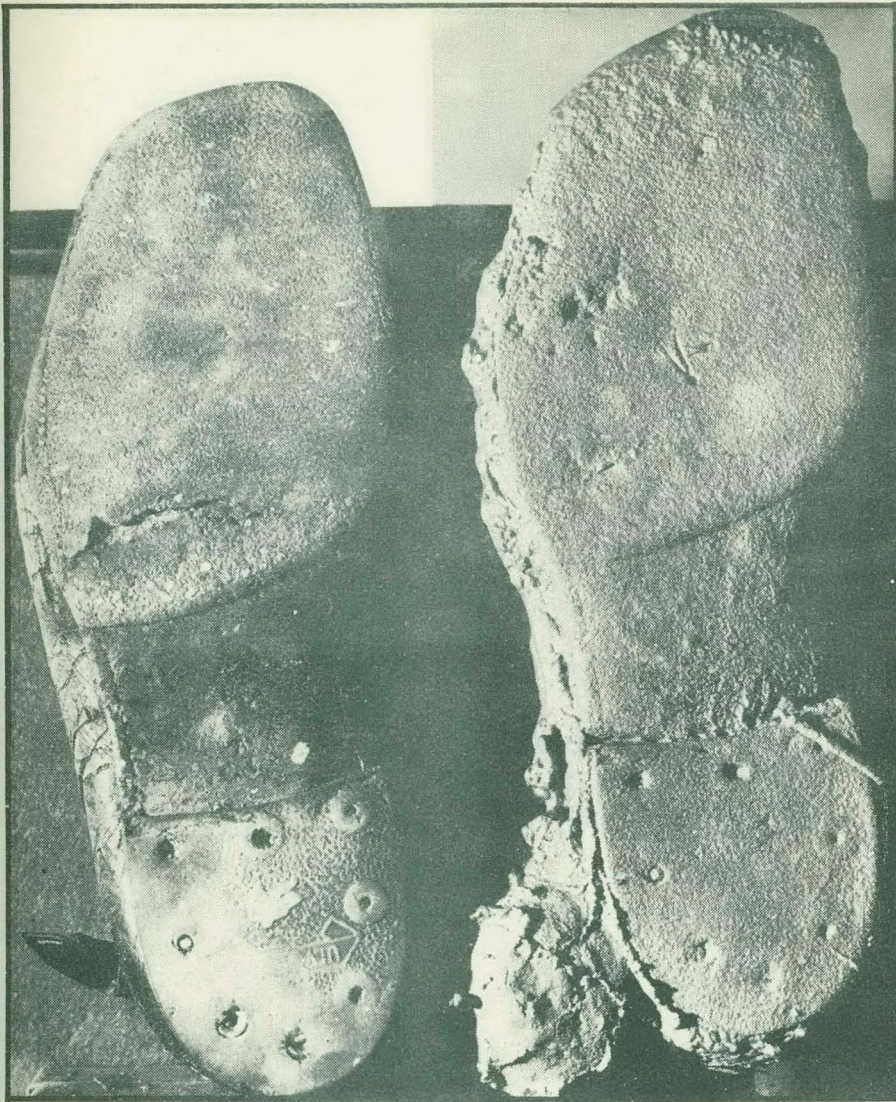

Thus, in 1935 the statement shortly was as follows: Calculate and choose a substance in such a manner that, in a melted condition, the same contains a very small amount of heat and, besides that, conducts heat badly when in a state of congelation! The substance will then, independently of the temperature at which it melts, practically not be able to melt a sufficiently great amount of snow in the footprint for influencing, to any important degree, the result of taking the cast, because the border-stratum (1) does not contain the necessary amount of heat for melting all the snow, and (2) will not, after the congelation of the border-stratum, allow of a quick passage to the footprint in the snow of the comparatively small amount of heat which the casting-mass then contains altogether.

THE CONDITION OF THE MASS: On the basis of the above shortly sketched theoretical calculations the author has theoretically and practically examined numerous substances which more or less well filled the requirements made, but no substance proved to be as practical as sulphur. As already mentioned, the author told this for the first time in 1935, and later on in a publication of April 1938.⁶ The author, however, is now in a position to publish a still better mode of procedure than in the publication of 1938. Finally, as far as the costs are concerned, the usual price of flower of sulphur is about 6 Swedish Crowns the 10 kilos,⁷ and thus quite moderate.

NATIONAL STOLEN PROPERTY FILE

The first of April, 1938, marked the second anniversary of the National Stolen Property File which is maintained by the Federal Bureau of Investigation. This file was established on April 1, 1936, to provide a central source of information regarding stolen property. It is available for the use of the Special Agents of the Federal Bureau of Investigation as well as law enforcement organizations throughout the United States.

The past year has seen the rapid growth and expansion of this file, and it is hoped that ultimately it will become a national clearing house in character, and that it will afford to all law enforcement agencies a complete reservoir of information as to stolen property comparable to the information relative to criminal histories now maintained in this Bureau's Identification Division. At the present time the file is prepared to receive and record for the information of law enforcement agencies any stolen property which might be described by name, model or serial number, such as watches, firearms, bonds, typewriters or similar office equipment, and of stolen property involving thefts amounting to an aggregate value of \$5,000 or more. Such property, of course, must be described in detailed nomenclature as to individual items involved.

Any property which is capable of descriptive indexing so that a subsequent search will locate it in a file of many such articles, will be indexed. In addition to the description of the property the contributing agency should supply the name and address of the victim, type of crime and circumstances of theft, and the names of any suspects. Many clerical difficulties are encountered in maintaining a file of this nature. In order to acquaint those organizations who desire to use the facilities of this file a brief discussion of its operation is set forth.

FURS, CLOTHING AND CLOTH GOODS

It has been found in the National Stolen Property File that attempts to index articles of clothing, fur coats and raw pelts, have proved unsuccessful because few such items bear indelible markings by which individual pieces can be identified. In reporting thefts of items of clothing such as men's suits, a list of the articles is frequently furnished. This list usually purports to show a manufacturer's number for each item of clothing, but invariably this number proved to be a stock number and did not appear on the garment. Description by size and color is not sufficient to permit indexing. In the future, therefore, no attempt will be made to index individually each article of this type.

When, however, a great quantity of men's suits, fur coats, or the like, is taken in a robbery, a single card will be inserted in the file, indexing such articles generally. Thus, if similar goods are recovered,

victims of prior thefts can be advised and given an opportunity of examining the recovered property in an effort to identify it.

It is suggested that with regard to the list furnished by the victim, inquiry should always be made to determine whether the numbers or descriptive data included on this actually appear on the articles taken. If such is not the case, no purpose is served in forwarding these lists to the Bureau.

SECURITIES

In securing detailed descriptive data regarding stocks and bonds the following should be borne in mind:

Stocks:

- (1) Full and correct name of issuing corporation.
- (2) Preferred or common stock.
- (3) Interest (if any).
- (4) Series or issue.
- (5) Serial number of certificate.
- (6) Number of shares.
- (7) Name and address of registrar.

Bonds:

- (1) Full and correct name of issuing corporation.
- (2) Series (e.g., mortgage, debenture, refunding, et cetera).
- (3) Interest rate.
- (4) Maturity date.
- (5) Whether coupon or registered.
- (6) If coupon, give maturity date of coupons and last coupon attached at time of theft.
- (7) If registered, give name and address of registrar.
- (8) Serial number.
- (9) Denomination.

The fact that one company might have several issues outstanding makes all this information important. Evidence of counterfeited securities should be furnished the FBI immediately. The serial numbers of recovered securities should be carefully examined for changes and, if necessary, the securities should be forwarded to the FBI Technical Laboratory for a technical examination.

Government issues are often erroneously described. Care should be taken to distinguish between United States Treasury bonds and United States Treasury notes, and the name of the governmental agency issuing the securities should be clearly set forth, e. g., Home Owners' Loan Corporation, Federal Farm Mortgage Corporation, Federal Land Bank and Joint Stock Land Bank.

In this connection, the Treasury Department is the transfer agent for all government issues, and here stop notices can be placed on all registered government bonds. In the case of coupon bonds, a flash can be placed to notify the FBI in the event the bond returns to the Treasury Department but this does not act to stop the transfer. Generally, many months elapse before a coupon bond which has been returned to the Treasury is checked against the records and the field division advised thereon. No notice of any kind can be placed against the coupons themselves with the Treasury Department, but these can be indexed in the Stolen Property File of the Bureau.

FIREARMS

All firearms that are manufactured bear a serial number. Because of the structure of the firearms themselves, a serial number identification of these weapons is generally a simple matter in the National Stolen Property File. In submitting descriptions of firearms the following data should be borne in mind:

- (1) Manufacturer's name.
- (2) Calibre.
- (3) Model and date.
- (4) Type of weapon.
- (5) Serial number, including all numbers on the firearm, giving location of each.

Firearms are primarily filed under the following categories:

- (a) Machine guns.
- (b) Rifles.
- (c) Guns (i.e., shotguns).
- (d) Pistols.

Under each of these categories the weapons are secondarily indexed by serial number. The manufacturer's name is not used to subdivide these guns, but all information obtainable appears on the index card.

Bureau records on firearms have been maintained for many years, and all firearms obtained by police departments from persons arrested may easily be searched. The possibility of connecting a suspect with other crimes by such a search is apparent.

JEWELRY

The greatest difficulty in handling the file has been in filing descriptions of jewelry, as such pieces usually lack serial numbers. The FBI file is primarily divided under type headings such as buckles, bracelets, brooches, chains and clips, alphabetically. Some of these headings are further subdivided; e.g., rings are divided into men's and women's rings, where they are further classified as solitaires (used for rings containing

one major stone), dinner rings (those intricately designed with many stones), and wedding rings. Further subdivisions are made according to the material used in the setting - whether gold, platinum, or other metal. Under the final heading, the rings are arranged according to the number of stones in the ring or the carat weight of the principal stone if the weight is four carats or over. This carat weight has been adopted arbitrarily as it is believed the number of rings containing small stones would be too great to permit identification.

Bracelets and necklaces are also indexed by the number of stones in the particular piece.

Where, however, the item contains a number, either stamped or scratch marked, or bears initials or name inscription, the item is filed by this number, initial, or name. This does not mean a model number, which appears on items of similar manufacture, but is a number peculiar to the piece itself. Photographs and drawings are of no assistance in filing material, but may be retained in the file to facilitate identification in a subsequent search.

Certain items bear trade-marks but no serial numbers. This is true particularly of silverware. While no positive identification can be made by such a mark, nevertheless when such items are taken which bear a trade-mark, a file card will be made and indexed according to the trade-mark. Recoveries of similarly marked items can thus be checked for a possible identification.

The following is a sample of a good description of a brooch to be indexed:

1 diamond brooch, cushion shape
 scratch number on clasp, 179
 1 emerald-cut blue white diamond, weight 14.47 carats
 2 pentagon-cut diamonds, weight 2.52 carats each
 4 baguette diamonds, 1.83 carats total weight
 18 square diamonds, 4.32 carats total weight
 36 baguette rubies, 3.82 carats total weight
 10% iridium platinum mounting
 Value: \$25,000.

This brooch will be indexed four different ways:

- (1) Under "Brooch," by scratch number.
- (2) Under "Brooch," by chief stone - diamond, 14.47 carats.
- (3) Under "Brooch," by total number of stones - 61.
- (4) The chief stone will be indexed under "Diamonds," 14.47 carats.

In this manner, the stone could be located if it were removed from the brooch, and the brooch could be located if the scratch number were obliterated.

Watches are indexed by case or movement number, or both. There is but one division and they are not primarily subdivided by manufacturer's name, as it is possible that the movement or case may be switched. If both movement and case numbers are given, the watch is indexed under both numbers. All other pertinent descriptive data should be obtained for inclusion on the index card.

In order to serve best the law enforcement organizations of this country, the information contained in the National Stolen Property File should be as complete and detailed as possible for contributing law enforcement agencies to make it. This, of course, depends upon the one factor of law enforcement agencies making proper notations of the loss of property and the recovery of property and transferring this information to the Federal Bureau of Investigation so that it may be checked in the National Stolen Property File.

This is another project of cooperation, the purpose of which is to facilitate and aid local agencies in the solution of crimes which come to their attention.

WOMEN IN CRIME

Only 6.9 percent of the 520,153 arrest records examined by the Federal Bureau of Investigation during 1937 represented women. For all types of crimes except commercialized vice the number of men arrested was larger than the number of women. However, a comparison of the figures representing an average group of 1,000 men arrested with those for an average group of 1,000 women arrested indicates that there were more women than men charged with murder, assault, and the use of narcotic drugs. In such average groups of 1,000 men and 1,000 women arrested it would be found that there were 13 men and 18 women arrested for murder, and that there were 56 men and 70 women charged with assault. The same type of comparison indicates a somewhat larger ratio of arrests of women for larceny, but for other types of crimes against property, such as robbery, burglary and auto theft, men predominate. The comparison further reveals that 13 of each 1,000 women arrested and fingerprinted were charged with driving while intoxicated, whereas 45 of each 1,000 men were charged with that type of violation.

As mentioned above, 6.9 per cent of the arrest records examined during 1937 represented women. This is a decrease as compared with 1936, when 7.3 per cent of the records represented women, but the 1937 figure is the same as the proportion of women arrested during 1934 and 1935.

The preceding figures are based upon fingerprint records received during the calendar year 1937 by the Identification Division of the FBI. Detailed figures for individual types of crimes may be found in the bulletin "Uniform Crime Reports" for the fourth quarter of 1937.

**POLICE USE FINGERPRINTS TO ESTABLISH IDENTITY OF
UNKNOWN DECEASED**

The value of fingerprint identification in connection with the discovery of information pertaining to persons classified as "unknown deceased" is clearly illustrated by the following case.

The Police Department at Meridian, Mississippi, was attempting to establish the identity of an unknown individual who was found dead in that city. All marks of identification were lacking other than a tattoo indicating the initials "J. L. B. #733" together with crossed flags. Upon receipt of this fingerprint card in the Identification Division of the FBI on January 25, 1938, this person, classified as "unknown deceased," was identified as being John L. Bradford who had previously been arrested in New Orleans, Louisiana, in 1924 and had subsequently been arrested in Oklahoma, Louisiana, and Mississippi. Upon determining the identity of this individual a check was made of the records of the War Department and information was disclosed which showed that he had previously enlisted as a soldier.

The complete criminal record appearing in the files of the Identification Division, together with addresses appearing on the fingerprint cards as well as place of birth, was furnished in order to assist the Police Department at Meridian, Mississippi, in establishing names of relatives in order that proper disposition might be made of the body.

The FBI was able to advise the Meridian, Mississippi, Police Department that the tattooing recorded on his fingerprint card indicated a present or past affiliation with Brotherhood of Railway Trainmen #733. The path was thus opened to further inquiry in the event such action should prove necessary to the location of relatives or friends. Information concerning this tattooing had been furnished by a law enforcement agency which had arrested this individual in the past and forwarded his fingerprints for inclusion in the files of the Identification Division.

Fingerprint identification has been a most important factor in connection with the identification of persons who die unknown, as well as those persons who are victims of the dreaded malady known as amnesia.
