The United States Bureau of Investigation is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Bureau does not have investigative jurisdiction over violations of the National Prohibition, Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the United States Bureau of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act

National Bankruptcy Act

White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnapped

Theft, Embezzlement or Illegal Possession of Government Property

Antitrust Laws

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property

Neutrality violations, including the shipment of arms to friendly nations

Frauds against the Government

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest office of the United States Bureau of Investigation. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field offices of this Bureau appears on the inside back cover of this bulletin.

It is my sincere desire that the United States Bureau of Investigation, Department of Justice, extend to you its fullest cooperation and I am pleased to announce that the Bureau's services are available to you twenty-four hours each day. You have no doubt observed statements in the press on recent occasions advising of the desire of this Bureau to be of all possible aid in matters of mutual interest. Due to the frequency of reported kidnapings and to the suggestions made by officials of this Department that such violations be promptly reported to this Bureau, I desire to call your attention to the methods you may employ in order to promptly get in touch with officials of the Bureau.

Hereafter, an employee will be on duty at each of the Bureau's field offices throughout the day and until midnight of every day, including Sundays and holidays. The address for letters or telegrams (the building address), as well as the office telephone number, will be found on the inside of the back cover of this and subsequent issues of the "Fugitives Wanted by Police" bulletin.

The office of the Director of the United States Bureau of Investigation will be open to receive any telegram or telephone message, or other communication, twenty-four hours each day. The telephone number of the Director's office during the day is National 0185; at night the number is National 7117. Telegrams for the Director may be addressed as follows:

It is suggested that you transmit all information concerning any matter requiring investigation by this Bureau to the Special Agent in Charge of the nearest field office. If considered necessary for any reason, you may of course telephone the Director's office at any time. Communications concerning fingerprint identification, including fingerprint cards, crime statistics or administrative matters, should be forwarded to the Director at the above address. This address, as well as the telephone numbers referred to, will be found on the inside back cover of each subsequent issue of this bulletin.

Concerning kidnapings I desire to call your attention to the Bureau's policy with regard to the handling of such violations. The Federal Government, of course, under existing laws does not have jurisdiction unless the person kidnaped has been transported in interstate commerce and is held for a ransom or reward. Obviously, in order that the Special Agents of the Bureau might technically perform their duties it would be only necessary for them to await the location of the kidnaped victim, which would mean that the case would be practically developed to a com-

pletion before cooperation was offered. However, this is not real cooperation. It is not my desire that employees of this Bureau intrude in any way upon the functions and jurisdiction of State authorities, but I do desire that the cooperation which is offered be sincere and valuable. Consequently, I have issued instructions for the Special Agents, upon learning of a kidnaping case, to immediately offer the full cooperation of this Bureau to the local or State peace officers, and the Bureau through its representatives will not make this offer with empty hands. Their cooperation makes immediately available the full resources of the Identification Division of the Bureau with its 3,780,584 fingerprint records; the single fingerprint files containing approximately 16,000 single fingerprints of known kidnapers and extortioners, which have already proven effective in kidnaping cases; the Bureau's Technical Laboratory, where certain latent evidence may be studied for identification purposes; and the full resources of each of the twenty-one field offices of the Bureau, out of which the Special Agents are daily operating in all sections of the United States, thereby making immediately available information which may be desired for prompt consideration at any point in the country. It is our desire to make plans with you, to study the case with you, and to work with you. It is this type of cooperation which is actively and voluntarily given and which undoubtedly is the most effective weapon which we may jointly utilize against the perpetrators of such dastardly crimes. It is for these purposes of cooperation that I have issued the instructions that will make it easy for you to communicate with each of the Bureau's field offices or with the Bureau at Washington.

I am also glad to report that within the past few days, because of the effective cooperation between the Bureau's employees and the officials of local police departments, several kidnaping cases have been brought to a logical conclusion, even though in some of the instances referred to the Federal Kidnapping Law was not violated. The effectiveness of such joint action is established, and the employees of this Bureau deem it a high pleasure and a privilege to be afforded the opportunity of working hand in hand with you and your staff of employees.

STATISTICS COMPILED FROM FINGERPRINT CARDS  
RECEIVED IN THE UNITED STATES BUREAU  
OF INVESTIGATION FROM JANUARY 1ST  
TO JUNE 30, 1933.

During the month of June, 1933, 27,555 arrest records as evidenced by fingerprint cards received by the United States Bureau of Investigation were examined, and it was found that the records of persons 23 years of age were more numerous than those of individuals of any other single age group. However, the records of persons aged 19 and of those aged 22 were almost as numerous as those of persons aged 23.

For the entire first half of the calendar year 1933, individuals aged 19 exceeded in number those of any other age group, although those of other ages between 18 and 24 were not greatly outnumbered. During the six-month period 159,493 arrest records were examined. The continuing predominance of youthful offenders is indicated by the fact that 1 of each 5 arrested was under 21 years of age, while an additional one-fifth of those arrested was aged between 21 and 24 inclusive. A slightly smaller proportion of the total was between 25 and 29 years of age. In other words, almost three-fifths of the persons arrested were under 30 years of age.

The offenses with which youths were most frequently charged include vicious crimes, as is evidenced by the following table:

In addition, 309 persons under 21 years of age and 473 individuals aged between 21 and 24 were arrested and charged with criminal homicide during the first half of this year.

The total number of records of persons aged 19 was 10 per cent greater than the number of records of those aged 18. The tabulation shows, however, a much larger proportion of 19-year-olds in the following instances:

These figures tend to indicate that youthful offenders quickly turn to the more serious crimes.

On the whole, there were fewer arrests for robbery during the second quarter of 1933 than during the first three months of the year. Of 80,785 arrests during the first quarter, 5241 were for robbery, whereas of 78,708 arrests during the second quarter of the year, only 3774 were for that offense.

On the other hand, arrests for disorderly conduct, drunkenness, and vagrancy showed an increase during the second quarter of the year, there being 14,274 such arrests as compared with 12,036 during the first three months. During June the number of arrests on these charges was greater than during any one of the preceding months of the year.

The majority of the persons arrested were males. Of the 159,493 arrest records examined, 11,029 (6.9%) were those of females.

Negroes constituted 23 per cent of all the persons whose records were received. Of the total persons charged with homicide, 34 per cent were colored, and this race contributed a correspondingly high proportion of individuals in the following instances: assault (40%), carrying and possessing weapons (33%), and gambling (44%). Negroes constituted a comparatively small proportion of those charged with forgery and counterfeiting, embezzlement and fraud, offenses against the family, driving while intoxicated, and violation of narcotic drug laws.

Of 159,493 persons arrested, 35 per cent had a previous record in the files of the Bureau. This does not mean that they had been previously convicted, nor does it mean that they have previously been charged with committing the same offense. It means merely that at some previous time they were arrested and fingerprinted and copies of the fingerprint records were forwarded to the Bureau at Washington, D. C. Six of each ten arrested for violation of the narcotic drug laws and approximately four of each ten charged with forgery and counterfeiting; disorderly conduct, drunkenness and vagrancy; robbery; or embezzlement and fraud had previous records. A slightly smaller proportion of those charged with burglary-breaking or entering, larceny-theft, or auto theft had previous fingerprint records on file. Approximately two of each ten charged with driving while intoxicated or criminal homicide had similar records.

It should be borne in mind that the data compiled from fingerprint records do not represent all offenses committed during the month, since there are offenses perpetrated for which no one is arrested, and due to the further fact that there are persons arrested for whom no fingerprint records are forwarded to the Bureau.

At the end of June, 1933 there were 3,621,609 criminal fingerprint records and 4,745,290 index cards containing names or aliases of individuals with criminal records on file in the United States Bureau of Investigation at Washington, D. C. Of each 100 fingerprints received during June, more than 47 were identified with criminal data in the files of the Bureau. During June, 1933, 347 fugitives from justice were identified through fingerprint records and information as to the whereabouts of these fugitives was immediately transmitted to the law enforcement officers or agencies desiring to apprehend these individuals. The number of police departments, peace officers and law-enforcement agencies throughout the United States and foreign countries voluntarily contributing fingerprints to the Bureau at the end of June totaled 5,941.
