The Federal Bureau of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act

Interstate transportation of stolen property valued at \$5,000 or more

National Bankruptcy Act

Interstate flight to avoid prosecution or testifying in certain cases White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Killing or Assaulting Federal Officer

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnaped

Extortion cases in which interstate commerce or interstate communication is an element

Theft, Embezzlement or Illegal Possession of Government Property Antitrust Laws

Robbery of National Banks and Member Banks of Federal Reserve System National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property Neutrality violations, including the shipment of arms to friendly nations Frauds against the Government

Crimes in connection with Federal Penal and Correctional Institutions Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

Federal Anti-Racketeering Statute

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

The Bureau does not have investigative jurisdiction over the violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

Law enforcement officials possessing information concerning violations over which the Bureau has investigative jurisdiction are requested to promptly forward the same to the Special Agent in Charge of the nearest field office of the Federal Bureau of Investigation, U. S. Department of Justice. The address of each field office of this Bureau appears on the inside back cover of this bulletin. Government Rate Collect telegrams or telephone calls will be accepted if information indicates that immediate action is necessary.

The FUGITIVES WANTED by POLICE BULLETIN is published by the Federal Bureau of Investigation, United States Department of Justice each month. Its material is compiled for the assistance of all Law Enforcement Officials and is a current catalogue of continuous reference for the Law Enforcement Officers of the Nation.

July 29, 1935 marked the opening of a Police Training School in Washington, D. C., under the supervision of the Federal Bureau of Investigation, U. S. Department of Justice. This training school, dealing with all aspects of crime problems, is part of the program that Attorney General Homer Cummings recommended to the crime conference meeting in Washington, D. C., from December 10 to 13, 1934.

The enthusiastic reception among law enforcement officials, of such a University of Police Methods, is gratifying and in making available the facilities of the Federal Bureau of Investigation to cooperating agencies we expect, as Attorney General Cummings said in his Stanford speech on June 7, 1935, "both to learn and teach." It is my sincere hope that this school will afford the opportunity of adding something to the knowledge of all law enforcement officials in the problems with which we must deal.

The beginning has been made on a limited scale, until we shall have passed the experimental stage. Nevertheless, the course offered is complete. In addition to the facilities of the Federal Bureau of Investigation the services of outstanding men from Universities, the field of criminology, and from Police Departments have been enlisted, to afford a thorough and complete course of study.

The course covers administration features of Police work, discussion and consideration of everyday Police problems, and practical training in the performance of enforcement duties. It is our aim to present in this Police Training School the answer to every problem which can arise in Federal, State, or Local Law Enforcement work.

The 12 weeks course is free. The only cost to the attending officer is his transportation and living expenses while in Washington. Those officers attending the school which opened on July 29th, 1935 are selected representatives from their respective organizations, based upon applications which had been filed with the Federal Bureau of Investigation during the last several months.

It is hoped that the men, after undergoing the course of instruction, will return to their communities equipped to inform their respective departments in the new things learned concerning crime problems and that there will thereby be accomplished another step to the extermination of crime and the betterment of Public Welfare.



INTERESTING IDENTIFICATION

LUCIEN GARR - JOHNNIE MACKEY - VICTOR PALMA

THREE TRANSIENT VAGRANTS ARRESTED BY MILWAUKEE, WISCONSIN POLICE OVER FOUR DAY PERIOD IDENTIFIED AS ESCAPED CONVICTS THROUGH NOTICES IN FUGITIVE BULLETIN

An escaped life termer from the State Reformatory, Frankfort, Kentucky, an escaped prisoner from the State Reformatory, Mansfield, Ohio, who had been serving a term of one to fifteen years for burglary and larceny, and an escape from the State Penitentiary, McAlester, Oklahoma, who had been serving a term of two years at that institution for burglary, all of whom were arrested as transient vagrants by the Police Department at Milwaukee, Wisconsin, were identified as wanted men through notices appearing in the bulletin "Fugitives Wanted by Police". The three arrests and identifications were made within a period of four days, commencing June 18, 1935, and it is believed that this accomplishment is one of the most outstanding illustrations of the value of the Fugitive Bulletin.

On June 18, 1935, one Frank Phillip Palmo was arrested by the police at Milwaukee as a transient vagrant and by means of information contained in the December, 1933, issue of the Fugitive Bulletin was identified as Victor Palma, an escape from the State Reformatory, Mansfield, Ohio. He had been received at that institution in June, 1933, to serve a term of one to fifteen years on charges of burglary and larceny, and had escaped in September, 1933.

An individual who stated that his name was James Martin was arrested by the police at Milwaukee as a transient vagrant on June 19, 1935. Although this person denied any prior arrest record, a search of the fingerprint files of the Milwaukee Police Department disclosed that Martin was really one Johnnie Mackey, an escape from the State Penitentiary, McAlester, Oklahoma. The identification was established through a comparison of his right ring fingerprint with a corresponding fingerprint as appearing in the September, 1934, issue of the Fugitive Bulletin. This subject had been received at the State Penitentiary, McAlester, Oklahoma, in November, 1933, to serve a term of two years for burglary and had escaped in April, 1934. Since this identification was made he has been returned to that institution.

The Police Department at Milwaukee, Wisconsin, arrested one George Scott on June 21, 1935, taking him into custody as a transient vagrant. Scott denied any previous arrests, but his fingerprints were taken at once and checked through the identification files of the Milwaukee Police Department. It was found that his right index print was identical with that of one Lucien Garr, the subject of a wanted notice which was published in the September, 1934, issue of the Fugitive Bulletin. Garr was wanted for escaping from the State Reformatory, Frankfort, Kentucky, on July 23, 1934, where he had been serving a life term for murder. As a result of this identification he was returned to the State Reformatory at Frankfort on June 24, 1935.

These cases demonstrate conclusively the effective results that are being attained through the use of the Fugitive Bulletin. When persons are arrested on minor charges the bulletin contains information for the immediate reference of the officials in determining whether such persons are wanted for major offenses. Over 8,000 law enforcement agencies receive the bulletin each month, and it is believed that the great majority are taking advantage of the opportunity to make practical and systematic use of the notices appearing therein.

INTERESTING IDENTIFICATION

WALLACE DAVIS

NOTICE IN FUGITIVE BULLETIN IS MEANS OF IDENTIFYING SUBJECT WANTED BY FEDERAL AND LOCAL AUTHORITIES WHEN FINGERPRINTS ARE TAKEN BY COUNTY RELIEF ASSOCIATION

Wallace Davis, whose apprehension had been sought by Agents of the Federal Bureau of Investigation on a charge of violation of the National Motor Vehicle Theft Act, and also by the Sheriff's Office at Bay Minette, Alabama, on a charge of armed robbery, was identified and taken into custody as a fugitive on June 1, 1935, at Fort Worth, Texas. Davis had been on the relief rolls of the Tarrant County Relief Association at Fort Worth. His fingerprints were taken by that Association and when they were checked against the files of the Police Department at Fort Worth, he was found to be wanted by the Federal Bureau of Investigation and the authorities at Bay Minette, Alabama. Notices of this person's fugitive status had been published in the May, 1934, and the April, 1935, issues of the bulletin "Fugitives Wanted by Police", and these notices had been placed in the fingerprint files of the Fort Worth Police Department. When this identification was made, Davis was turned over to the Federal authorities and appropriate steps were instituted at once against him.

The case against Davis rested on the charge that in February, 1934, he and another individual had held up the owner of a Ford coach at Memphis, Tennessee, and driven him to a point near Hulbert, Arkansas, where he was tied and robbed, and where the car was taken from him. Davis was taken into custody shortly thereafter, and was released to the Sheriff at Bay Minette, Alabama, for prosecution on a charge of armed robbery, which charge is a capital offense in the State of Alabama. On April 22, 1934, he had escaped from the County Jail at Bay Minette. Investigations that were conducted from the time of his escape until his identification as a fugitive through the notice in the fugitive bulletin were of no avail.

The case of Wallace Davis is a clear demonstration of the decidedly worthwhile results attained through the systematic use of data furnished in the fugitive bulletin. Where an immediate check is desired, for the purpose of ascertaining whether an individual arrested for investigation is wanted, the bulletin is a readily available medium for making such determinations.






