The Division of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Division does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Division of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Division has investigative jurisdiction:-

National Motor Vehicle Theft Act
Interstate transportation of stolen property valued at \$5,000 or more
National Bankruptcy Act
Interstate flight to avoid prosecution or testifying in certain cases
White Slave Traffic Act
Impersonation of Government Officials
Larceny of Goods in Interstate Commerce
Killing or Assaulting Federal Officer
Cases involving transportation in interstate or foreign commerce of any persons who have been kidnaped
Extortion cases in which interstate commerce or interstate communication is an element
Theft, Embezzlement or Illegal Possession of Government Property
Antitrust Laws
Robbery of National Banks and Member Banks of Federal Reserve System
National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds
Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property
Neutrality violations, including the shipment of arms to friendly nations
Frauds against the Government
Crimes in connection with Federal Penal and Correctional Institutions
Perjury, embezzlement, or bribery in connection with Federal Statutes or officials
Crimes on the high seas
Federal Anti-Racketeering Statute
The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Division has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Division of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field Offices of this Division appears on the inside back cover of this bulletin.

All of you, I feel certain, are interested in the Crime Conference called by the Attorney General to meet at Washington on the 10th of this month.

The Attorney General outlined the purpose of the conference in his recent radio address delivered under the auspices of the American Bar Association when he stated:

"You may have noticed in the press that I have called a national conference on Crime to meet at Washington on the 10th day of December, to which will be invited Governors of States and representatives of all organizations, official and otherwise, whose activities, at one point or another, bear on this problem.

"In the language of the official call, 'The purpose of the Conference is to evolve a practical program of objectives that will commend itself to the support of the American people. What is sought is neither a Federal program alone, nor a State program alone, but methods of effective cooperation in the sphere of crime prevention and criminal law enforcement among the Federal, State, and local governments, as well as the active assistance of all agencies, official and otherwise, which can participate in a sustained national movement to deal with the criminal menace'.

"No one, of course, expects that the problem of crime can be solved within the space of a single conference, nor, indeed, can it be solved in a series of conferences, nor, for that matter, in our generation. Nevertheless, the conference that is to assemble here in December will meet for serious, practical business. It is one of the pathetic and frequently observed characteristics of conferences that zealous people are brought together for a high purpose, thereby developing a fine enthusiasm, which immediately oozes when the conference adjourns, leaving but a small residue of actual accomplishment. The forthcoming Conference will, I am confident, approach the problem of

crime without prejudice, without sentimentalism, without sensationalism, and will examine it from the most realistic viewpoint possible, with full appreciation of its fundamental social and economic implications. Approached in that spirit, I believe that this Conference will produce results - concrete, practical results - that can be translated into effective action. Our aim will be to discover means to sustain the movement against crime after the conference has adjourned. What we are seeking is the concentration and cooperation of forces that will be able to make themselves felt, not for a few brief hours, but for 365 days in the year."

This is the last issue of the Fugitives Wanted by Police Bulletin before the Holiday Season and I desire to take this opportunity to wish every one of you the happiest of Christmases and a New Year which will witness the achievement of all your desires.

ANNOUNCEMENTS

The Division of Investigation from time to time has occasion to review its fingerprint files to secure photographs of certain persons in order that the said photographs may be of assistance in the establishment of "sight" identifications. In many instances, however, it has been observed that the last available photograph has been prepared several years and, in some instances, two or three decades ago. In the majority of these cases the person depicted by the photograph has been confined to a penitentiary for a prolonged period, with the result that a subsequent likeness is not available. It is suggested, therefore, that wherever possible and practicable the wardens or superintendents of the various penal institutions may desire to devise arrangements to photograph inmates, particularly the most notorious criminals, immediately before they are discharged and to send such photographs to the Identification Unit of this Division. The further suggestion is made that possibly it would be advantageous in some instances to secure not only the usual front and profile views, but the full length picture of the inmate attired in civilian clothes immediately before he is released.

It is the feeling of the Division of Investigation that the arrangement suggested would produce effectual results in many instances in the identification of persons charged with crime where such identifications at present are rendered difficult due to the inadequate nature of the available photographs.

Beginning with the present issue of the Bulletin, "Fugitives Wanted by Police", the fingerprint classifications which appear in connection with the wanted notices will be supplemented by additional formulae for the assistance of those contributors who require such information for the purpose of filing the finger impressions which appear with the wanted notices. The additions to classification formulae which are being made at the suggestion of a contributor, will show the sub-secondary classification as well as the small letter patterns in those secondary classifications showing a whorl in either index finger.

It is hoped that this information will be of assistance to contributors in general.

INTERESTING IDENTIFICATIONS

JAMES O'KEEFE

MURDERED MAN, IDENTITY UNKNOWN FOR THIRTEEN YEARS,
IDENTIFIED BY FINGERPRINTS AS EX-LIFE TERMER
FOR MURDER

A fingerprint card was received in the Identification Unit of the Division of Investigation on October 24, 1934, from the Omaha, Nebraska office of the Division, the impressions on this card being those of an unknown man who had been shot at Bristow, Oklahoma on April 26, 1921 and who died at Sapulpa, Oklahoma on April 27, 1921. These fingerprints had been submitted shortly prior to their transmission to the Division to the Omaha Division office by local authorities in an effort to clear up the thirteen year old mystery with respect to the identity of the dead man. It appeared that when this individual had been shot in 1921 he refused to tell his name or anything else, although he was conscious practically up to the time of his death. Moreover, the identity of his assailant was unknown. Efforts made to effect an identification of the dead man during the period from 1921 to 1934 had been unsuccessful.

The fingerprints of the unidentified murdered man were searched through the files of the Identification Unit and it was ascertained that this person was identical with one James O'Keefe who, on October 22, 1919, had been arrested by the Police Department at Sioux City, Iowa, on a charge of bank robbery and who, on November 21, 1919, had been received at the Iowa State Penitentiary, Fort Madison, to serve a life sentence following a conviction on a charge of murder in the first degree. Accordingly, the Iowa authorities were advised immediately of the identity and criminal history of this person.

The above case is one of many in which the identity of unknown deceased persons is ascertained by means of fingerprints. It is of especial interest in view of the fact that this person's identity was unknown for thirteen years, all efforts to identify by other means having proved fruitless.

INTERESTING IDENTIFICATION

HAROLD HANSEN

FOREIGN BIRTHPLACE OF RECIDIVIST DETERMINED BY INTERNATIONAL
EXCHANGE OF FINGERPRINTS, THEREBY PROVIDING GROUNDS FOR
DEPORTATION

The files of the Identification Unit reflect an extensive criminal record on one Harold Hansen, covering the period from 1924 to 1933. It appears that his criminal specialty was forgery and obtaining money by false pretenses. He had served a term of two years commencing in January, 1925, at the State Farm, Raiford, Florida, as well as a term of from three to five years at the State Penitentiary, Walla Walla, Washington, commencing in May, 1929, for the aforementioned offenses. In addition, several minor terms appeared on his record sheet.

Shortly after this individual's release from the State Penitentiary at Walla Walla, Washington, he was taken into the custody of the Sheriff's Office at Walla Walla and held for deportation proceedings. Accordingly, two sets of his fingerprints were transmitted to the Division by the Sheriff's Office at Walla Walla, Washington, and one set of them was transmitted to the Identification Bureau in Norway for the purpose of ascertaining facts relative to his birthplace. It appears that Hansen had been arrested on numerous occasions over a period of three years with a view to his possible deportation as an alien and that at all times he had told Immigration officials an untrue story as to his family and birthplace, but such a story that they were unable to prove either the truth or falsity of his statements. Being suspicious that he was a Norwegian, arrangements were made as indicated above to forward a copy of his prints to the authorities in Norway. Subsequently, in September, 1933, advice was received from the authorities in Norway that a search of the fingerprints transmitted by the Division against the files of the Identification Bureau in that country reflected an extensive criminal record there and also furnished absolute evidence that Hansen had been born at Lindas, Norway on June 3, 1895.

The above information was furnished the Immigration authorities and with the assistance of this positive proof of his foreign birth, deportation proceedings against him were successfully prosecuted.

This case is a striking example of the effectiveness of fingerprints not only in ascertaining complete records of international criminals, but also in providing indispensable evidence for the Immigration authorities in connection with deportation cases.
