The Federal Bureau of Investigation, United States Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act  
Interstate transportation of stolen property valued at \$5,000 or more  
National Bankruptcy Act  
Interstate flight to avoid prosecution or testifying in certain cases  
White Slave Traffic Act  
Impersonation of Government Officials  
Larceny of Goods in Interstate Commerce  
Killing or Assaulting Federal Officer  
Cases involving transportation in interstate or foreign commerce of any persons who have been kidnaped  
Extortion cases in which interstate commerce or interstate communication is an element  
Theft, Embezzlement or Illegal Possession of Government Property  
Antitrust Laws  
Robbery of National Banks, insured banks of the Federal Deposit Insurance Corporation and Member Banks of Federal Reserve System  
National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds  
Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property  
Neutrality violations, including the shipment of arms to friendly nations  
Frauds against the Government  
Crimes in connection with the Federal Penal and Correctional Institutions  
Perjury, embezzlement, or bribery in connection with Federal Statutes or officials  
Crimes on the high seas  
Federal Anti-Racketeering Statute  
The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

The Bureau does not have investigative jurisdiction over the violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

Law enforcement officials possessing information concerning violations over which the Bureau has investigative jurisdiction are requested to promptly forward the same to the Special Agent in Charge of the nearest field division of the Federal Bureau of Investigation, United States Department of Justice. The address of each field division of this Bureau appears on the inside back cover of this bulletin. Government Rate Collect telegrams or telephone calls will be accepted if information indicates that immediate action is necessary.



Law enforcement has come to be recognized as both an art and a science. Those who are engaged in this profession are recognizing more and more the need of high standards of selection in the field of law enforcement and for careful training of a well-adapted personnel in order to obtain the most satisfactory results in this field of activity. In other words, law enforcement is now established on a professional basis and as is true of all great professions, its code of ethics and standards of conduct must be clearly defined in order to govern the activities of those engaged in such a profession.

With a view to codifying the rules of conduct for the professional law enforcement officer, a pledge has been prepared for the voluntary consideration, acceptance, execution, and adherence by all law enforcement officers. Just as those entering the medical profession take the oath of Hippocrates and as those engaged in the profession of law are required to adhere to canons of ethics enunciated by the members of that profession, so are all the Special Agents of the Federal Bureau of Investigation executing the FBI Pledge for Law Enforcement Officers.

This pledge is likewise being submitted for execution by the members of the FBI National Police Academy, and all the graduates of the Academy, and will also be submitted to those who enter any future training schools of the Federal Bureau of Investigation.

Copies of this pledge will be made available to any law enforcement organization so that they may be executed by all those engaged in law enforcement work, and placed in the records of the Federal Bureau of Investigation as an enlistment in law enforcement work as a profession.

## THE FBI PLEDGE FOR LAW ENFORCEMENT OFFICERS

Humbly recognizing the responsibilities entrusted to me, I do vow that I shall always consider the high calling of law enforcement to be an honorable profession, the duties of which are recognized by me as both an art and a science. I recognize fully my responsibilities to defend the right, to protect the weak, to aid the distressed, and to uphold the law in public duty and in private living. I accept the obligation in connection with my assignments to report facts and to testify without bias or display of emotion, and to consider the information, coming to my knowledge by virtue of my position as a sacred trust, to be used solely for official purposes. To the responsibilities entrusted to me of seeking to prevent crime, of finding the facts of law violations and of apprehending fugitives and criminals, I shall give my loyal and faithful attention and shall always be equally alert in striving to acquit the innocent and to convict the guilty. In the performance of my duties and assignments, I shall not engage in unlawful and unethical practices but shall perform the functions of my office without fear, without favor, and without prejudice. At no time shall I disclose to an unauthorized person any fact, testimony, or information in any pending matter coming to my official knowledge which may be calculated to prejudice the minds of existing or prospective judicial bodies either to favor or to disfavor any person or issue. While occupying the status of a law enforcement officer or at any other time subsequent thereto, I shall not seek to benefit personally because of my knowledge of any confidential matter which has come to my attention. I am aware of the serious responsibilities of my office and in the performance of my duties I shall, as a minister, seek to supply comfort, advice and aid to those who may be in need of such benefits; as a soldier, I shall wage vigorous warfare against the enemies of my country, of its laws, and of its principles; and as a physician, I shall seek to eliminate the criminal parasite which preys upon our social order and to strengthen the lawful processes of our body politic. I shall strive to be both a teacher and a pupil in the art and science of law enforcement. As a lawyer, I shall acquire due knowledge of the laws of my domain and seek to preserve and maintain the majesty and dignity of the law; as a scientist, it will be my endeavor to learn all pertinent truth about accusations and complaints which come to my lawful knowledge; as an artist, I shall seek to use my skill for the purpose of making each assignment a masterpiece; as a neighbor, I shall bear an attitude of true friendship and courteous respect to all citizens; and as an officer, I shall always be loyal to my duty, my organization, and my country. I will support and defend the Constitution of the United States against all enemies, foreign and domestic; I will bear true faith and allegiance to the same, and will constantly strive to cooperate with and promote cooperation between all regularly constituted law enforcement agencies and officers in the performance of duties of mutual interest and obligation.

## INTERNATIONAL COOPERATION IN IDENTIFICATION

Address of Colonel S. T. Wood, Assistant Commissioner and Director of Criminal Investigation, Royal Canadian Mounted Police, delivered before the Twenty-third Annual Convention of the International Association for Identification at the Willard Hotel, Washington, D. C., September 29, 1937.

The definition of "Identification" is given as follows: "TO PROVE TO BE THE SAME." It is without question the most important science in the study of the prevention and detection of crime.

It was my good fortune two years ago to visit England, France and Belgium and study their police systems. I was at once impressed with the fact that radical re-organization and expansion was then taking place in all the large forces of those countries, one of the main purposes being to improve their methods of identification. Tremendous sums of money are now being spent with this object in view. Although I had read beforehand all available books and articles on police organizations on the continent, I soon found they were obsolete and, at this moment, I doubt if an authentic article on the organization of one of the continental police forces could be written for they are all experimenting and effecting changes. On my return two years ago I began to look about me and came to the conclusion that we on this side had been going through much the same experience as is exemplified in your own Federal Bureau of Investigation. Our own Force has undergone many changes with considerable expansion and we are continually on the lookout for new ideas in police and identification methods. In so far as England is concerned, I was permitted to re-check on changes there since my visit of two years ago when I attended the Coronation in May last. Even in that comparatively short interval much has been accomplished.

It has been my experience that the most important single factor in the development of a sound system of cooperation between police organizations of different countries is the establishment of really good personal working arrangements among the people who are actually doing the work. Systems of codes and so forth are valuable and indeed essential but however perfect a system may be on paper, it is unlikely to work as it should, unless and until the persons responsible for working it understand each other's problems and have established personal working arrangements. The more informal these arrangements are the better they are likely to work. From this point of view periodical conferences of police officials who are doing the work, are of great value so that if a peace officer here at Washington wants some information in a hurry about a foreign criminal in this country he can write or even telephone to the appropriate bureau and speak there to someone he has met and who will be more disposed to go out of his way to help than he might be if he were merely dealing with an official telegram. Having got the personal relations on a satisfactory basis, the maximum benefit can be derived from perfecting the actual machinery of communications.

Various measures have been taken by European Police Forces to improve and systematize their working arrangements and for the last ten



years or so the International Criminal Police Commission has been prominent in this connection. This is a body, with its headquarters at Vienna, Austria, on which most of the European countries and some others are represented. It meets in a different capital once a year for the discussion of common problems. The idea of the International Criminal Police Commission germinated after the war when the disturbed situation in Europe led to a large increase in the activities of international criminals; the countries which took the initiative were Austria and Holland. Its functions are two-fold, namely the working of executive machinery for dealing with international crime and the undertaking of research or enquiry into various problems of police technique for the benefit of the police service as a whole. Apparently this organization has produced definite results in an increase in the efficiency of the machinery for fighting crime.

The Bureau of the Commission is situated at Vienna and its executive functions, being centered on that capital, are naturally designed to serve the countries of Central and Southern Europe in the first instance. Some of these functions have a very wide sphere of usefulness. For instance, the Bureau keeps elaborate records of international criminals and circulates to countries which subscribe to it a periodical, on the lines of the police bulletins, giving information as to the movements, etc., of important criminals who are likely to operate on an international basis. For this purpose, the Bureau is fed by the forces constituting the Commission with the necessary particulars of criminals who merit circulation.

More recently the Commission has established an International Police Wireless Service, which is operating successfully over an area embracing many European countries and it has had some very promising results.

In England, Scotland and Wales Committees composed of prominent police officials of the Government and the various city, borough and county forces are working on similar local problems, such as regional wireless systems, regional laboratories, training, detective work, with good results. One of these Committees under the leadership of Mr. Howe, Assistant Commissioner of the London Metropolitan Police, recently visited the United States and Canada to study police methods. In order to understand the situation there, it is necessary to explain the setup. The British Government, through the Home Office, pays one-half the cost of all police organizations in that country including buildings and equipment, and exercises supervision over these forces by means of two or more Inspectors of Constabulary. The duties of these latter officials consist of inspecting the various city, borough and county forces and reporting on their efficiency to the Home Office. Thus pressure may be brought to bear on these forces to put in practice any policy which these Committees may recommend to and be approved by the Government.

Of the different methods of identification and the possibilities of international cooperation, fingerprinting is the one method common to all countries. Aside from its importance to law enforcement agencies, this science is of equal importance to the general public though unfortunately the public does not, as yet, fully appreciate this fact. It is perhaps un-

fortunate that fingerprints have been connected in the public mind with criminals and, therefore, a certain odium is attached thereto. As we know, much uncertainty and many heartaches to next-of-kin would be saved if fingerprinting were universal.

Various codes have been devised to transmit fingerprint classifications from one country to another but, I believe all identification officials must agree, no matter how complete a telegraphed code of fingerprint impressions may be, it is still necessary for the purpose of positive identification to forward a set of the prints in question for comparison. In our opinion, no great improvement may be expected in this direction other than by more rapid means of communication or possibly television. The latter seems to have distinct possibilities, not only in connection with fingerprints but photographs.

With the present day airmail and other fast mail services between the United States and Canada, there is not much necessity to telegraph fingerprint data or make use of any code. In my opinion, however, we should be on the lookout for possible future advances in the science and be prepared. Above all things it appears to me that this most important science of fingerprinting should be protected, whereas we know repeated attempts are being made to undermine public confidence in its infallibility.

In connection with the International Overseas Exchange of Criminal Records: Although time is an important factor it is essential that each country have one Central Bureau through which all correspondence may be routed to ensure uniformed procedure. The problem is to educate police departments to cooperate by forwarding through the Central Bureau their requests to foreign police forces. In fact I understand that here, as in Canada, the State Department has expressed a desire to have all such correspondence forwarded through the Federal Central Bureau.

The advantage of following this system is obvious, for not only are the records of the Central Bureau augmented but the contributing agency is assured of more complete criminal histories. In other ways the Central Bureau is in the happy position of being better informed as to the requirements of each foreign country and usually employs qualified translators to handle this correspondence. Again, foreign countries could not be expected to know the identity of all local police departments and would experience difficulty in replying to their communications.

The main consideration from the administrative point of view seems to be to secure that the fingerprints of international criminals and their photographs be circulated by the country responsible for them to the police of any other country which they are thought likely to visit.

Whilst fingerprinting is in general use on the continent other means of identification vary considerably. Photography is of equal importance to fingerprinting as a means of identification and it was found that other countries make far more use of the photographer than we do on this side. An elaborate series of photographs are recorded in conjunction with an ac-



curate drawing or plan of practically every type of crime, as well as serving as a record of unidentified bodies. The police photographer of a raiding party is the first to enter to snap photographs before the inmates can gather their wits and protest. This is good evidence in the case of speak-easys; gambling joints; illegal betting transactions.

In France exactness of detail in photography is carried to the extent of taking all photographs the same size so when mounted on a mat, the border of which is marked off in the metric system, it is possible to ascertain the exact size of any article or object appearing in the photograph. Photographs of criminals are taken in three postures -

- (1) Full face without hat,
- (2) Right profile without hat,
- (3) Three-quarter face with hat.

They claim that were it not that enlargements of the right ear were required at times, the photograph in profile could be dispensed with. In England photographs are taken -

- (1) Right profile,
- (2) Full face with hat.

In Canada we are trying to standardize the latter although there is argument as to whether the hat does not cause shadows and conceal features while, on the other hand, there is the contention that the type of hat and angle at which it is worn assists greatly in identifying a wanted person. Sweden has, in our opinion, the most practical method, namely three photographs of the one person on a sheet about 4x3 - top left, full face without hat; immediately below, bottom left, right profile without hat, while the right side of the sheet contains a full length picture of the individual with hat and in normal dress.

The International Criminal Police Commission of Vienna in 1923 prepared and brought into operation a telegraph code for use of their subscribers in transmitting information (not fingerprint classifications) regarding criminals. This code was founded on the three letter system and was supposed to save time in decoding and to guarantee secrecy. It has not been used to the extent that it could be deemed a success and, in my opinion, is too complicated. Something less elaborate could serve the English speaking countries.

Another problem to which the Commission has been applying itself is the question of evolving a standard form of personal description for the use of all police forces. At the moment complete agreement between the different countries has not been arrived at for each is naturally wedded to its own national system.

In France the Bertillon System of Identification by means of measurement was discarded in 1925 on the death of Bertillon in favour of fingerprinting. True, the Bertillon System of Identification is still con-



tinued but in modified form in registering the descriptions of persons in what they describe as "Portrait Parle" or the spoken likeness. This system is based on describing in detail certain features, principally the right ear, nose, forehead and eyes. For instance there are twelve different points of identification in describing the ear alone; nine in the case of the nose, etc. No measurements are recorded. It is a fascinating study and it is the proud boast of the French Detective that with such a description in his possession he can identify a man from among a crowd of one hundred in less than two minutes. I was much impressed with this system which, after all, is merely a matter of improving the power of observation. Portrait Parle as at present in use in France as devised by Bertillon is perhaps too elaborate for other countries in its present form.

A Committee formed by the Home Office in England is working on a standard description form and it seems to me that here is a question that we on this side might give some thought to and possibly collaborate with that Committee.

My travels abroad have made me a firm believer in centralization in so far as all criminal data is concerned including fingerprints, photographs, criminal records, modus operandi, police publications, ballistics, handwriting, etc. In making this statement do not take it that I am opposed to local identification bureaus in the large centers for I consider these serve a very useful purpose but, when some person comes along and advocates one central bureau for the Pacific Coast separate and distinct from one for the Midwest and another for the East on the allegation that criminals do not move from their respective districts, then I do not agree with that person. This latter is the situation into which at least one European country is now drifting and will, in my opinion, seriously affect the expeditious and efficient handling of crime in that country. If I may offer you a suggestion, it is this - as you have in your FBI an efficient law enforcement organization with the very best facilities for housing all the criminal records of the United States, that you do everything possible to support and build up this one Bureau and oppose any attempt at decentralization.

You will have noted that the European countries have for some time been engaged, through the International Criminal Police Commission at Vienna and their respective Police Committees, in studying all phases of and new developments in police technique with a view to international cooperation. It is suggested that we on this continent should do likewise by appointing a Committee whose business it would be to -

- (1) Study methods whereby international cooperation between law enforcement agencies may be improved and organized on a sound basis;
- (2) Conduct research and enquire into problems for the benefit of all law enforcement agencies;

- (3) Contact and collaborate with various commissions or committees in Europe which are engaged in the study of police technique, organization and equipment.

The whole question of international cooperation in identification boils down to the common sense application of the precept that any police force, however big or small, is to some extent dependent upon the cooperation of other forces if it is to deal efficiently with its own crime problem and, therefore, any cooperative measures designed to assist any other force are bound in the long run to add to the efficiency of the force giving this assistance equally with those which receive it.

In closing it is desired to express appreciation of the cordial cooperation received from the Director, Mr. Hoover, and his Federal Bureau of Investigation here in Washington, and to thank all United States Police Departments and State Police for most considerate attention to our many requests for fingerprints, photographs and criminal data.

## INTERNATIONAL COOPERATION

The international exchange of fingerprint identifying data initiated by the Federal Bureau of Investigation in March, 1932, at the present time associates eighty-two foreign countries, territories and possessions in an extensive coordination of identification activities having for their purpose the exchange of complete records of criminals operating on an international scale.

Fingerprints and criminal records of persons arrested in this country are routed by the Bureau to the appropriate foreign bureaus in cases wherein the interested agency in the United States has reason to believe an individual in custody may have a record in, or be wanted by another nation. Similarly, the fingerprints of persons arrested outside the continental United States are referred by the foreign bureaus to the Federal Bureau of Investigation for search in its files when it would appear a record would be disclosed by such a search.

The international exchange of fingerprint information and other cooperative activities between law enforcement officials on an international scale were discussed at the recent annual convention of the International Association for Identification in Washington, D. C., as reflected by the address of Colonel S. T. Wood, Assistant Commissioner and Director of Criminal Investigation, Royal Canadian Mounted Police, which is quoted above.

## INTERNATIONAL WORLD POLICE CONVENTION

The 1937 Convention of the International World Police was called to order at 10:00 A.M., Monday, October 25th, in one of the salons of the Mount Royal Hotel, Montreal, Canada, with the President, Fernand DuFresne, Director of Police, Montreal, Canada, presiding and with the Honorable Barron Collier, Chairman of the Advisory Committee, and the Honorable A. Raynault, Mayor of Montreal, sharing the honors of the occasion with the President. Mayor Raynault extended the greetings and best wishes of the host city. There were present forty-five outstanding law enforcement officials from Canada, the United States, and various foreign countries.

After a short address by the President, there followed a series of addresses by other internationally known law enforcement officials. Inspector Leon V. Jenkins of the Portland, Oregon, Police Department and immediate Past President of the International Association of Chiefs of Police, spoke on the "Value of Personal Contacts Between International Police Heads," and was followed by Chief Constable P. J. Sillitoe of Glasgow, Scotland, who addressed the convention on "The Scottish Police." Chief Constable Sillitoe stressed the necessity of world-wide cooperation between all law enforcement agencies and pointed out particularly two instances in which the Federal Bureau of Investigation had assisted the Scotland authorities as being typical of the desired type of cooperation.

Lieutenant Colonel Leon Lambert, Assistant Chief of the Provincial Police of Quebec, Canada, outlined the activities of his organization in his talk on "Quebec Provincial Police Matters," expressing the opinion that more consideration should be given to the good citizens of various countries who had committed no crimes than to the convicted criminals throughout the world.

Chief of Police William J. Quinn of San Francisco, California, presented a masterly paper on "America's Narcotic Problem," in which he traced the growth of the problem and outlined the active steps being taken to combat it in the State of California.

On the opening day of the Convention, the delegates were luncheon guests of the Quebec Police and Fire Chiefs' Association at the Hotel Windsor. At this luncheon all delegates were introduced. The Honorable Barron Collier was awarded an honorary life membership in the Quebec Police and Fire Chiefs' Association.

Chief P. J. Siccardi of the Bergen County, New Jersey, Police and a Past President of the International Association of Chiefs of Police, addressed the Convention on "Police Schools and Their Successful Functioning," pointing out the growing trend towards well-trained police officers. He was followed by Mr. A. Killick Mayall of Oldham, England, Past President of the Chief Constables' Association of England and Wales, who outlined the development and activities of the English Police. Deputy Chief Inspector John J. O'Connell of New York City spoke on the subject "New York's Scientific Police Laboratory," citing several cases in which the department's



laboratory had been of great help in the solution of crimes.

On the evening of the first day of the convention, a welcoming dinner was tendered the delegates in the Mount Royal Hotel with the President of the International World Police presiding and the Honorable Maurice Duplessis, Prime Minister and Attorney General of the Province of Quebec, as guest speaker. At the conclusion of the dinner the delegates attended a Musical Ride by the Montreal Mounted Police and a demonstration by the Montreal Police Cadet Corps, both exhibitions being held in the Armory of the 17th Duke of Royal Canadian Huzzars.

The activities on the second day of the convention were opened with an address by the Honorable Barron Collier, entitled, "Public Safety in Major Cities," in which Commissioner Collier expressed the hope that the annual meeting of the International World Police would succeed in drawing the law enforcement officials of all countries closer together.

Superintendent of Police Charles A. Wheeler of Bridgeport, Connecticut, next spoke on the subject, "American Police Radio," and was followed by Brigadier General D. C. Draper, Chief Constable of Toronto, Canada, who addressed the convention on the subject, "Co-ordination in Law Enforcement and the Treatment of Criminals." General Draper, in the course of his remarks, deplored the lackadaisical attitude and treatment of the very important parole and ticket-of-leave systems in Canada and the United States.

At noon on this date, Mr. John Edgar Hoover, Director of the Federal Bureau of Investigation, spoke on the subject, "Federal Cooperation with State, Municipal and Foreign Police." Director Hoover's address was broadcast through Canada and the United States and stressed particularly the probability of criminals plying their trade on an international scale with the advent of more rapid methods of transportation. He informed the delegates that the Federal Bureau of Investigation was looking forward with keen anticipation to their visit to Washington and the Bureau on the next day.

At the opening afternoon session of the convention on the second day, Commissioner K. H. Broekhoff of Amsterdam, Holland, read a paper on the "Suppression of Currency Counterfeiting," using recent European cases to illustrate his points.

On the same afternoon Deputy Superintendent of Police John M. Anderson of Boston, Massachusetts, read a paper on "Labor and Law Enforcement" and was followed by Sir James MacBrien of Ottawa, Canada, Commissioner of the Royal Canadian Mounted Police, who spoke on the subject, "History, Organization, Training and Work of the Royal Canadian Mounted Police." Commissioner MacBrien pointed out that his organization was at present divided into fourteen divisions with laboratories at Ottawa and Regina and that he had instituted in 1936 a reserve of approximately three hundred men from which active appointments to the force are made.

Dr. Eugene Bianu of Bucharest, Roumania, Director General of

Public Security, read a short paper on the "Social Character of Police Work," as did Director of Police K. Welhaven of Oslo, Norway, who discussed general law enforcement problems.

The Honorable A. Raynault, Mayor of Montreal, tendered an official dinner, on behalf of the city, on the evening of the second day of the convention, at the conclusion of which the delegates entrained for Washington, D. C., via New York City. A diner and special coach had been provided by Commissioner Collier for that portion of the trip between New York City and Washington, and breakfast was served the delegates en route from New York City to Washington.

Upon their arrival in Washington shortly after noon, the delegates were met by cars from the Federal Bureau of Investigation and taken immediately to the Mayflower Hotel where a luncheon was given for them in the Italian Gardens of that hostelry by Mr. John Edgar Hoover, Director of the Federal Bureau of Investigation. No talks were made at this luncheon but a toast was drunk to Director Hoover by the delegates in appreciation for his hospitality.

The members were then conducted on a two-hour tour of the Federal Bureau of Investigation in the Department of Justice Building, returned by automobile to the station and entrained for New York City at 5:00 P. M.

### JACK GOSS IDENTIFIED IN FBI LAW ENFORCEMENT BULLETIN

A fugitive was identified through the use of the FBI Law Enforcement Bulletin within ten minutes after the publication was received by the Charlotte, North Carolina, Police Department.

Jack Goss, an escaped convict from the State Penitentiary at McAlester, Oklahoma, was arrested by local authorities shortly after he had held up and robbed a grocery store of \$162, at Charlotte.

He was taken to the Charlotte, North Carolina, Police Department where he was fingerprinted. The identification officer had received the November issue of the FBI Law Enforcement Bulletin about ten minutes before the subject was fingerprinted.

His prints were compared with those of the wanted fugitives in the Bulletin and on page 35 it was found his were identical with those of Jack Goss. The interested parties were notified.

This perhaps is one of the quickest identifications which have ever been made by means of the FBI Law Enforcement Bulletin.



## LEGISLATION AND THE POLICE

Address delivered at the Twenty-third Annual Convention of the International Association for Identification in Washington, D. C., October 1, 1937, by State Representative Richard J. Lyons, Libertyville, Illinois.

Mr. President, members of the International Association for Identification, Ladies and Gentlemen:

You may be sure I deeply appreciate the privilege of addressing this international group of scientific law enforcement officials because it gives me an opportunity to focus attention upon those legislative bodies which, in my judgment, are chiefly responsible for most of the crime that is rampant throughout America at the present time.

And, unless enough attention is focused upon them, especially by the American public, this appalling crime situation will not only continue but will become even greater as the years go by.

It would be difficult to overestimate the importance of legislative bodies in any practical discussion of the great American crime problem. Viewed from every angle, crime reduction depends principally upon the proper support of our law-making bodies. And, by the same token, it can easily be shown that nearly every outstanding weakness in our defense against crime may be attributed directly to the blighting effects of corrupt politics in the halls of our state legislatures.

We cannot have efficient law enforcement organizations unless we make police work an honorable and well paid profession, entirely independent of politics and politicians; and this can be accomplished only when legislatures are compelled through public opinion to pass laws completely divorcing police work from politics.

The legislatures of the various states are directly responsible for lax laws pertaining to crime and criminals.

In the limited time allotted me today, I wish to emphasize in particular our present day parole systems which have become a disgrace to modern civilization and which cry out to high heaven for legislative reform.

I charge that legislators themselves, in many cases, are more interested in "how can I spring so and so out of prison" than in how can we keep him where he properly belongs until he has served his time.

I sincerely do believe in the laudable aims and purposes of the parole system, especially in the cases of first offenders where the circumstances clearly indicate that the convict is entitled to another chance.

But I am unalterably opposed to politically appointed parole boards which sell paroles to dangerous criminals like fish in the market.



Through this damnable parole system, politics and politicians undo more in one month than all the police and courts can accomplish in a year. In the State of Illinois, we have had more sex crimes and killings by paroled brutes during the past year than ever before in the history of the state, yet the parole board is actually turning them out faster than the police can apprehend and the courts convict them.

The official records for Illinois show that during the year 1935, approximately 1000 convicts were sent to the penitentiary and that 1150 were PAROLED during the same period.

I sincerely believe that you will never have honest and impartial justice in parole until you get rid of the political parole board and make it a career position. Personally, I would like to place the power of parole in the hands of the courts. The court sentences the criminal; the court should release him, either when his time is up or via parole. With the power of public opinion centered upon the courts, judges could not stoop to do the things that our notorious parole boards are doing at this time.

We tried hard in Illinois during the recent session of the legislature to change the parole laws in order to make them more workable, to place in the hands of the court the right to determine how much time a man should serve, etc. But politics was more powerful than sound reasoning or a real sense of justice and, therefore, politicians defeated every effort to correct the scandalous conditions that still exist in one of the most politico-criminal states of the Union.

We spend millions upon millions of dollars to apprehend and convict murderers and other criminals and as fast as one is put in prison, some political racketeer starts the machinery of politics in order to release him.

Let me cite you a typical case in point.

A robbery was committed in Lake Forest, Illinois, at the home of William Mitchell. The crime was committed by five armed men, the leader of whom was a paroled convict. This parolee's name was Nick Maentanis. He, together with the other four, was apprehended and indicted by the grand jury and tried in the Circuit Court of Lake County. They were defended by able lawyers, the chief counsel for the defense being an eminent Chicago criminal lawyer.

A jury found the defendants guilty of robbery while armed with dangerous weapons. Motion for a new trial was heard and overruled. The defendants were sentenced to the penitentiary for a long period of years. An appeal was made to the Supreme Court, where the judgment of the lower court was affirmed and the defendants were lodged in the penitentiary at Joliet, as of February 19, 1932. This all happened in the year 1932.

One year later, in January, 1933, the defendant, Nick Maentanis, made application to the Illinois Parole Board for parole and a hearing was

had by the subcommittee at Joliet. At that time the State's Attorney of Lake County made an objection and requested the Secretary of the Parole Board to notify him if it was necessary for him to appear before the Parole Board in order to press his protest.

Under date of January 23, 1933, the secretary notified the State's Attorney of Lake County that it would not be necessary for him to appear as his protest would be given careful consideration. The State's Attorney again received notice in April, 1933, that the defendant would have a second hearing before the board on May 1, 1933. A telephone conversation was had with the Secretary of the Parole Board and he stated that final action would be taken and that the protest of the State's Attorney would be given consideration; and, further, that the State's Attorney would then be notified.

May 27, 1933, the State's Attorney of Lake County was notified that parole was denied in the case, and that the defendant could not again be heard by the Parole Board until the defendant had served a total of five years, five months and fifteen days, including good behavior.

Then, without advance warning of any kind, the State's Attorney of Lake County was notified on October 16, 1935, that the defendant, Nick Maentanis, was paroled and that he would do his parole in the City of Chicago, County of Cook, State of Illinois.

This, gentlemen, was a flagrant and typical violation of all the real and broad underlying principles of parole.

Is it any wonder that George E. Q. Johnson, former U. S. District Attorney in Chicago, in a copyrighted article, stated that paroles are for sale and that the prevailing price is five thousand dollars, with a bargain once in a while for twenty-five hundred dollars?

Here then is my criticism of the legislature. Whenever bills are placed before that august body to modernize the parole system and to prevent sex criminals, morons and murderers from being released, political crooks in the legislature, together with the professional social workers, sob sisters and mushy sentimentalists, promptly get busy and proceed to take just such steps as may be necessary to prevent the passage of effective parole laws.

In Chicago recently, we have experienced a veritable epidemic of vicious sex crimes. Armed morons and murderers are prowling around in our midst and many of our policemen, not only in Chicago, but throughout Illinois have been shot down in cold blood. In nearly every instance when the guilty party is apprehended, he is found to be a paroled convict.

As a result, the Chicago newspapers have been giving the widest possible publicity to this scandalous situation. "The heat is on" and the public is aroused as never before.

In response to this unmistakable protest from the press and



public, the Governor of Illinois made several gestures to help reduce the "heat" and attempt to whitewash a rotten parole administration.

The legislature also responded and after overcoming much bitter opposition, actually passed one bill to help relieve the frightful conditions that still prevail. This bill had the endorsement of practical law enforcement authorities but was opposed by some professional social reformers.

Just as a great victory for society was being won, the Governor vetoed the bill, thereby placing the whole miserable situation right back where it was originally, at its worst.

I am not attacking the honesty of purpose of the Governor, but I do say that he listened to the siren voice of professional reformers rather than to men of seasoned experience and sound judgment, who constitute the leading law enforcement groups of Illinois.

May I suggest at this time that the law enforcement bodies are themselves partly to blame for the failure to pass more favorable laws to promote police progress and help in the war against crime. By this I mean they have been too modest in using their strength and combined influence in making direct appeals to the legislatures. In other words, they have failed to maintain a vigorous and aggressive lobby to put over the kind of laws that are needed. Instead, they have usually left that most important feature to self-constituted reformers. These busy-bodies are at best only a swarm of pests who accomplish nothing in the way of real reform. And, at worst, they are to be found as tools who "front" for professional racketeers and help to prevent all real and lasting reform.

Ten long years of continuous service in the storm center of the Illinois legislature have taught me some valuable lessons in practical statesmanship which, when translated, means how to get laws passed.

I have watched at close range and with critical interest how the bankers associations, agricultural associations, labor organizations and manufacturers associations get laws placed upon the statute books. You know as well as I, that they get them placed there due to their intense lobbying and active participation in legislative activities. This the police have failed to do, believing it was not their duty. It was, therefore, generally left to crime committees and other would-be civic committees. Only recently, in Illinois, have the police, not only of the cities and villages, but also the special police of the railroads and other institutions for law enforcement, taken an active part in securing effective crime legislation.

As a direct result of their commendable participation, we now have upon the statute books of Illinois, the laws which created the State Bureau of Criminal Identification and Investigation; also a law making it a felony for one to have in his possession a machine gun when not an officer of the law.

We passed another bill, setting up a most modern state police

broadcasting system, and more recently we passed a bill, giving minimum wages to the police officers in the downstate cities of Illinois.

Here, for the first time, we have seen the effect of organized crime fighters, participating in and securing sound crime prevention legislation; and I want to emphasize to this gathering the necessity of a powerful, organized group of police officers to invade the legislatures of every state in the Union. Let them demand of those bodies, powerful crime fighting laws that will prevent, in a measure, the criminal-political alliances.

The unholy alliance of crime and politics is one of the saddest pages in America's history. We know it to be a fact that many criminals laugh at the police and the courts because they have powerful henchmen waiting to "spring" them. And the nauseating part of it is that some of these henchmen are supposed to be honorable public officials.

I know of the case of one legislator who was very successful, financially, due to his many appearances before the parole board in the State of Illinois. True, he was a lawyer, but he was also a member of the legislature. Here, in my judgment, should be the beginning of a means to smash the political-criminal alliance; and I want to suggest to this distinguished gathering today, a bill that would place upon the statutes of every state a law making it a felony for any member of any legislature, or, in fact, any elected public official, to appear before any parole board or in any way attempt to aid any convicted person in securing parole or fixing a case while he holds public office.

You may say this is strong language. Well, I say you must not only use strong language but also pass strong laws in order to fight this hideous monster.

Gentlemen, this is what you law enforcement officers must, as organized bodies, begin to fight. I say there is absolutely no place in American political life for political crooks, and the time has now arrived to drive out of office any man, Republican or Democrat, who associates himself with crime and criminals; and, if you want to start at the right place, I would say, begin with the legislatures in the larger states of the Union.

A short time ago, decent men who are honestly trying to fight this crime menace, arose one morning and learned that J. Edgar Hoover, Director of the Federal Bureau of Investigation, had launched a fight in America upon the political-criminal alliances, and now men have taken courage who, for political reasons, were formerly very timid about "getting their necks out."

Thank God, we have at the head of the Federal Bureau of Investigation a man who exemplifies law and order! Thank God, we have a man who is fearless and who projects hope and encouragement out into the hearts and minds of other law enforcement officers throughout America; and if we will but follow his precepts--if we will take courage from his actions, I can see in the not far distant future, when shady ravines will never again be drenched



with the blood of ravished little girls, such as occurred only a short time ago in distant California.

While America is still the most crime-ridden nation on the face of the earth, yet we have reason to rejoice at the present outlook in our relentless warfare against crime and criminals.

I have singled out sex crimes and the parole problem for special treatment partly because they happen to be the most scandalous crime subjects of the hour. And in this connection, I have aimed to make clear the responsibility of our legislatures in this deplorable state of affairs.

But, in my judgment, the stage is now set for greater progress than ever before in this country-wide fight against crime.

Statistics show a steady and substantial reduction in major crimes for the past several years, since our country became thoroughly aroused to the awful seriousness of the situation.

The time is therefore ripe, in my judgment, for the organized groups of law enforcers everywhere to fight for needed reforms as never before.

The "heat" is on, and crime and criminals are on the run. The forces of political corruption in high places are painfully aware of this fact, and they, too, are already hurrying and scurrying for safety to the storm cellars. They are at last ready to listen to reason; and, if properly approached by organizations such as yours, I now feel safe in predicting a further brilliant and lasting victory for the forces of law and order, and greater contentment and peace of mind for our families and loved ones, in every home of the land.

### MURDER OF ISADORE SCHWARTZ

Isadore Schwartz, a pawnbroker at Pueblo, Colorado, was murdered while selling a secondhand gun to an unknown customer. It was presumed that the potential purchaser, while examining the gun offered for sale, loaded it and killed Schwartz. Near the body were found three empty cartridge cases, two spent bullets which had passed through the body of the victim and a third spent bullet was removed from a wooden panel. Later the gun missing from the pawnshop was located by the members of the Denver, Colorado, Police Department in a Denver pawnshop. Willis Wynn who pledged it was taken into custody and charged at Pueblo with the murder. The Chief of Police at Pueblo sent the automatic pistol to the Federal Bureau of Investigation to determine if the spent cartridge cases and bullets found at the scene of the murder had been fired in the suspected weapon. In the Bureau's Laboratory at Washington, D. C., a microscopic study of the specimens revealed that the bullets were fired from the weapon. On February 18, 1937, the Bureau's laboratory expert appeared in Pueblo and gave testimony in the trial of the murder charges against Willis Wynn. The defendant was convicted and the death penalty affixed.



## THE TECHNICAL LABORATORY

The value of scientific laboratory study of certain types of physical evidence obtained in criminal investigations has been amply demonstrated by the results accomplished since the establishment of the Technical Laboratory of the FBI at Washington, in the Fall of 1932.

Eugene S. Willis was a private in the Sixth Corps Area, Selfredge Field, Michigan, and was suspected of having forged and uttered several checks in Mount Clemens, Michigan. A complaint was filed against him by the local authorities charging him with forgery, but he was discharged in the state case because the bank teller who cashed the checks for Willis was unable to identify him as the man who had received the money at the local bank. The officers in charge of the Sixth Corps Area were not satisfied with this verdict, and they submitted the questioned checks with specimens of Willis' known handwriting to the Technical Laboratory of the Federal Bureau of Investigation. Specimens of the writing of two typewriters to which Willis had access were also submitted. Upon the completion of the examinations in the Laboratory, the report was furnished the officer in charge that the handwriting appearing on the checks was that of the suspect, Willis, and that the typewriting appearing thereon was written on one of the known typewriters. The expert of the Technical Laboratory who conducted the examinations upon request went to Michigan and testified as to his findings. Willis was court martialed and sentenced to five years imprisonment in a Federal Prison.

The Technical Laboratory of the Federal Bureau of Investigation received from the Baltimore police three guns used in a shooting affray in which the late Alfred Brady was involved. After examinations, it was found that two shells submitted by the Cincinnati Field Division of the Federal Bureau of Investigation, on June 7, 1937, in connection with the robbery of the Citizens State Bank of Greenville, Ohio, were fired from one of these guns. The Brady gang had already been considered the perpetrators of this robbery, and this provided a further link in the chain of evidence.

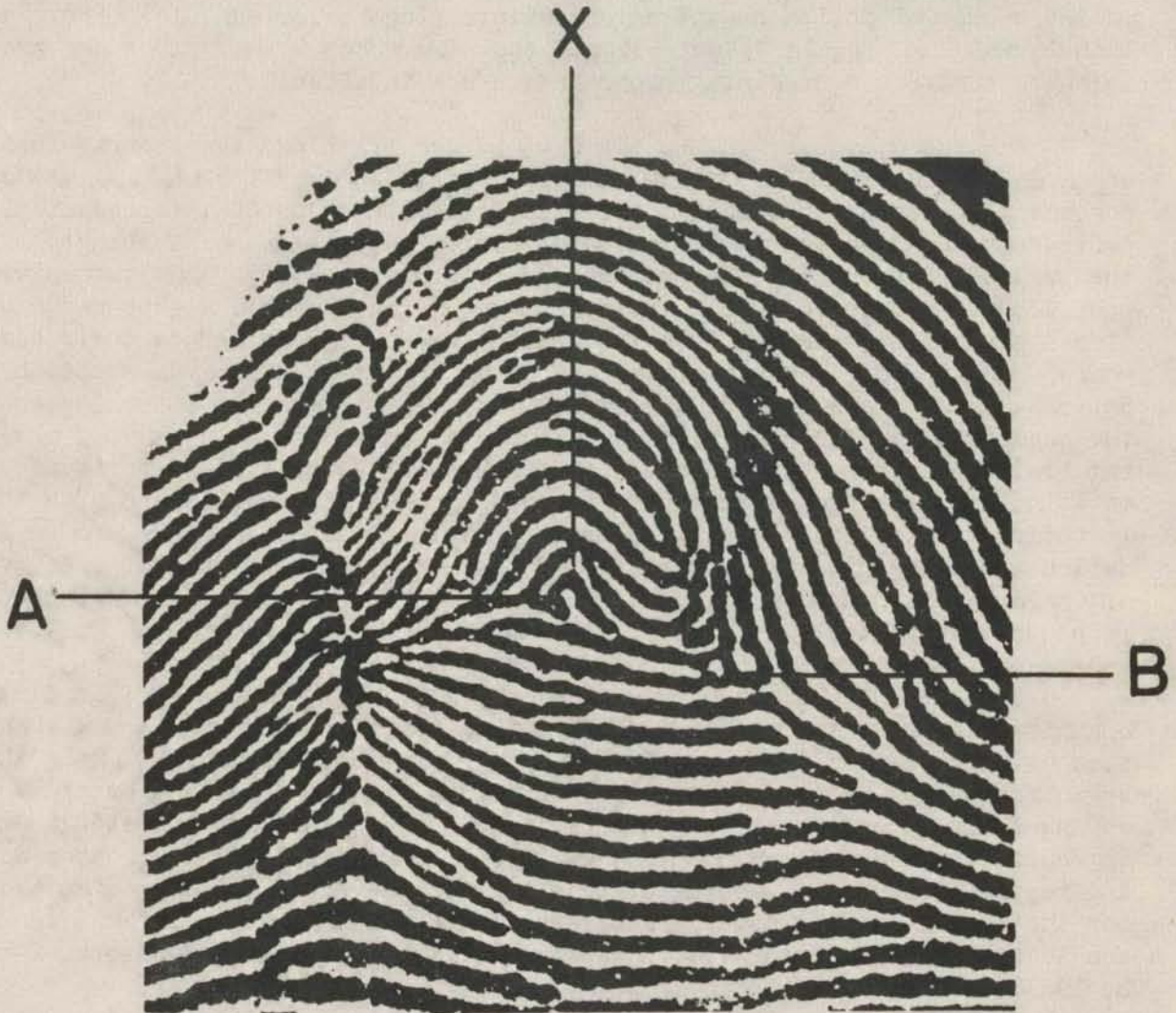
From Hailey, Idaho, two fatal bullets taken from the body of a murdered man were transmitted to the Laboratory, together with one revolver with empty shells and another revolver with hair specimens thereon, recovered from a suspect. It was possible to notify this Idaho correspondent by telegram that the fatal bullets had been fired from the gun taken from the suspect, and that the hair found on the other revolver was sufficiently similar to known hair taken from the victim to constitute an identification...

During the month of October, a total of 450 examinations consisting of 3,759 specimens were made in the Laboratory, assistance being rendered to other governmental agencies in 22 instances, and to state, county, and municipal law enforcement agencies in 94 cases. During the same period last year a total of 436 Laboratory examinations consisting of 1,831 specimens were made, of which 19 were at the request of other government bureaus and 71 were conducted for state and municipal authorities.



## A QUESTIONABLE PATTERN

The finger impression reproduced below is an example of a com-



Under the rules of interpretation adopted by the Bureau's Identification Division, a pattern in which the ridges flow from one side to the other but in which two or more ridges meet to form an angle is classified as a tented arch. The angular formation at point "X" meets this requirement. The loop formation which lies over the tented arch and passes in front of delta "B" fulfills the description of an accidental whorl. This type is defined as an impression composed of two or more different patterns within the same pattern area.

For sub-classification purposes, ridge tracing from delta "A" to delta "B" would give the impression a "meeting" whorl value.



## THE FBI NATIONAL POLICE ACADEMY ASSOCIATES

In the past few years law enforcement officers have witnessed a tremendous change in police training methods and an almost mushroom growth in the number of police organizations maintaining police schools. From less than a score of regularly-established training schools the number has grown to where hundreds of training programs are now in effect.

As a pioneer in the field of police training, the Federal Bureau of Investigation extended its training facilities on July 29, 1935, to law enforcement officers throughout the United States in order that representative officers, selected by their own departments, might come to Washington for the purpose of receiving instruction and returning to their own communities properly trained to instruct others. To date, one hundred eighty-seven officers have been graduated from the Academy and have returned to their homes where, at present, their services are being utilized in the instruction of police organizations having a personnel of 68,283 men. In some instances the graduates have been enabled to extend the opportunity of further training to law enforcement officials not connected with their own departments by inviting neighboring law enforcement organizations to participate with them in their local police training schools. In other cases, members of the FBI National Police Academy Associates have been invited to conduct full courses of training or to deliver specialized lectures before police training schools in other communities.

The graduates of the Academy have become members of an alumni organization known as The FBI National Police Academy Associates. All graduates of the Academy become members of the Associates automatically. This organization has as its purpose the continuing of the relations established during their attendance at the Academy, the holding of annual meetings during which problems of mutual interest can be discussed, doing research work and reporting upon the results of this work in the field of law enforcement for the benefit of the other graduates of the Academy. Annual reunions of the Associates have been held in Washington, the last being on October 2 and 3, 1937.

The outstanding achievement of the Associates has been their effective participation in the work of training the members of local law enforcement organizations. Graduates of the Academy are in full charge of police training in a number of the larger cities in the United States. For example, the training schools of the police departments are under the guidance of Associates in the following large cities:

Graduates also assist in the conduct of police training schools operating in many large cities such as Detroit, Michigan; Elizabeth, New Jersey; Kansas City, Missouri; New York, New York; Philadelphia, Pennsylvania, and Portland, Oregon.

Graduates have been placed in full charge of training activities in many state law enforcement organizations, as in the case of the Alabama Highway Patrol, Arkansas State Police, Delaware State Highway Patrol, Idaho State Highway Patrol, Kentucky Highway Patrol, Louisiana State Police, Nevada State Highway Patrol, New Mexico State Police, Ohio Highway Patrol, South Dakota Attorney General's Office, Texas Highway Patrol, and the West Virginia State Police.

Graduates also assist in the conduct of police training programs in the Connecticut State Highway Patrol, the Missouri State Highway Patrol and the South Carolina Highway Patrol.

In addition to the regular police training programs, state-wide police training courses have been conducted either for the benefit of state organizations or for law enforcement officers generally in many states, outstanding schools being held in Arkansas, Georgia, Idaho, Indiana, Iowa, Kentucky, Louisiana, Minnesota, Montana, New Mexico, North Carolina, Oregon, South Carolina, Texas, Vermont, Virginia, Washington and West Virginia.

With the increased emphasis on the need for training in police work in order that law enforcement as an occupation might attain a professional status, a need has arisen for competent instructors to deliver lectures and to make demonstrations before police training schools of departments which, as yet, have not had the opportunity of having a representative in attendance at the FBI National Police Academy. Graduates of the Academy have cooperated in many instances with authorities in other jurisdictions in the conduct of their police training schools by inviting members of neighboring organizations to attend their classes. Outstanding instances of this type are the activities of Captain H. M. Adair of the Columbus, Georgia, Police Department, who invited to the first session of the school conducted by him the Sheriff of Muscogee County, Georgia, and two deputies; the Chief of the Muscogee County Police and six officers; the Chief of the Phoenix City, Alabama, Police Department and five officers; the Investigator for the Prosecuting Attorney's Office, Muscogee County; the Sheriff and Under-Sheriff of Russell County, Alabama; two officers attached to the office of the Provost Marshal, Fort Benning, Georgia, in addition to sixty-seven members of the Columbus, Georgia, Police Department.

Sergeant Frank M. Bemus, in charge of the Denver Police Training School, Denver, Colorado, Police Department, afforded the benefit of his training, not only to members of his organization who were given full-time training until the entire force was trained but also invited members of the Colorado State Highway Patrol to participate.

Sergeant Emile Vallet of the Seattle, Washington, Police Department, and Director of the Police Training School at Seattle; Detective Henry E. Warren, in charge of the Tacoma, Washington, Police Training School; and Officer Forbes Barrett, in charge of the Hoquiam, Washington, Police Training School, coordinated their efforts in the conduct of a state-wide school for law enforcement officers held under the auspices of the Institute of Government at the University of Washington during the current year.

In the State of North Carolina, where a well organized police training program has been formulated, the services of a number of graduates from the Academy have been utilized, including Chief of Police Walter F. Anderson, of Winston-Salem, North Carolina. In addition to the state-wide police training schools in North Carolina, many graduates have reported considerable success in the conduct of their local schools. Chief of Police Anderson of Winston-Salem, North Carolina, informed the Bureau that last fall he invited officers from the Sheriff's Office of his county to attend the police school. On one evening a lecture was given concerning the necessity for detailed examination of the scene of crime. The lecture was delivered by Chief Anderson with the assistance of the Special Agent in Charge of the Charlotte, North Carolina, Field Office of the Bureau, who was present in accordance with the Bureau's policy of affording assistance and instruction to such police training schools. After the lecture, the sheriff's officers returned to their duties. The same night a man came to the Sheriff's Office and reported that he had been held up, robbed and that he had been fired upon. The deputies proceeded to the scene of crime, pointed out by the complainant, and there found his truck. The truck was carefully handled so as not to destroy evidence and was examined carefully. The investigation showed that the hole, purported to have been made by a bullet, was somewhat different from a bullet hole. Tests were conducted, firing a .22 calibre pistol, and a comparison made between the holes. A decided difference in the size and character of the holes convinced the deputies that further interview should be had with the complainant. When he was interviewed, a search of his surroundings was made and a twenty-penny nail was found among his belongings. Upon inserting this in the hole in the truck, it was determined that the hole was made with the use of this large nail. Following further questioning, the complainant confessed that he had not been held up and robbed but he had made this report because a great many creditors were clamoring for payment and he was unable to pay them. Further investigation disclosed that on the date of the alleged holdup the complainant had made a large deposit of money in another city.

State-wide police training schools in Minnesota have been operated with the cooperation of Chief of Police Louis J. Claude, in charge of the Rochester, Minnesota, Police Training School, and Chairman of the Police School Committee, Minnesota Police Short Course.



In the State of Montana, Sergeant Edward J. O'Connor, with the cooperation of local officials, was enabled to establish a state-wide training program during October, 1937.

A state-wide school for Idaho officers is now in session at Boise, Idaho, under the direction of Patrolman Forrest M. Kingsbury, of the Idaho State Highway Patrol.

The Federal Bureau of Investigation is, of course, extremely gratified because of the effective manner in which the Associates have applied their experience and training and particularly because of the cooperative spirit in which they have assisted the officials of other organizations in police training programs. The purpose of the FBI National Police Academy is not to train police officers in fundamental police duties but rather it is to train police officers in order that they may return to their communities and afford instruction to others.

In order that law enforcement officials desiring assistance in their police training programs may avail themselves of the experience and training of the graduates of the Academy, there are listed below the names of the graduates, together with the names of the law enforcement organizations with which they are presently associated.

### FINGERPRINTS OF VICTIM OF AUTO ACCIDENT DISCLOSE TWENTY-YEAR CRIMINAL RECORD

On October 28, 1937, there were received in the Identification Division of the Federal Bureau of Investigation from Sheriff Arnold F. Isch of Wood County, Bowling Green, Ohio, the finger impressions of a white, unknown deceased individual. The Sheriff informed the FBI that this individual was struck and killed by an automobile while walking on the highway near Toledo, Ohio, in Wood County. The Sheriff requested the Bureau to attempt to ascertain the identity of this unfortunate deceased individual and to wire him any information obtainable, inasmuch as he was holding the body for burial.

The fingerprint card of this victim of an automobile accident was immediately searched upon its receipt in the Identification Division. It was ascertained that this victim was one Edgar Van Brunt, with aliases. Van Brunt had a criminal record in the files of the Identification Division of the FBI extending from January 19, 1917. His criminal specialty was forgery. On June 12, 1922, he had been received at the State Prison, at Columbus, Ohio, to serve a sentence of from one to twenty years for forgery. On August 7, 1936, under the alias of Frank Olten, he had been received at the Workhouse, Dayton, Ohio, to serve a sentence of one hundred and forty-one days for forgery. As recently as April 2nd of the current year, he had been fingerprinted by the Police Department at Highland, Illinois, as a lodger. At the time of this fingerprinting in April, he had informed the police officials at Highland that he was born in Cincinnati, Ohio, and that his present residence was in Cincinnati.

When the identity of this unknown deceased individual was thus established in the Identification Division of the FBI, a telegraphic notification was immediately forwarded to Sheriff Arnold F. Isch informing him of all pertinent data appearing in the Bureau's files. Had Van Brunt not been arrested, his identity would probably never have been disclosed.

## ESCAPED MURDERER IDENTIFIED BY FINGERPRINTS WHEN SUBSEQUENTLY ARRESTED FOR TRESPASSING

Charlie B. Ross, who, during his criminal career, used the aliases Narlie Boyd White and B. B. Hatfield, has a criminal record in the files of the Identification Division of the Federal Bureau of Investigation extending from January 14, 1918. On this latter mentioned date, Charlie B. Ross was received at the United States Disciplinary Barracks, Governors Island, New York, to serve a sentence of ten years for breaking and entering, assault and escape. A fingerprint record received in the Identification Division of the FBI discloses that on April 8, 1918, this individual was received at the United States Penitentiary, Leavenworth, Kansas, on transfer for this same offense. This ten-year sentence was later commuted to five years on May 12, 1919, and on March 5, 1921, the sentence was commuted to four years. The Bureau's records reflect the release of this individual on the expiration of this four-year sentence on October 25, 1921.

On April 17, 1923, Charlie B. Ross, under the name of Narlie Boyd White, was arrested by the Police Department at Evansville, Indiana, and charged with murder. For this felony he was convicted, and on June 7, 1923, was received at the State Prison, Michigan City, Indiana, to serve a life sentence. On July 27, 1937, the FBI was advised by the Warden of the State Prison, Michigan City, Indiana, that Narlie B. White had escaped from that institution. Upon the receipt of this information, a wanted notice was posted in the files of the Identification Division.

To circularize the fugitive status of this individual among law enforcement officials and agencies throughout the United States, Charlie B. Ross, with aliases, was published as a fugitive in the FBI Law Enforcement Bulletin for the month of September, 1937. On October 14, 1937, there were received in the Identification Division from the Knox County Identification Bureau, Knoxville, Tennessee, the finger impressions of an individual arrested for trespassing. This individual who had been arrested in Knoxville, Tennessee, on October 11, 1937, advised the arresting agency that his name was B. B. Hatfield, and he further denied having any previous criminal history. However, on October 14th, upon the receipt of the finger impressions of this individual for search in the files of the Identification Division, it was ascertained that he was none other than the above-mentioned escaped murderer, wanted by the Indiana institution.

As soon as this identification was effected in the files of the Identification Division of the Bureau, a telegram was dispatched to the Warden of the State Prison at Michigan City, Indiana, informing him of the arrest of Ross, alias White, by the Sheriff at Knoxville, Tennessee, on October 11, 1937, for trespassing. The Indiana institution was also advised that for this offense a sentence of twelve days in the workhouse had been imposed.

The attempt of Ross to defeat identification by changing his name and denying a criminal history was futile and ineffective.
