The United States Bureau of Investigation desires to express its pleasure at the flattering comments upon the initiation of its new law enforcement service received after the transmission of the first issue of its "Fugitives Wanted by Police". It has been encouraged to continue this project by the apparent recognition of law enforcement officials of the value of a nation-wide broadcast of this kind and trusts that future issues may prove of progressively increasing value. Attention is invited to the basically cooperative character of this project. Like other phases of the work of the United States Bureau of Investigation, its success depends entirely upon the measure of enthusiastic support afforded by those who are the ultimate beneficiaries of the plan. This service is rendered without cost, to all law enforcement agencies, and every effort will be made to develop this plan along lines which may be found most practicable and useful. The advice of law enforcement agencies is, therefore, of more than ordinary importance in the determination of methods to be employed in the further development of this cooperative project.

As stated in the foreword of the first issue of this bulletin, these will be issued periodically and will list data with reference to individuals for whom warrants are outstanding and who are wanted by law enforcement officials for major crimes. It is hoped to extend at an early date the number of crime classifications to be included. It is, of course, understood that all of the fugitives referred to in these bulletins as wanted are those whose names have been transmitted to the United States Bureau of Investigation by its correspondents in various parts of the country. Fugitives apprehended are indicated in a separate list in each bulletin. It is necessary that this Bureau be advised promptly when any of the individuals listed as wanted have been apprehended or are no longer wanted so that the proper information may be circulated in a subsequent issue. Too great emphasis cannot be placed upon the necessity for giving full consideration to the aid which may be afforded by the Identification Division of the United States Bureau of Investigation in determining whether those persons under investigation or held by law enforcement officials are identical with those referred to in the "fugitives wanted" bulletins. Cases involving any doubt should be determined by the transmission of fingerprints in the usual manner to the Identification Division of the United States Bureau of Investigation.

The United States Bureau of Investigation submits for the benefit of law enforcement officials both here and abroad its first attempt at a standardized list of abbreviations of English words used in personal descriptions. (The necessity for a list of this kind has been apparent for a considerable period and many requests have been received that a standardized list be at least tentatively transmitted to law enforcement officials by the United States Bureau of Investigation. The useful purpose which standard abbreviations will serve seems to require no argumentative exposition. The universal adoption of a standardized list will concededly be of benefit to law enforcement officials in the clarification of criminal identification data in their own files as well as in the exchange of these data with others. It will mean that all engaged in this work will speak the same language. This list is submitted for the purpose of general consideration and subsequent adoption as a standard by all those who recognize the benefits to be derived therefrom. Its tentative character, however, should be considered, inasmuch as suggestions for both change and amplification will not only be given careful consideration but are earnestly desired.) The list may be found in this issue following the recording of fugitives wanted.

Attention is invited to the fact that fingerprint classifications are those of the Identification Division of this Bureau, developed as an extension in many instances of more basic classifications in order to properly segregate the extremely large collection of fingerprints possessed by the United States Bureau of Investigation, and at the same time to synchronize so far as may be possible with classifications current in other identification divisions.

The United States Bureau of Investigation hopes to be of further service in the standardization of methods and forms and the suggestion is made that any similar work which may be performed by the Research Division will be cheerfully undertaken upon appropriate request.
