In an effort to amplify and render of increased value the current exchange of criminal identification data among the United States Bureau of Investigation and law enforcement officials in this country and abroad, it has been suggested that a bulletin be issued periodically in which will be listed data with reference to individuals for whom warrants are outstanding, and who are wanted by the law enforcement officials for major crimes. It has been necessary to definitely limit the scope of the proposed bulletin to this arbitrary classification of major crimes. At a later date, if the value of this service is definitely established, it may be possible to broaden to a considerable extent the scope of subsequent bulletins. It is understood that the individuals mentioned include those whose names have been transmitted to the United States Bureau of Investigation as those wanted for the offenses listed.

The United States Bureau of Investigation desires that its correspondents realize the tentative character of this service plan, the continuance of which will depend entirely upon its value to law enforcement officials. It is based upon the admittedly marked success which has attended the centralization of fingerprint data in the Identification Division of the United States Bureau of Investigation. It is based upon the theory that similar success will follow the establishment of a centralized division to which may be directed wanted notices by law enforcement officials everywhere in connection with fugitives whose apprehension is desired for the commission of major crimes. It will be appreciated if this Bureau is advised by its correspondents promptly when any of the individuals listed as wanted have been apprehended or are no longer wanted. It is, of course, understood that the assistance of the Identification Division of the United States Bureau of Investigation will be sought, and promptly rendered in all cases wherein the identity of individuals in custody is not entirely certain. In such cases, the prompt transmission of fingerprints to the Bureau will accomplish complete identification.

The United States Bureau of Investigation invites suggestions from law enforcement officials with a view to the benefit to be derived from this plan, and will give careful study to any suggestions designed to improve in any manner the additional service which it desires to render along the lines indicated.

Study is now being given to a plan whereby abbreviations of personal descriptions will be standardized in future bulletins. It is believed that a standardization of description abbreviations would be of considerable value to law enforcement officials everywhere. Any suggestions that may aid in this study will be appreciated.
