The United States Bureau of Investigation is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Bureau does not have investigative jurisdiction over violations of the National Prohibition, Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the United States Bureau of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act

National Bankruptcy Act

White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnapped

Theft, Embezzlement or Illegal Possession of Government Property

Antitrust Laws

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property

Neutrality violations, including the shipment of arms to friendly nations

Frauds against the Government

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the nearest office of the United States Bureau of Investigation. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of the Bureau office having investigative jurisdiction over the district in which you are located is as follows:


It has been my pleasure on previous occasions to make deserved comment in this bulletin concerning the splendid type and quality of cooperation which has been afforded the United States Bureau of Investigation by law enforcement agencies throughout the nation in its identification work. Obviously the rapid development of the Bureau's identification work and the effective results being obtained from it are always worthy of mention as being undoubtedly the greatest cooperative movement between law enforcement agencies of the United States in the war against crime. I desire again to express my appreciation for this cooperation and to inform you that every possible advantage will be taken of the resources afforded by this project in order that its full benefits might be realized. In a further effort to extend the value of this service, you will find included in this bulletin an article showing the effective results that have followed the effort of this Bureau to obtain an international exchange of fingerprints in order to check the activities of international swindlers and other criminals. This effort is but a further development of the facilities of the Identification Division of this Bureau in order that the most beneficial results of mutual interest may be obtained.

It has further been my pleasure to have included in this bulletin articles which are calculated to prove of interest and value to law enforcement officials and agencies in the investigation and prevention of crime. In furtherance of this progressive movement, there will be found included in this bulletin an article which, it is hoped, will be found of value in deciphering cryptograms which are frequently employed by prisoners who are attempting to communicate with their allies, and by criminals who do not desire that their communications be legible.

Obviously, a primary function of this Bureau is that of investigation. The United States Bureau of Investigation is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest. It is, therefore, that investigative agency of the Federal Government which possesses broad jurisdiction. For the sake of economy, however, and in order to avoid duplication of effort, the Special Agents of this Bureau confine their attention to those matters not specifically assigned by Congress to other Governmental agencies. For the convenience of law enforcement officials, there will be found on the inside front cover of this bulletin a tabulation of those laws to which this Bureau most frequently gives investigative attention, and any violation of these Federal laws which comes to your attention and which needs the services of an investigator may be reported to the field office of this Bureau, the address of which will be found stamped immediately beneath such tabulation. Your communications relative to alleged violations of these Federal laws may be transmitted to the Special Agent in Charge of the field

office at the address shown, and in the event more expeditious action is necessary, telegrams may be addressed Government rate, collect, to the field office. You may be assured that the administration of this Bureau is based upon the well-understood rule and policy that all Special Agents must work in close cooperation with police officials, sheriffs, and other law enforcement agencies in their respective jurisdictions, and it is a matter of pleasure to note the extremely cordial and actively friendly relations which have existed for some years past between the representatives of this Bureau and the officials with whom they come in daily contact.

The functions of this Bureau are investigation, identification and research, and your continued cooperation with the Bureau in these activities is most earnestly solicited. The suggestions which you have afforded in the past and which have proven of great value will be welcomed at all times concerning any phase of the work of the United States Bureau of Investigation. This Bureau, in continuing its efforts to adhere to the strictest ideas of economy, while maintaining the highest possible standards of efficient service, has not been permitted to adopt all the suggestions heretofore received, particularly in the preparation of this bulletin. These ideas have not been abandoned, however, but are properly recorded in order that they may be utilized whenever opportunity permits. In this connection, in response to inquiries concerning the arrangement of the wanted notices included in the bulletin, the suggestion has been offered that the wanted notices might be clipped from the bulletin and pasted on cards, since the notices are printed on only one side of the page, following which they may be filed either alphabetically or according to fingerprint classification, dependent upon the varying types of methods which are employed in your offices. This change in the initial plan of the publication of this bulletin is based upon many suggestions offered, and it is earnestly desired that you will afford the Bureau the benefit of your ideas and additional suggestions as to how to make this bulletin of additional service and the greatest possible value.

CIPHERS

In law enforcement work there are sometimes encountered cipher messages which it is necessary for the investigating officer to decode. The usual message of this kind is comparatively simple as it is impracticable for those using communications of this kind to employ complicated methods. The reason for this is the fact that the use of a cipher necessitates the possession by the addressee of a key or a means by which the message is to be deciphered. Complicated ciphers require complicated keys.

Because of the relative simplicity of such ciphers, many of them may be solved without much difficulty. Cryptographers utilize in this connection "frequency tables", that is, computations showing the relative frequency with which the various letters of the English alphabet appear normally in writings. These tables are prepared on the basis of counts of various numbers of letters and those offered by different authors do not agree in detail, although the general sequence is approximately the same. Compilations of this kind require a great deal of time and effort, it being an exceedingly tedious and exacting clerical task to count a large number of letters.

The purpose of this article is to offer what is believed to be a valuable frequency table which was compiled by the United States Bureau of Investigation from a recently completed count of approximately 220,000 letters. This work was performed by means of a tabulating machine in the Statistical Division of the Bureau. The use of the machine eliminates most of the human errors usually to be found in such work. It would appear that the difference in frequency tables heretofore available has probably been occasioned by the relatively small number of letters included and the likelihood of some clerical error in the count. It is believed that the table offered, in the preparation of which these factors were largely eliminated, may be accepted as authoritative. It is offered for what value it may be in work of this kind and is shown in Plate 1.

It is not the purpose of this article to offer any detailed statement with reference to ciphers as this may be found in the writings of authorities on the subject. It may be, however, that a brief reference to the more simple ciphers of the type usually to be encountered in law enforcement work will be of assistance in connection with the use of the above frequency table.

In simple ciphers the proper letters of the alphabet are usually replaced by other letters, numbers or symbols. For instance, the letters of the alphabet may be transposed and substituted for the corresponding letters wherever they appear in the message. B would be used for A, C for B, D for C and so on. In order to read such a cipher message it would be only necessary in place of each letter to substitute the letter which imme-

diately precedes that letter in the alphabet. Of course, in practice, the transposition may be anywhere from 1 to 26 letters before or after the proper letter of the alphabet. In addition to this, one transposition may be used for the first letter, a second for the second letter, and so on. The key to such a message would be a number, such as 215 which would represent the number of transpositions used for each of the first three letters, this being then repeated throughout the message, so that the first letter of the cipher would be transposed two positions, the second, one position and the third, five positions from the proper letter of the alphabet.

Similarly, numbers may be substituted, the figures 1 for A, 2 for B, and so on throughout the 26 letters of the alphabet. Variations of this are again very numerous. Instead of starting with 1, any number might be used and it would only be necessary for the addressee to remember the number with which the alphabet is started.

In addition to this, there may be various rearrangements of the alphabet and it would be necessary, of course, for the addressee to remember such an arrangement.

The use of the frequency table in deciphering such messages is described as follows:

First, make a list of all the characters or symbols appearing in the message, counting the number of times each character appears in the whole message and classifying them in order of frequency;

Second, compare the frequency of the characters in the cipher message with the normal frequency table, Plate 1;

Third, substitute letters for the characters in order of frequency, making the substitutions in a portion of the message sufficiently large to ascertain whether the solution is correct. If incorrect in some particulars, substitutions may be made for the letter or letters which appear improper, that is, where a letter is wrong, those occurring next in the frequency table should be tried, the frequency table being made use of to determine the most likely letters.

Plate 2 is a tabulation in which each letter of the alphabet is substituted for each other letter. This may also be of some assistance in deciphering transposition ciphers.

INTERNATIONAL EXCHANGE OF FINGERPRINTS.

The United States Bureau of Investigation, which in March 1932 announced the initiation of a program designed to effect a more liberal international exchange of fingerprints, points out that the developments attending this exchange of identifying data have been so satisfactory that it has enlarged this activity to include all foreign countries desiring to cooperate therein, as well as all law enforcement agencies in the United States and Canada which contribute fingerprints regularly to the Bureau.

The superintendents of identification bureaus of Argentina, Australia, Austria, Bahamas, Barbados, Belgium, Chile, Colombia, Cuba, Czechoslovakia, England, Finland, France, Germany, Greece, Holland, Ireland, Italy, Mexico, Norway, Poland, Portugal, Rumania, Spain, Switzerland, Sweden, and Turkey, as well as the superintendents of identification bureaus of all the territories and possessions of the United States, such as Hawaii, Canal Zone, Philippine Islands, and Puerto Rico, have participated in this activity. An invitation has been extended by the Bureau to all law enforcement agencies throughout the United States and Canada, which transmit fingerprint records regularly to indicate to the Bureau the instances where they desire that foreign exchange be arranged and to furnish duplicate copies of prints to be relayed to the foreign countries. The numerous fingerprints received in the Bureau marked for transmittal to foreign identification agencies are an indication of the enthusiastic support which has been accorded this project.

The Bureau is of the opinion that to provide for a more comprehensive identification service further efforts must be made to ascertain whether the persons whose fingerprint cards are referred to the Bureau have criminal records in foreign countries. It is felt that the development of this international exchange of fingerprints should prove to be a further step in the cause of effective law enforcement, insure the regular receipt of criminal records of Americans arrested in foreign countries, and also provide for the completion of the records of citizens or natives of other countries, who may be taken into custody in the United States. The adoption of the plan outlined conforms to the existing policy of the Bureau in handling fingerprints, since any law enforcement agency which has referred a fingerprint record to the Bureau relating to an individual is kept informed as to his future whereabouts through the transmittal to the said agency of copies of letters in answer to prints received thereafter concerning him.

A recent identification effected through the international exchange of fingerprints affords an interesting illustration of the efficacy of this service. The fingerprints of Charles J. Drossner were received by the United States Bureau of Investigation from the State Penitentiary, Waupun, Wisconsin, on October 12, 1932. Drossner had been received at the penitentiary to serve two terms of one to five years to run concurrently, for the crime of forging and uttering. The fingerprints of this individual were forwarded to the Commissioner of Police of the Metropolis, New Scotland Yard, London, England, by the United States Bureau of Investigation. Scotland Yard reported that Drossner's fingerprints were identical with those of Jose de Braganca, who on November 12, 1924, had been sentenced at Rome, Italy, to serve seven months' imprisonment on a swindling charge, and who at present is wanted by the Paris police department on a warrant issued by the Examining Magistrate, Tribunal of the Seine on February 19, 1929, for forgery and making

use of forged documents. The letter from Scotland Yard indicated further that it was believed extradition papers would be issued for Drossner alias de Braganca.

Subsequent to the receipt of the above information the Bureau was advised by the Prefect of Police at Paris, France, that Drossner had been arrested in 1918, at Paris on a charge of issuing a check without funds and illegal wearing of decorations. It was also disclosed that this individual in 1922, was arrested at Bayonne, France, for a similar offense under the name of Douglas Campbell. Previously he had been arrested for theft in Rome, Italy, under the name of de Bracanza, and in Vienna, Austria, for identification purposes. A confidential report which accompanied the Paris information indicated that in 1918, Drossner was sentenced to serve six months and fined 500 francs for abuse of confidence. He was expelled by Ministerial Order in August of that year. On November 9, 1922 he was sentenced to serve six months and fined 4000 francs for issuing a check with no funds, infraction of an expulsion order, and illegally wearing decorations. The confidential report further indicates that on May 13, 1932, Drossner was sentenced to penal servitude for life and a fine of 3000 francs by the Assizes of the Seine, for forgery. The report contains the statement that the subject defaulted at the time of this arrest. On the same date that the Paris report was received by the Bureau, advice was received from the Minister of Justice, Brussels, Belgium, giving a criminal record for Drossner similar to that outlined above but reporting the additional aliases of Charles Jean Drossner, Douglas Campbell, Jose Brancanza, Jose Carlos Brazanca, Daniel Chester, and Vincente Montoya. The above mentioned case is an illustration of the readiness with which the facilities of the United States Bureau of Investigation enable law enforcement agencies to secure the complete record of an international criminal.

A second case which has come to the Bureau's attention is that concerning Charles Lawrence Conway, who, under the name of David C. Conway was arrested by the Police Department at Los Angeles, California, on April 30, 1932, charged with auto theft. Conway was sentenced to a term of five years and placed on probation and ordered to serve the first two years in the County Jail. On July 20, 1932, he was taken into custody by the U. S. Immigration Service at Los Angeles, because of illegal entry. Deportation proceedings were then instituted. He was ordered deported to England, and the New Scotland Yard officials have indicated that his criminal record began in 1915, when he was arrested for stealing a revolver. In 1924, he was arrested charged with shopbreaking and larceny, and given six months hard labor. Later in 1924, he was bound over on probation for theft of a bicycle. He was sentenced in 1925, to serve three years on a charge of officebreaking after a previous conviction of a felony. In October, 1926, he was sentenced to serve three years, to run concurrently with the 1925 sentence, on a housebreaking and larceny charge.

Also, during August of 1932, the Bureau received from the Director of the Judicial Police at Brussels, Belgium, the fingerprints of one Frank Jansko, held in custody in Antwerp, Belgium, on July 12, 1932, charged with attempted larceny. According to the Bureau's records, this individual, also known as Joseph Sehec, Frank Lanik and John Edward Etkins was sentenced to serve two and one-half to ten years in the State Penitentiary at Walla Walla, Washington, in 1915, for attempted robbery. In 1919, he was sentenced to serve one year to life in the State Prison at San Quentin, California, for the crime of robbery, and in 1928, he was received in the State Penitentiary at Salem, Oregon, to serve seven years for grand larceny. This extensive criminal record was furnished to the Belgian Officials at once in connection with the disposition of charges against Jansko in Belgium.

The Immigration Bureau of the Department of Labor has been so impressed with the results which have been accomplished and which may attend the international exchange of fingerprints that instructions were issued on September 28, 1932, to its various agencies requiring that a copy of each fingerprint record, taken by Immigration Officers in the cases of aliens arrested for deportation for cause, be referred to the United States Bureau of Investigation for transmittal to the interested foreign countries, so the deported persons may be kept under surveillance.

The action of the Bureau in the development of the plan to provide for the international exchange of fingerprints is an elaboration upon the service which it has given to all law enforcement agencies. The Bureau's criminal identification activities have been increased tremendously since it assumed this important work on July 1, 1924, when, largely through the efforts of the International Association of Chiefs of Police, the Bureau was authorized to receive, file and exchange criminal identifying data, and as a nucleus for its work received a total of 810,188 fingerprint cards, which previously had comprised the collections of the International Association of Chiefs of Police and the Federal Penitentiary at Leavenworth, Kansas.

When the Bureau began its identification activities there were only 987 contributors of fingerprint cards, who were transmitting approximately 300 records each day. A steady growth has been experienced in this work since the year 1924. On January 1, 1933, there were 5,282 contributors of fingerprints, forwarding about 2,000 cards each working day. Federal, State, and local officials, including sheriffs, chiefs of police, and wardens of penal and correctional institutions, and numerous foreign officials, are numbered among these 5,282 contributors. About 45% of all criminal fingerprints received are identified with previous records, contrasted to the 14% of identifications made in 1924. In contrast to the 87,918 fingerprint cards received in 1924, there were forwarded 573,731 cards to the Bureau during the fiscal year 1932. On January 1, 1933, there were 3,340,261 fingerprint cards in the Bureau's archives, the largest collection of criminal records in the world. The Bureau's index cards numbered 4,431,419 on that date, compared with less than 1,000,000 in the files when the work was assumed in 1924.

The large number of law enforcement officers and agencies utilizing the Bureau's facilities on January 1, 1933, realized that its cooperation is a potent weapon in effective law enforcement. It is interesting to observe that several of the 24 states which maintain state bureaus of identification require in their own statutes that fingerprints shall be forwarded to the Bureau in the cases of individuals arrested within their jurisdiction charged with various offenses. While there is no Federal Law requiring the states to cooperate with the Bureau's identification work, they thus recognize the identification activities of the Federal Government as an aid to proper local law enforcement.

It is the policy of the United States Bureau of Investigation to reply to all fingerprint records within 36 hours after receipt to insure to its contributors the prompt service which is so necessary to handle effectively the cases of many individuals who are taken into custody. Also, through the medium of a section devoted to the handling of wanted notices on individuals whose apprehension is desired for any offenses, over 350 fugitives are identified each month. These are persons who are wanted for offenses ranging from petty larceny to murder, or as escaped prisoners, parole or probation violators.
