The Division of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Division does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Division of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Division has investigative jurisdiction:-

National Motor Vehicle Theft Act National Bankruptcy Act White Slave Traffic Act Impersonation of Government Officials Larceny of Goods in Interstate Commerce

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnapped

Theft, Embezzlement or Illegal Possession of Government Property
Antitrust Laws

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property
Neutrality violations, including the shipment of arms to friendly nations
Frauds against the Government

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Division has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Division of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field Offices of this Division appears on the inside back cover of this bulletin.

I feel that all of you will be interested in comparative figures of the activities of the Division's Identification Unit for the last six months of the years 1932 and 1933. The noticeable increase during the last six months of 1933 is directly attributable to your increased cooperation.

The total number of fingerprint records received during the last six months of the calendar year 1933 totaled 280,439 as compared with a total of 279,528 fingerprint records for the same period during 1932.

The criminal fingerprint records received during the last six months of the calendar year 1933 totaled 267,432 as against 261,689 criminal fingerprint records for the same period during 1932.

The total number of identifications made during the last six months of the calendar year 1933 was 124,073 as against 114,497 for a like period in 1932, while the percentage of criminal identifications during the last six months of 1933 was 45.4 as compared with a percentage of 43.6 for the same period in 1932.

Fugitives identified during the last six months of the calendar year 1933 totaled 2,192 as against 1,720 for the same period in 1932.

The number of contributors of fingerprint records at the end of the last six months of the calendar year 1933 (i.e. December 31, 1933) was 6,394 as compared with a total of 5,282 contributors at the end of the last six months of the calendar year 1932 (i.e. December 31, 1932).

The total number of fingerprint records on file at the end of the last six months of the calendar year 1933 was 4,060,174 as compared with a total of 3,489,738 fingerprint records on file at the end of the last six months of the calendar year 1932.

THE IDENTIFICATION UNIT OF THE DIVISION OF INVESTIGATION.

The science of fingerprinting has been associated in the lay mind with the activities of law enforcement officers, probably because this indispensable adjunct to police work has been developed largely through the efforts of progressive and alert peace officers. When the research activities of Faulds and Galton in the dactylographic field and the great possibilities inherent in this definite means of establishing identity were brought to the attention of the scientific world, Sir E. R. Henry, later Commissioner of Police of the Metropolis, New Scotland Yard, London, England, was commissioned to study and amplify the existing classification systems. Henry presented an improvement of these systems which permitted of the ready segregation and search of large collections of finger-print records.

In 1903 the fingerprint identification system was first introduced into the United States and readily adopted by peace officers who, cognizant of its distinct advantages, rapidly initiated the practice of exchanging fingerprints of individuals charged with offenses to determine whether they were ted elsewhere or possessed of prior criminal records. This exchange served effective purposes in many instances, yet the very nature of the exchange tended to emphasize the imperative need of a central agency which would serve as a depository and clearing house of information based on fingerprints for the entire United States and interested foreign agencies. Particularly, the exchange between local bureaus or even state bureaus, which were established in many jurisdictions to collect criminal records therein, could not meet effectually the problem of dealing with the roling criminal as it was found that these exchanges, necessarily haphazard upon occasion, many times failed to establish true identity. Accordingly, on July 1, 1924, largely through the efforts of the International Association of Chiefs of Police the records of the identification bureau theretofore maintained under the jurisdiction of that organization at Washington, D. C., with the fingerprint coll tion of the Federal Penitentiary at Leavenworth, Kansas, were transferred to the custody and control of the Division of Investigation at Washington to provide, under Federal supervision, a national fingerprint hange to afford free service to all law enforcement agencies desiring to a themselves of its facilities.

In commenting upon the activities of the Division of Investigation in maintaining its fingerprint files, it is significant to observe the measure of cooperation by law enforcement officers. It is interesting to note that while only 810,188 fingerprint cards were available to start the Division's collection on July 1, 1924, on January 1, 1934, this number had been increased to 4,060,174 cards. When the Division entered upon this work 300 fingerprint cards were being received daily from 987 law enforcement officers and agencies and 14% of these records were identified; whereas at the present time 2.200 cards are referred to the Division each working day by 6,394 agencies and previous criminal records are established in 45.4% f these cases.

The identification service of the Division of Investigation is available free of cost to all law enforcement agencies in this country and abroad. Through the centralization the clearing hole it is now possible for an officer to have available a positive source of information relative to the past activities of an individual in his custody. This information, it may be added, is immediately available, as it is the Division's policy to reply to all fingerprint cards within thirty-six hours of their receipt in Washington, since it is realized that speed is essential in this service. When the facts indicate an individual may have a record in an her country, his fingerprints are transmitted by this Divisio proper loreign bureau in accordance

with the arrangements made with the identification agencies of these countries whereby criminal identification data are exchanged. This international exchange which has revealed many interesting cases is designed to place an effective curb on criminals of a roving character who conduct their criminal operations on an international basis.

As indicated, the Division's service is given without cost to regularly constituted law enforcement officers and agencies. In addition to the information supplied without charge the Division also furnishes the peace officers with fingerprint cards; franked envelopes requiring no postage, for use in transmitting fingerprint records to this Division at Washington; instructions for the proper taking of fingerprints; standard "wanted notice forms" to report the fugitive status of any individuals to the Division; prepared forms upon which dispositions of cases may be recorded; a treatise on the court decisions relating to fingerprints; a manuscript relative to the subject of latent fingerprints and a copy of the Modification and Extension of the Henry System of Identification as applied to this Division's files.

In addition to its criminal identification activities the Division's Identification Unit maintains several auxiliary services. Not the least of these is the system whereby fugitives are identified through the comparison of fingerprints which are received currently. When a law enforcement officer desires the apprehension of a fugitive and the fingerprints of that individual are available, it is necessary only that he inform the Division of this fact so a wanted notice may be placed in the fugitive's record. This insures his identification when his fingerprints are next received from any of the 6,394 contributors. Through this medium 365 fugitives are identified each month.

This fugitive service is amplified by the Division's action in transmitting a monthly bulletin to all law enforcement agencies who forward fingerprints for its files. In this bulletin are listed the names, descriptions, and fingerprint classifications of persons wanted for offenses of a more serious character. This information facilitates prompt identifications of individuals arrested for any offense or otherwise located by those receiving the bulletin.

To afford a more comprehensive service the Division has initiated a single fingerprint system. Individual impressions of known gangsters, kidnapers and extortionists are being classified separately and filed in a designated sequence so latent impressions or those found at the scenes of crimes may be checked against them to establish the identity of suspects. A detailed descriptive card of each subject of this file is maintained, fully cross-referenced, to enhance its value to law enforcement officials.

The fingerprint records of the Division of Investigation are used liberally of only by peace agencies to obtain previous criminal histories and to ascertain whether persons arrested a need elsewhere, but by prosecutors to whom the information from the Division's files may prove to be valuable in connection with the prosecution of a case. These records are likewise of frequent value to the Judge for his consideration in connection with the imposition of sentence. Obviously the ends of justice may be served most equitably when the past criminal record of the person on trial can be made known to the Court, or information may be furnished to the effect that the defendant is of hitherto unblemished reputation.

INTERESTING IDENTIFICATION

FUGITIVE WANTED FOR ROBBERY AND HOLD-UP IDENTIFIED BY FINGERPRINTS

The criminal record of the person known as George Clauson may be traced in the identification files of the Division of Investigation to August, 1921, when he was arrested by the Police Department at St. Louis, Missouri, charged with attempted auto theft. In November of the same year, Clauson was received in the State Reformatory at Monroe, Washington, to serve one to five years for forgery. In March, 1923, he was received in the United States Penitentiary at McNeil Island, Washington, to serve 15 months for violation of the National Motor Vehicle Theft Act. On February 4, 1925, he was received in the State Penitentiary, Walla Walla, Washington, to serve not less than one year for forgery and released on parole September 24, 1925. In January, 1926, he was sentenced to serve 90 days in the county jail at Portland, Oregon, for carrying concealed weapons and in June, 1928, he was received in the State Penitentiary, Salt Lake City, Utah, to serve one to ten years for grand larceny.

Further reports received in the Division of Investigation in Clauson's case reflect that on March 2, 1933, he was arrested by the State's Attorney's office, Cumberland, Maryland, charged with investigation. In April, 1933, the Division was informed that his apprehension was desired for armed robbery and hold-up by the Cumberland officials, as well as by the State Police at Greensburg, Pennsylvania, and the usual wanted notices were placed in the files at that time so any future record received in Clauson's case would lead to his immediate identification.

On December 6, 1933, a fingerprint card came to the Division's attention, forwarded by the Police Department at Paragould, Arkansas, reporting the arrest of George Knopp Clauson on December 2nd, charged with investigation. It appears that the Arkansas officials were particularly interested in Clauson's case, as this fingerprint card contained a request for telegraphic information if it was discovered that he was wanted. When the fingerprints were classified and searched, it was determined that this person was identical with the fugitive whose apprehension was desired by the Maryland and Pennsylvania authorities and the interested officials were informed immediately of the facts.

All peace officers are invited to make liberal use of the wanted notice facilities of the Division of Investigation, as through this medium approximately 365 fugitives are identified each month. The Division issues blank wanted notice forms for the convenience of law enforcement agencies in the transmittal to the Division of advice relative to the fugitive status of any individual.

INTERESTING IDENTIFICATION

ESCAPED CRIMINAL IDENTIFIED THROUGH FINGERPRINTS

According to the criminal history appearing a the identification files of the Division of Investigation, the record of the person known variously as Raymond Calvin Miller, Thomas Harbridge Barr, Buck Lacey, Thomas Harvey King and T. B. Lacy may be traced to 1910 when he was involved in a burglary case at Alameda, California. In 1914, he was arrested at Los Angeles, California charged with a forgery violation and placed on probation for five years.

According to the identification files, it appears that this person in 1915 was received in the Folsom State Prison, Represa, California to serve a three-year term for forgery; that in 1917, he was received in the State Penitentiary at Santa Fe, New Mexico to serve four to five years for robbery while armed; in 1924, he was received in the State Penitentiary at Nashville, Tennessee to serve five to ten years for bank robbery and grand larceny, paroled in October, 1928 and returned to prison in May, 1929 while awaiting trial on three cases of attempted larceny, for which he was given a further sentence of one to three years.

The further criminal history of this person is *raced to May, 1932 when he was received in the State Penitentiary at McAlester, Cklahoma to serve six years for grand larceny. On December 27, 1933 the Division was informed that he had effected his escape from the Oklahoma institution and a wanted notice was placed in the files at that time.

On January 10, 1934, the Division received a fingerprint card from the Police Department at Winslow, Arizona reporting the arrest of one Ed Woods on January 6th, charged with turglary. When these fingerprints were classified and searched in the technical files, it was found that he was identical with the escaped prisoner from the Oklahoma Penitentiary and the Warden of that institution was informed by telegraph of his arrest in Arizona.

OFFENSES KNOWN TO THE POLICE JANUARY TO DECEMBER, 1933

During the calendar year 1933, the Division of Investigation received useable monthly crime reports from 87 cities with population in excess of 100,000. The reports are based on the number of offenses known to the police, which is generally considered the best index to the amount of crime.

More complete tabulations based on these reports are published in the bulletin "Uniform Crime Reports". However, as of interest to law enforcement officials generally, there appears below a table showing the number of offenses reported by the police departments in 87 cities with an aggregate population of 29,756,512. The figures are also expressed in the form of daily averages.

During the second half of 1933, the averages for murder and non-negligent manslaughter were higher than for the first half of the year. For manslaughter by negligence the averages were highest during the fourth quarter, whereas for aggravated assault, the figures are highest during June, July, and August. The averages for robbery and burglary were lower during the second and third quarters than during the first and fourth. However, the figures for the last quarter of the year were not as high as for the first period. On the other hand, the figures for larceny-theft show a high point during the fourth quarter of the year.

Pursuant to the recommendation of the Committee on Uniform Crime Records of the International Association of Chiefs of Police, the Division of Investigation will begin in the issue of the bulletin "Uniform Crime Reports" for the first quarter of 1934, the publication of crime rates for individual cities with population in excess of 100,000.
