The Division of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Division does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Division of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Division has investigative jurisdiction:-

National Bank and Federal Reserve Act Violations, such as embezzlement,
abstraction or misapplication of funds
Crimes on any kind of Government reservation, including Indian Reserva-
tions or in any Government building or other Government property
Neutrality violations, including the shipment of arms to friendly nations
Frauds against the Government
Crimes in connection with Federal Penal and Correctional Institutions
Perjury, embezzlement, or bribery in connection with Federal Statutes or
officials
Crimes on the high seas
Federal Anti-Racketeering Statute
The location of persons who are fugitives from justice by reason of vio-
lations of the Federal Laws over which the Division has jurisdiction,
of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforce-
ment officials concerning the above listed violations is promptly forwarded
to the Special Agent in Charge of the nearest field office of the Division
of Investigation, U. S. Department of Justice. If the information indicates
that immediate action is necessary, telegrams marked "Government Rate Collect"
or telephone calls will be accepted. The address of each of the Field Offices
of this Division appears on the inside back cover of this bulletin.

In the results of the four swiftly moving days which marked the Attorney General's Conference on Crime, held in Washington, D. C., December 10-13, 1934, every law enforcement official and every friend of good government has reason to find encouragement.

Serious delegates, representing all parts of the nation and many of the groups having a direct or indirect interest in the problems of crime, gave thoughtful consideration to plainly spoken challenges of existing conditions, and plans for improvements. The Conference was not a legislative body, and so could not enact into law the ideas it presented, but it did, I feel certain, send back to many communities public leaders who will fight with renewed determination, for the improvement of present practices.

In the closing hour of the Conference, the Attorney General aptly stated:

"I think it may truthfully be said that the Nation as a whole has awakened from a strange sort of torpidity and, like an aroused giant, is shaking off the chains in which it has been bound. The plain fact is that our country has been a laggard amongst Nations in dealing with this matter. The vehement agitation of a few, or the righteous indignation of a small minority, may stir limited groups and exercise a healthy and stimulating influence, but accomplishments of a real and permanent character can never be achieved without a stout-hearted public sentiment supporting the forces of law and order in every nook and corner of our land."


He then declared the problem to comprise four major topics:
1. Devising and securing a proper law enforcement system. 2. Personnel. 3. Crime Prevention. 4. Public Support.

Of these he said:

"The immense difficulties inherent in these matters must be apparent to all. We are in for a long time program. It will require unremitting service, continued over a long period of years."

I am certain that every official will join the Attorney General in his summation of the crime problem, and I believe it is safe to say that the public is becoming more and more concerned. We can look ahead with confidence.

Repeated references were made during the Conference to the necessity of united action on the part of law enforcement officials. The past year has witnessed an unusual number of cases involving widespread activities of criminal groups, and the pursuit of fugitives over a wide area. The success achieved has been a tribute to the willingness of every local, state or federal group to offer its assistance to fellow officers. I think we can look forward to an even greater spirit of unity and comradeship in the future.

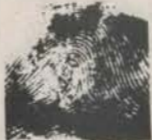

SPECIAL ANNOUNCEMENTS

The Division of Investigation is pleased to announce that arrangements have been devised to provide for the posting or tabulating in its records of all information relative to the various steps in the treatment or movement of prison population, such as the fact of release upon the expiration of sentence or for any other cause, as parole, commutation, pardon, or through some other type of clemency. The Division, therefore, is pleased to invite any penal institutions which are not now submitting record sheets or information of this character to forward at monthly intervals, if possible, reports relative to the said movement of prison population. It is assumed that these reports, prepared in the usual manner, will include the names and numbers of the prisoners involved, with aliases, or the primary classifications in the cases of common names, the particular step in the treatment of each case, and the date of the said treatment. It is suggested that re-commitments and returns, as well as any other activity of interest be reported so the said information may be noted in the identification files. Where a person is committed to serve an indeterminate sentence, the facts surrounding his release should be stated.

It is felt that the information of the character described which is requested frequently by interested officials will serve a very valuable purpose for all law enforcement agencies which contribute fingerprints to the Identification Unit. The wardens of all penal and correctional institutions who now send fingerprints are invited to make use of this expansion to the identification service. Appropriate disposition sheet forms are available for distribution in the event the said officials make requests therefor.

It is suggested that any notifications relative to the fugitive status of prisoners such as escapes, parole violations and the like be reported in the manner now prevailing. Forms for this purpose also are distributed by this Division whenever they are requested.

In order to assist those contributors requiring such information, the last issue of the Bulletin, "Fugitives Wanted by Police", contained additions to the fingerprint classification formulae appearing in connection with the wanted notices. For the first time the sub-secondary classification as well as the small letter patterns were included in those secondary classifications showing a whorl in either index finger.

It is thought that this additional classification will be of assistance to those contributors who do not use the small letters for filing purposes. The completely extended classification formulae are also given as has been the practice heretofore.

INTERESTING IDENTIFICATION

ALBERT BEST

INMATE OF ALCATRAZ REVEALED BY FINGERPRINTS TO BE
INTERNATIONAL SWINDLER WANTED IN MANY JURISDICTIONS

On September 1, 1934, Albert Best, one of the most badly wanted swindlers operating on an international scale, was received at the United States Penitentiary at Alcatraz, California. His criminal record as disclosed by the files of the Identification Unit of the Division of Investigation extends from 1920 to the present time and includes several fugitive notices by authorities in this country and abroad, as well as notices of incarcerations for forgery, larceny and embezzlement.

Following a sentence of five years in the State Industrial Reformatory at Huntingdon, Pennsylvania for the offense of forgery and a sentence of three to five years in the State Prison at Charlestown, Massachusetts, commencing in October, 1925, for the offense of larceny, Best's active career in attempting to elude law enforcement officials began. He was arrested by the Police Department at St. Louis, Missouri in September, 1930, as a fugitive confidence man from Miami, Florida. He was turned over to the Florida authorities, convicted of embezzlement and in November, 1930 was received at the State Farm, Raiford, Florida to serve a term of ten years for embezzlement and grand larceny. It is interesting to note that when taken into custody he was wanted by the Police Departments in New York City, Boston, Massachusetts and San Francisco, California. However, approximately one month after he was received at the Florida State Farm he effected his escape from that institution.

The next information relative to his activities is that in April, 1931, the Berlin, Germany authorities sentenced him to a term of nine months for fraud and serious falsification of documents. However, this information was not received in the Identification Unit until after his release by the Berlin authorities.

Best appeared in San Remo, Italy in November, 1932 and represented himself to be the General Consul of the Republic of San Domingo and paid his hotel bill with a forged check of over \$500. Shortly thereafter, he proceeded to Munich and in May, 1933 information was received from the Vienna authorities that he was wanted for fraud committed in November, 1932. The communication from Vienna indicated that he had perpetrated a series of frauds totalling 7610 Reichsmark. It appeared, further, that in December, 1932, he had fled to North America.

The Police Department at Washington, D. C. notified the Identification Unit in April, 1933 that Best was wanted by that Department for false pretenses. In October of that year an inquiry was received from the Royal Canadian Mounted Police requesting information as to Best's whereabouts and stating that a warrant for him was held by the Police Department at Halifax, Nova Scotia.

In November, 1933, Best was arrested by the Police Department at Akron, Ohio and held for the District of Columbia authorities and shortly thereafter was sentenced to a term of one to three years for obtaining money under false pretenses. Originally committed to the D. C. Reformatory at Lorton, Virginia, he was transferred to the United States Penitentiary at Alcatraz, California, in September, 1934.

All interested officials have been notified of this person's incarceration at Alcatraz and it is assumed that detainers have been filed or will be filed by many of the Police authorities by whom Best is wanted.

This case is an outstanding illustration of the value of the international exchange of fingerprint data, which not only provides a compilation of complete criminal data but is also an indispensable vehicle whereby Police officials who desire the apprehension of a person may be notified of his arrest in foreign jurisdictions.

INTERESTING IDENTIFICATION

GIDEON L. REDING
BADLY WANTED BANK ROBBER IDENTIFIED BY WANTED NOTICE
IN FUGITIVE BULLETIN

In January, 1934, the Sheriff's Office at Las Cruces, New Mexico advised the Division of Investigation that one Gideon L. Reding was wanted by that office and also by the Sheriff's Office at Estancia, New Mexico for bank robbery while armed. Upon receipt of this information a wanted notice was posted against Reding's record in the files of the Identification Unit. Moreover, a notice of his fugitive status was published in the April, 1934 issue of the bulletin, "Fugitives Wanted by Police".

A letter was received in the Identification Unit of the Division on November 22, 1934, from the Sheriff at Yuma, Arizona, wherein that official indicated that by means of the fugitive bulletin he had been successful in determining that a person under arrest by his office was identical with the fugitive bank robber from New Mexico. The pertinent details relative to the instant case reflect that on the night of November 4, 1934 a lone bandit entered a drug store in Yuma, Arizona and at the point of a gun forced the proprietor and two employees to open a safe and turn over to him \$300 in cash. He was successful in remaining at large until November 15, 1934, when he was taken into custody on a charge of robbery. His fingerprints were taken and the Sheriff at Yuma, Arizona referred to his files for the purpose of comparing this person's fingerprints with those appearing in the bulletin, "Fugitives Wanted by Police". A comparison of the finger impressions revealed that he was wanted for bank robbery in New Mexico as indicated above. Although he gave the name of Taylor Edwards, when arrested for the offense at Yuma, Arizona, he admitted that his name was Reding when confronted with the information in the fugitive bulletin.

This individual's fingerprints were received in the Identification Unit of the Division on November 26, 1934 and, of course, were identified with those of the bank robber from New Mexico. A communication from the Division confirming the identification made by the Sheriff at Yuma, Arizona was transmitted to that office and also to the Sheriffs' Offices at Las Cruces and Estancia, New Mexico.

In expressing his gratification for the service rendered by the fugitive bulletin in this case, the Superintendent of the Bureau of Criminal Identification at Yuma, Arizona emphasized the salient fact that had it not been for the information in the bulletin and subsequent advice received from the Identification Unit there would have been little likelihood that the State of New Mexico would ever have known that the man wanted there so badly for a serious crime had been arrested so nearby.
