The Division of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Division does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Division of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Division has investigative jurisdiction:-

National Motor Vehicle Theft Act

Interstate transportation of stolen property valued at \$5,000 or more

National Bankruptcy Act

White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Killing or Assaulting Federal Officer

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnapped

Extortion cases in which interstate commerce or interstate communication is an element

Theft, Embezzlement or Illegal Possession of Government Property

Antitrust Laws

Robbery of National Banks and Member Banks of Federal Reserve System

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property

Neutrality violations, including the shipment of arms to friendly nations

Frauds against the Government

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Division has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Division of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field Offices of this Division appears on the inside back cover of this bulletin.


The Division of Investigation, U. S. Department of Justice, endeavors to keep in close personal touch with all matters pertaining to law enforcement. In reading of the various developments in this field in periodicals, reports of meetings and organizations, we have noted with much interest and pleasure the marked increase in the formation of law enforcement and peace officers' organizations and associations throughout the country. We can conceive of no better sign or indication of vigorous development of the theory of organization and the basic principle of cooperation underlying all developments of this kind.

Organizations such as these are not only desirable from the standpoint of the social and fraternal exchange of personal development which they reflect, but they are vitally necessary in the war against crime in all parts of this and other countries. Operating alone a law enforcement organization or representative is weak and ineffective and any attempt to secure a successful consummation of effort with a view to permanent or comprehensive success will, under these conditions, prove unavailing. Working, however, in close and efficient cooperation with other law enforcement organizations and officials, the same success which has attended cooperative efforts in this field in the past will continue, with even more gratifying results, in the future.

No plan, idea or policy can be safely carried into active and extensive operation until it is first tested in the crucible of a broadly mutual consideration and study in the light of our combined experience. A law enforcement official need never fear giving more than he receives when he submits any plan or project to the consideration of his fellow officers in the law enforcement field. The combined wisdom of all will prove beneficial in each and every case. For this reason, we believe that any new plan or policy which appears to function successfully in our individual spheres should be submitted, through peace officers' organizations, to all of the members thereof, not only for the good that may accrue by the adoption of these plans or policies by other peace officers, but because of the improvement and the extension that will come to all worthy plans and policies through the testing process that can only be applied by the mutual wisdom and experience of all of us.

It is a source of much regret to me that because of the pressure of official duties it is impossible for me to attend in person all of the meetings of these peace officers' and law enforcement associations to which I am invited. I appreciate keenly the honor and courtesy involved in the extension of these invitations. I will attend them whenever possible. It has been the policy of the Division of Investigation, however, and will continue so to be, to arrange for a representation of the Division at any such meetings by an official of the Division. A few exceptions to this policy have been necessary because of exceptional personnel conditions, but we are always glad to be permitted to have a representative present at meetings of this kind. The Division of Investigation has benefitted much by the exchange of ideas and the consideration of policies which have developed at meetings of this kind.

The Division of Investigation receives the official publications of a large number of these peace officers' organizations. In the event that any such publications are not being transmitted to the Division, it is requested that the Division of Investigation be placed on all mailing lists in order that the Division may be able to keep in touch with all developments of this kind in the law enforcement field.

NOTICES

The attention of all law enforcement officials is invited to the fact that the Identification Unit of the Division of Investigation now furnishes a file number on its criminal record sheets, i.e., in all cases where a prior criminal history has been located. This number appears at the top of the regular criminal history sheets or on the bottom of certain form letters prepared in the Identification Unit to transmit prior criminal records to interested officials.

It is the desire of the Division that wherever available this file number be cited on disposition sheets prepared for the Division to complete criminal records on file in the Identification Unit. When a Division file number is available, the search of the records and the assembly of the data for the posting of the dispositions are materially simplified and shortened.

Where disposition sheets are submitted in the cases of fingerprints which have not been identified by the Division, the search of the Card-Index files conducted for the purpose of locating the record to which each disposition pertains will be shortened materially if the primary classification can be furnished, particularly in the cases of common names. For example, at the present time the Division has approximately 4,000 alias and true name cards on John Smith. Unless the Division file number is furnished in the case of an identified record, or the primary classification in the case of an unidentified record, several hours' time may be expended in the location of the index card relating to the case covered by the disposition furnished by the interested official. It is understood, of course, that in all instances where dispositions are supplied, the name appearing on the fingerprint card represented by the disposition must be cited, as well as the arrest or institution number and the date of arrest or commitment, if necessary.

All law enforcement agencies may afford material assistance to the Division through the adoption of these suggestions.

OFFENSES KNOWN TO THE POLICE
APRIL AND MAY 1934

There is presented in the following compilation, the number of offenses reported for April and May 1934 by the police departments in 79 cities with more than 100,000 inhabitants. The figures are also presented in the form of daily averages. In comparing the amount of crime reported in April and May, it is preferable to employ the daily averages, since the number of days in each of the two months is not the same.

The compilation discloses decreases in the daily averages for all classifications with the exception of rape and aggravated assault. Figures for manslaughter by negligence show a decrease of 11.6 percent, but in this connection it is desired to point out that in the past several cities have scored as cases of manslaughter by negligence, all instances of so-called automobile deaths. In recent months several of the cities have modified their scoring procedures so as to include in that classification only those instances in which the driver of the automobile was guilty of culpable negligence. It will be observed that a large portion of the decrease in negligent manslaughters may be due solely to changes in the scoring procedure.

The following additional decreases are disclosed: robbery 15.4%, auto theft 11.2%, murder and non-negligent manslaughter 9.5%, burglary-breaking or entering 9.4%, larceny-theft 5.9%.

In connection with the decreases indicated above, consideration should be given to the compilation appearing in the June issue of this bulletin which reflected substantial increases during April in the number of offenses of murder and auto theft.

INTERESTING IDENTIFICATION

DAVID McKECHNIE

UNKNOWN DECEASED PERSON IDENTIFIED
THROUGH FINGERPRINTS

On June 8, 1934, the Division of Investigation received in its Identification Unit from the Police Department at Georgetown, Kentucky, the fingerprint card of an unidentified white male, apparently 50 years of age, whose body had been found on the Southern Railway track near Georgetown. The body was reported to be so badly mutilated that it would be impossible to establish an identification excepting through the fingerprints which were taken in the case of the deceased.

When this fingerprint card was classified and searched in the technical files, it was found that the unidentified person was identical with David McKechnie, who in May, 1932, had been received at the State Farm, Greencastle, Indiana, from Henry County to serve a sentence of 130 days and to pay a fine and costs for assault. Advice of the identification was transmitted by telegraph to the Police Department at Georgetown at once so efforts could be made to trace the relatives and make proper disposition of the body. The Division has been notified that the wife of the deceased has since been located.

While the Division identifies many deceased individuals through a comparison of the fingerprints included in its files, the instances wherein the bodies are so badly mutilated that identification could not be effected in any other manner are relatively rare. This case is cited as an illustration of the efficacy of the fingerprinting practice. All law enforcement officials are invited to transmit to the Division of Investigation fingerprints of unidentified deceased persons.

INTERESTING IDENTIFICATION

WHEREABOUTS OF FUGITIVE DETERMINED THROUGH
SUBMISSION OF "REPRINTS" BY INTERESTED OFFICIAL

In the conduct of its Identification Unit, the Division of Investigation endeavors to encourage all interested law enforcement agencies who are enrolled as contributors of fingerprints, to transmit the most legible impressions obtainable under any and all conditions. Fingerprints which are entirely susceptible of accurate classification are, of course, particularly required for the proper maintenance of a large bureau and, therefore, when impressions are received which cannot be classified accurately, the Division has followed the practice of returning such records to the contributing officials, with the request that "reprints" be taken.

Frequently an identification is effected when the "reprints" are searched. During the month of May a case of particular interest in this respect was observed in the Identification Unit. A law enforcement official of a smaller city, transmitted to this Division the fingerprints of a person charged with highway robbery. These prints were prepared in such a manner that they could not be classified or searched properly. Therefore, they were returned to the interested official for the purpose of securing more legible impressions. When these "reprints" were received in the Identification Unit, it was found that this person who was being held under an assumed name, was wanted in an adjacent state, charged with robbery and bond forfeiture. This information, of course, was furnished to the interested officials at once.

This case illustrates the need for clear finger impressions in all instances. The Division of Investigation feels that its practice and policy in this respect is constructive in that many officers, particularly novices in fingerprint work, are aided materially in the preparation of accurate impressions through the suggestions given by the Division. In this connection, it is noted also that even though no prior record is disclosed when a "reprint" is transmitted to the Division, the more legible impressions insure the proper classification and arrangement in the files, of the fingerprint record and thus facilitate a subsequent identification.

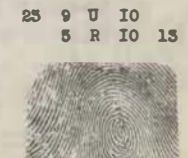
