The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction,



Arrangements have been made so that an attendant is on duty in the Communications Section of the Bureau at Washington, D. C., and in the field offices throughout the country during the entire twenty-four hour period of each day.

On the rear cover of this Bulletin you will find a list of the field offices of the Bureau with their addresses, telephone and teletype numbers, which will be of material assistance to you for reference and use in future communications.

It is my hope and belief that the use of teletype facilities will be another step forward toward a more expeditious dissemination of desired information by various law enforcement officials throughout the country.

In an effort to have this information readily available, the Bureau is providing appropriate space for the entry of the names and police numbers of accomplices, to be inserted on the arrest fingerprint cards which will be issued by the Bureau in the future.

It is desired to extend an invitation to interested law enforcement agencies who arrest members of individual gangs to cross-reference appropriately the names and numbers of such members on the fingerprint cards transmitted to the Identification Division. This information will, of course, be available for the use of any agencies making requests therefor.

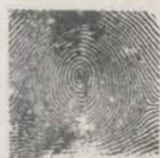

INTERESTING IDENTIFICATIONS.

ROBERT H. MCCOY.

FLOATER ARRESTED FOR GENERAL INVESTIGATION
IDENTIFIED AS ESCAPED LIFE TERMER.

The warden of the State Prison, Salt Lake City, Utah, notified the Federal Bureau of Investigation in March, 1935, that one Robert H. McCoy, who had been serving a life term for robbery and first degree murder, had escaped from the State Prison Farm on March 3, 1935. Accordingly, a notice of his fugitive status was posted against his record in the fingerprint files of the Bureau. It is observed that the Bureau's files indicate this person had previously escaped from the Utah State Prison, but had been returned to that institution.

A fingerprint card received in the Bureau on May 8, 1935, from the Police Department, St. Paul, Minnesota, contained the report that one Robert Edward Walker, whose finger impressions appeared on this card, had been arrested by that Department on May 5, 1935, on a charge of general investigation. Walker told the St. Paul authorities that he was a "floater" and that he had no permanent residence. The only prior criminal history that he admitted was that he had been arrested in 1925 at Peoria, Illinois, on a charge of investigation and had been released. The St. Paul authorities requested that they be notified by telegram whether or not this person had a record.

Very shortly after the fingerprints were received from St. Paul they were searched through the files of the Identification Division and it was found that Robert Edward Walker was identical with Robert H. McCoy, the escape from the Utah State Prison Farm. A telegram was dispatched at once to the Chief of Police at St. Paul advising him of the fugitive status of this person, and the Warden of the State Prison at Salt Lake City, Utah, was furnished telegraphic advice of the arrest at St. Paul.

It is observed that in this case the fugitive was arrested in a state distant from the jurisdiction seeking his apprehension, and further that he had adopted an alias which he had never used previously so far as the Bureau's records disclosed. Many similar cases illustrating the value of placing wanted notices in the Bureau's files whenever a person's apprehension is sought and the desirability of having fingerprints of all persons who are arrested forwarded to the Bureau occur each day. As a matter of general interest, during the month of May, 1935, 446 fugitives were identified through fingerprints forwarded to the Bureau.

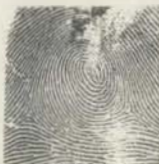

INTERESTING IDENTIFICATION.

WILLIE BYRD.

TRAFFIC VIOLATOR, ARRESTED FOR INVESTIGATION, IDENTIFIED
AS MURDERER THROUGH FINGERPRINTS FORWARDED TO BUREAU.

A wanted circular was received in the Identification Division of the Federal Bureau of Investigation on July 25, 1934, from the Sheriff's Office at Columbia, South Carolina, reporting that one Willie Byrd, alias "Snake Byrd", was wanted by that Office for the murder of a woman near Columbia, South Carolina, on July 21, 1934. On the receipt of this circular a notice of Byrd's fugitive status was posted against his record in the fingerprint files of the Bureau.

On April 12, 1935, a fingerprint card was received in the Bureau from the Police Department at Greensboro, North Carolina, whereon it appeared that one Mack Owens had been arrested by that Department on April 10, 1935, on a charge of investigation of traffic violation, and that a 30-day sentence had been imposed in this case. A search of Owens' fingerprints through the files of the Identification Division of the Bureau disclosed that he was identical with Willie Byrd, who was wanted for murder in Columbia, South Carolina, as indicated above. Information of his arrest at Greensboro, North Carolina was transmitted at once by telegram to the Sheriff's Office at Columbia, and the Chief of Police at Greensboro was furnished telegraphic advice of the fugitive status of the individual under arrest by his Department.

Subsequent information has been received that when confronted with the report of this fingerprint identification Owens admitted his identity, and furthermore, on being questioned, admitted the killing for which his apprehension had been sought.

It is interesting to note that suspicion had been cast upon Byrd when his presence was noticed near the scene of the killing shortly before the woman had been murdered. He disappeared at that time and had not been seen in the neighborhood since. Were it not for the fact that the Federal Bureau of Investigation provides a central clearing house for fingerprint data this badly wanted murderer probably would have remained at large even though he was arrested in a neighboring state.

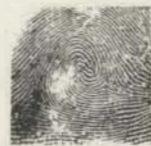

OFFENSES KNOWN TO THE POLICE
April and May, 1935.

In order to make available current information regarding fluctuations in the amount of crime in the United States, there is presented in the following tabulation the number of major offenses reported by the police departments of 74 cities, with more than 100,000 inhabitants, for April and May, 1935. The figures are also presented in the form of daily averages. Due to the fact that April has only 30 days, whereas May has 31, persons desiring to make exact comparisons between the number of offenses reported during those two months should employ the daily averages.

In general, the compilation shows increases in the number of offenses against the person (murder, aggravated assault, and rape). A decrease was shown in the number of cases of negligent manslaughter.

The figures for May show substantial decreases in the number of crimes against property, which include robbery, burglary, larceny, and auto theft. In general, the trends referred to above are in harmony with the figures for prior years.

In presenting the following tabulation, it is suggested that individual police agencies may desire to compare their figures with those representing average data, based on the reports received from the larger cities of the country.

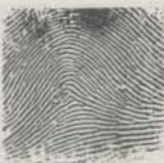

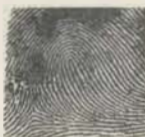

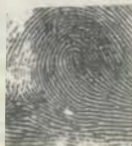

FINGERPRINTS AND THEIR USE IN IDENTIFYING
AMNESIA VICTIMS.

Among the interesting cases that have developed in connection with the civil identification activities of the Federal Bureau of Investigation, the following identification of an amnesia victim was recently effected.

On June 10, 1935, a set of fingerprints were received, in the Fingerprint Unit of the Bureau, from the Sheriff's Office at Stockton, California.

A notation appeared on the fingerprint card that the fingerprints were those of a white man who, being an amnesia victim, gave himself up at the Sheriff's Office, stating that he did not know who he was, what his name was, where he came from or any facts that would be of assistance in aiding the Sheriff's Office to determine his identity.

A search of the fingerprints through the files of the Identification Division disclosed that this person was one Thomas E. Hennessy. Hennessy having been arrested by the Sheriff's Office, Los Angeles, California, on April 8, 1935, on a charge of burglary and attempted robbery.

This identification was made because Hennessy had been arrested on a criminal charge, because he thereby had a record of identity on file in the Identification Division of the Bureau.

Had the amnesia victim been an average law abiding citizen, who is not a criminal and who is not picked up on suspicion, the fingerprint search would have had no value in determining his identity. This is an incident where one suspected of crime, had a decided advantage over the average citizen, who has no fingerprint record on file for identification purposes.

Too much emphasis can not be placed upon the advantage to the individual, in having his or her fingerprints on file in the Civil Identification Section of the Bureau fingerprint files. This is a service maintained for the people and to their protection in guarding against accident, abduction and amnesia, which should be utilized.
