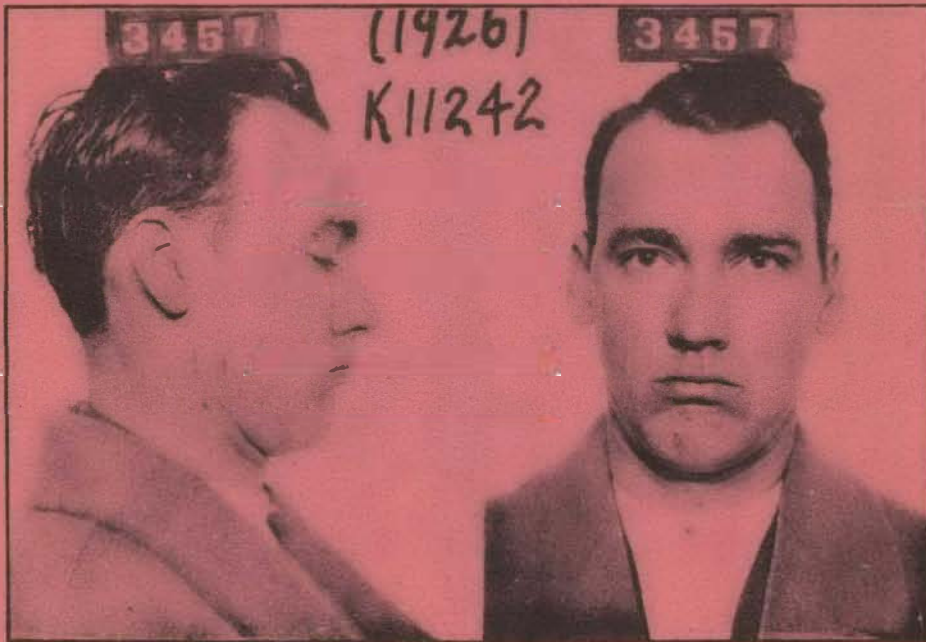

The Federal Bureau of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Bureau does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Federal Bureau of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act

Interstate transportation of stolen property valued at \$5,000 or more

National Bankruptcy Act

Interstate flight to avoid prosecution or testifying in certain cases

White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Killing or Assaulting Federal Officer

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnaped

Extortion cases in which interstate commerce or interstate communication is an element

Theft, Embezzlement or Illegal Possession of Government Property

Antitrust Laws

Robbery of National Banks and Member Banks of Federal Reserve System

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property

Neutrality violations, including the shipment of arms to friendly nations

Frauds against the Government

Crimes in connection with Federal Penal and Correctional Institutions

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

Federal Anti-Racketeering Statute

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Federal Bureau of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field Offices of this Bureau appears on the inside back cover of this bulletin.


Law enforcement officials who visited the Century of Progress Exposition at Chicago will recall the exhibit of the Federal Bureau of Investigation. Speaking of this exhibit, the Bulletin on "Fugitives Wanted by Police" for May 1, 1933 said:

"It is hoped that by means of this exhibit there can be portrayed to some extent the actual workings of this Bureau in such a manner as to cause law enforcement officers, in particular, to become more familiar with the detailed operations in connection with the Bureau's work, and perhaps at the same time to feel a degree of pride in the accomplishments which have been effected due to the splendid cooperation between the peace officers of the nation and the Federal Bureau of Investigation."

The hopes which the Bureau felt for this exhibit were more than realized. The interest shown, and the friendly comments received from law enforcement officials demonstrated that the exhibit was not only a popular favorite, but also that, in some instances, it served the useful purpose of bringing about a greater use of those of the Bureau's facilities which are helpful to peace officers in their own work.

The project was, in fact, so well received and so successful that the Bureau has placed another exhibit at the California Pacific International Exposition which opened at San Diego, California on May 29, 1935. It is made up of entirely different features, and, I believe, will prove equally as interesting to peace officers as was the exhibit at the Century of Progress.

A cordial invitation is extended to all law enforcement officials to visit the Bureau's San Diego exhibit, where a most friendly reception will await those who call. The exhibit is located in the center space of the United States Government Building on the Exposition grounds, and will be operated for the duration of the Exposition, which, according to present plans, will last five months.

SPECIAL ANNOUNCEMENTS

NON-REMOVABLE AUTOMOBILE LICENSE PLATES

The Federal Bureau of Investigation has received from time to time suggestions relative to the desirability of the adoption by the various States of some form of license plates for automobiles, so constructed that the plates could not be removed without rendering them unfit for further use; in other words, without practically destroying these plates.

The Federal Bureau of Investigation cannot, of course, take any steps to initiate or to in any manner influence legislation on the part of the individual States. It is, however, interested, together with all law enforcement authorities, in any plan or plans which will serve to render more difficult the theft and interstate transportation of stolen automobiles, inasmuch as it is vested with investigative jurisdiction in these cases under the National Motor Vehicle Theft Act. If plans could be effected which would bring about the adoption by the various States of the use of some device which would render it impossible for an automobile thief to exchange license plates on a stolen car, it would, of course, render the stealing of automobiles and their subsequent concealment more difficult. This is a matter which may well be considered of interest to law enforcement officers in general and it is, therefore, being brought to the attention of the Bureau's correspondents in order that they may give the matter such study as may appear desirable and take such action, if any, as they may deem appropriate.

BURGLARIES OF CLOTHING STORES

The attention of the Federal Bureau of Investigation has been invited by the Police Department at Macon, Georgia to recent extensive burglaries of clothing stores committed in Georgia, Alabama, Florida and South Carolina. The method of operation is described as follows:

"Approach is made to the street entrance of a high class men's clothing store at or around midnight; the lock cylinder removed by use of an instrument such as a wheel-puller and the lock opened by tripping the catch through the cylinder hole. In all cases the stores burglarized have been locked with Yale door locks. After entrance has been gained the thieves empty the clothes racks nearest the front door and do not disturb any other articles in the store. In all cases approximately 200 suits have been taken."

The foregoing information is brought to the attention of all interested officials in this bulletin as it is felt that, having knowledge of these burglaries, they may wish to give attention to the possibility of similar operations in their own cities. The Bureau will be glad to publish in future bulletins matters of a similar character referred by interested officials.

INTERESTING IDENTIFICATION

JESSEY MOSLEY McGRAW

UNKNOWN PERSON, KILLED BY TRAIN, IDENTIFIED AND BIRTHPLACE
ASCERTAINED THROUGH FINGERPRINTS FORWARDED TO
FEDERAL BUREAU OF INVESTIGATION

The fingerprints of a deceased person, whose body had been found by railroad tracks near Boulder, Colorado, and who apparently had been struck by a train, were received in the Federal Bureau of Investigation on April 8, 1935, from the Sheriff's Office at Boulder. It appeared that all efforts to determine the identity of this person had been unsuccessful. The fingerprints were searched at once against the files of the Identification Division and the deceased person was found to be one Jessey Mosley McGraw, who had a record of several arrests, commencing in 1926.

The files disclosed that this person had been arrested at Phoenix, Arizona; Billings, Montana; Sacramento, California; El Centro, California; and Pocatello, Idaho. His record included arrests on such charges as robbery, petty larceny, vagrancy and shoplifting. Information appeared in the files that his birthplace was Davis, Oklahoma. A few hours after this person's fingerprints were received in the Bureau, information of the foregoing criminal record, together with a report as to his birthplace, was transmitted by telegram to the authorities at Boulder. Information has been received that on the receipt of the above report appropriate inquiries were conducted at Davis, Oklahoma, for the purpose of locating his relatives.

This case is but one of many in which the identities of deceased persons are established each month through fingerprints forwarded to the Federal Bureau of Investigation. It is noted that there has been a decided increase in the extent to which the Bureau's facilities are utilized in connection with cases of this character. Such satisfactory results have attended the practice of forwarding to the Bureau the fingerprints of unidentified deceased persons that the Bureau has promoted an extensive campaign of encouragement to law enforcement officials and coroners' offices throughout the country in the interest of having the fingerprints of all unidentified deceased persons forwarded to the Bureau.

INTERESTING IDENTIFICATION

"LITTLE JEFF" SHARUM

FINGERPRINT FILES DISCLOSE FIFTY-TWO YEARS
OF CRIMINAL ACTIVITY BY NOTORIOUS CON MAN

One of the most prolonged records on file in the Identification Division of the Federal Bureau of Investigation is that of Jeff Sharum, whose criminal career commenced in 1883 and whose most recent arrest was by the Police Department at Reading, Pennsylvania, on February 17, 1935. Over this period his unlawful activities caused his arrest on such widely divergent charges as defrauding in stock swindle, murder, and common thief and pick-pocket. His record comprises nineteen arrests in fifteen different cities, resulting in eleven commitments to penal institutions. During his criminal career he has adopted fifty aliases.

Sharum's first penitentiary sentence was in the year 1883 when he received a sentence of four years to the Chester, Illinois Penitentiary for murder. He was 26 years of age at that time. In 1932, at the age of 75, he was received at the Essex County Penitentiary, Caldwell, New Jersey, to serve eighteen months for conspiracy. Following his release from that institution he resumed his accustomed life as a bunco operator. Reports from law enforcement officials in Colorado Springs, Colorado, and Detroit, Michigan, indicated that he was notorious as a swindler in stocks and bonds and as a fake race horse con man. In February, 1935, he was arrested by the Sheriff's Office at Miami, Florida, as a fugitive from Pennsylvania, where he was wanted for false pretenses, and shortly thereafter he was taken into the custody of the Police Department at Reading, Pennsylvania, on a charge of conspiracy.

Although the Bureau files contain records of many persons who have been arrested more often than Sharum, the duration of this person's criminal career is one of the most extensive on record. The value of maintaining a central depository of all criminal data in the Federal Bureau of Investigation is apparent in view of the many cities, in all sections of the country, where Sharum has been arrested. Furthermore, the fact that this person used so many aliases demonstrates clearly the necessity of employing the fingerprint system for maintaining complete and accurate criminal records.

OFFENSES KNOWN TO THE POLICE
March and April, 1935.

There is shown in the following table the number of offenses reported for March and April, 1935 by the police departments of 77 cities with an aggregate population of 32,448,412. The figures are also presented in the form of daily averages.

Examination of the compilation discloses that with one exception, the number of known offenses for April was smaller than for March. The increase was shown in the number of offenses of murder, the March figure being 173, whereas the figure for April was 183.

It should be observed that for offenses of manslaughter by negligence, larceny, and auto theft, the data are based on reports received from the number of police departments indicated in the footnotes to the table.
