The Division of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Division does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Division of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Division has investigative jurisdiction:-

National Motor Vehicle Theft Act

National Bankruptcy Act

White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Cases involving transportation in interstate or foreign commerce of  
any persons who have been kidnapped

Theft, Embezzlement or Illegal Possession of Government Property

Antitrust Laws

National Bank and Federal Reserve Act Violations, such as embezzlement,  
abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property

Neutrality violations, including the shipment of arms to friendly nations

Frauds against the Government

Perjury, embezzlement, or bribery in connection with Federal Statutes or  
officials

Crimes on the high seas

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Division has jurisdiction, of escaped Federal prisoners. and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Division of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field Offices of this Division appears on the inside back cover of this bulletin.

In a recent radio address, the Attorney General said  
in part:

"I repeat now as I said then that 'The Department of Justice belongs to the people of America; it is their servant, ministering to their needs, and I bespeak for it the support and the good opinion of all law abiding citizens.'

"Surely I could not have expected more loyal and generous support than I have received. Ten busy months have passed rapidly by and during that period the various state and municipal authorities, the newspapers of the country, and the people as a whole, have given the Department of Justice such frank and wholehearted cooperation that our work, though difficult and exacting, has been stimulated and, indeed made inspiring.


"The intensive campaign against kidnapers, racketeers, and other predatory criminals, which was commenced last March, has made distinct and gratifying progress.\* \* \*

"The Department has not been content to rely solely upon the Kidnaping Statute, but has used every available weapon in combating this despicable type of crime. In the case of Charles F. Urschel of Oklahoma City, the total of 15 convictions (6 of which were for life) included convictions of persons who had given refuge and counsel to the actual kidnapers. Indicative of the far flung character of these offenses, it should be noted that the Urschel kidnaping occurred in the State of Oklahoma, the victim was held captive in a remote rural section of Texas, the ransom money was paid in Missouri, a portion of the ransom money was exchanged in Minnesota, another portion was hidden in Texas, one of the guilty parties was located in Colorado, and the others in Tennessee, Minnesota, Texas and Illinois. These seven States have an area of about 683,000 square miles, which exceeds in extent the combined area of Austria, Denmark, France, Germany,



Italy, Holland, Switzerland, England, Scotland and Wales. This particular case, which carried our Agents into sixteen States (Texas, Arkansas, Oklahoma, Colorado, Kansas, Missouri, Iowa, Minnesota, Wisconsin, Illinois, Tennessee, Kentucky, Indiana, Ohio, Pennsylvania and New York), could not have been handled successfully without the effective and loyal cooperation of the local authorities. In this instance, as in many others, Special Agents of the Division of Investigation offered to and received from the State authorities wholesome, friendly and reciprocal help. Through this policy, which is one of cardinal importance, and one upon which we have insisted from the beginning, we were able to coordinate the activities of the law enforcement officials in such a way that in a short time, and with the greatest economy of effort, the guilty parties were brought to justice."

I call your attention especially to the Attorney General's reference to the "wholesome, friendly and reciprocal help" received by Special Agents of this Division from local authorities and I wish to join with him in thanking all of you for the close cooperation and helpful aid which you have always given both the Department and this Division.

It is believed that the new bulletin arrangement will be of material assistance in the identification of fugitives, as with the assistance of the individual impression, arresting departments will be enabled to establish the positive identity of any fugitive when he is taken into custody. Extreme care, of course, will be taken in the publication of classifications, as has been the practice in the past. In line with the usual practice of this Division, I would welcome any pertinent comments from all interested officials as to the efficacy of this new arrangement.

## FINGERPRINTING DECEASED PERSONS

The Division of Investigation frequently is of assistance to officials in the establishment, by fingerprint identifications, of the identity of unknown persons, such as amnesia victims, as well as deceased individuals. This article indicates the technique of taking the fingerprints of the unknown dead, and offers suggestions as to the methods practised by some officials.

Generally speaking, fingerprint operatives find it necessary to take the impressions of three classes of deceased persons; i.e., those who have died recently, when the process is relatively simple; those where considerable difficulty is experienced either because of pronounced stiffening of the ten digits, or the early stages of decomposition or both; and those where great difficulty is met because of advanced stages of disintegration, maceration, decomposition, or putrefaction. The problems are discussed separately, as follows:

1. Sometimes when the fingers are entirely flexible it is possible for the experienced operative to secure impressions of a deceased person thru the regular inking processes on a standard card. However, it is usually found to be more convenient to cut from one card the ten "squares" of paper pertaining to the ten digits so each may be "rolled" separately around each digit, thus securing complete impressions without "slipping" or blurring. The back of each square should be numbered carefully to indicate the finger to which it pertains. When the ten squares are filled, they should be pasted or glued to another card, in their proper positions. The "simultaneous" impressions may be placed on the completed card, if believed to be helpful. Of course, the fingers must be cleaned before the printing operation, as in the case when the subject is alive. It is considered helpful, also, to improvise a tool, similar in appearance to a wide, blunt knife or spatula, and roll thereon a thin film of ink, evenly spread and to use this tool to ink the fingers. While many good impressions are prepared thru inking with an ordinary rubber roller, it is believed that better, and more uniform results attend this work when each finger is inked by passing the inked tool around the finger. Use of the tool, of course, eliminates inking from a glass slab or plate, a practice rendered extremely difficult or awkward when pronounced stiffening is developing.

2. This brings our attention to the second phase of our problem. Frequently, the subject's hands are stiff and clenched. Surgical attention, such as the cutting of controlling tendons, may be required to release them, but usually it is possible to insert the squares described under the fingers and thus secure the impressions. This action is aided greatly thru the employment of another spatula or spoon-shaped tool in which each square is inserted, in turn, in its proper order, the square of paper being held in place by a groove or slot. The "spoon", of course, should have a handle and it should be semi-circular in its shape, resembling a piece of three-fourths' inch lead pipe about one inch long, cut diagonally from end to end. square thus affixed in the spoon should be impressed gently against the finger, held firmly by the other hand. As the square assumes a semi-circular position, since it conforms to the shape of the spoon, a "rolled" impression is easily obtained.

So far this article has dealt with the taking of impressions of fingers when the flesh is firm and the friction ridges intact. A different problem arises when decay has started. The technique of treating the fingers in such cases varies greatly, depending on the surrounding conditions. It is suggested that the services of a surgeon or embalmer be procured to assist in this work, where, of course, the operative may lack the proper facilities. Frequently, the skin on the corpse is peeling or shrunken, and only pieces or fragments may be had. Soaking in a solution of caustic potash causes the skin to swell. When it seems to have attained its regular appearance, it should be washed quickly in water to prevent possible rupture, and then preserved in an alcohol or formalin solution. Often, the injection of paraffin into the fingers, when the skin is intact and sufficiently firm, will "round out" the bulbs again so they may be inked and printed. In many cases the fingers are amputated for the treating and printing action. These usually require surgical operations, also, and care must be taken in their performance.

3. The third group of cases is the most difficult to handle. Frequently, the skin tissue is so badly decomposed and is so softened that, regardless of careful treatment, particles would adhere to any inking instrument, or only blurred results would follow. The tissue may even be peeling because of decomposition. Such cases may be solved most effectively by forensic radiography or dactyloscopic radiography as it is sometimes called; i.e., photographing by means of Xrays. Briefly, the inner surface of the fingers is covered with heavy salts, such as bismuth or lead carbonate, or a white lead mixture, which fills the depressions only. A radiograph taken of the fingers reflects these depressions as white lines while the friction ridges appear to be black. The characteristic details of the ridges show very plainly in these photographs. The pictures should be mounted on an 8 x 8 card in the usual manner.

This article relates to the technique employed by many officials in their work. This Division does not claim that satisfactory results cannot be produced thru following variations thereof. The operations are described briefly in the hope that they may be helpful in particular to operatives to whom the fingerprinting of deceased persons represents a new field of endeavor.

OFFENSES KNOWN TO THE POLICE

December, 1933 and January, 1934

There is presented below a tabulation showing the number of offenses reported for December, 1933 and January, 1934, by the police departments in 82 cities with population in excess of 100,000. The figures are also presented in the form of daily averages. A similar compilation covering the entire calendar year 1933 has been included in the issue of the bulletin "Uniform Crime Reports" for the fourth quarter of 1933.

The tabulation presented below shows that with the exception of the offenses of rape and burglary there has been a substantial decrease in the amount of reported crime. The decreases for the remaining offenses range from 7 per cent for auto theft to 26 per cent for murder and nonnegligent manslaughter.

## INTERESTING IDENTIFICATION

### ESCAPED BURGLAR IDENTIFIED THROUGH FUGITIVE BULLETIN

In the March, 1933 issue of its bulletin, "Fugitives Wanted by Police", the Division of Investigation published the fugitive status of Chester H. Foote, whose apprehension was desired by the Sheriff of Port Angeles, Washington for burglary and escape. According to the Division's fingerprint files, Foote was an ex-convict, because the records reflected that in April of 1926 he had been received in the State Penitentiary at Walla Walla, Washington to serve one to two years in connection with a statutory offense.

On January 15, 1934, a man giving the name of John Kelly was arrested by members of the Tacoma, Washington Police Department, charged with investigation. After he had been fingerprinted, he was identified by the officials at Tacoma at once as Foote, the escaped prisoner from Port Angeles. Foote, alias Kelly was returned to Port Angeles on January 17th. The identification in this case is reported to have been effected solely upon the basis of the publication of Foote's fugitive status in the bulletin prepared and distributed by the Division of Investigation to all law enforcement agencies transmitting fingerprints for its Identification files.

It is the view of the Division that the more liberal and regular use of these bulletins by all law enforcement officials will enable additional fugitives to be identified and held in custody for agencies desiring their apprehension.

## INTERESTING IDENTIFICATION

### ESCAPED CONVICT IDENTIFIED THROUGH FUGITIVE BULLETIN

The criminal record of the person known as John Lewis, as reflected by the files of the Division of Investigation may be traced to 1928, when this person was arrested at Knoxville, Tennessee, charged with larceny. In January of 1929 he was received in the State Penitentiary at Nashville, Tennessee, to serve a 3-year term for larceny of an auto. In April, 1933, he was returned to the Brushy Mountain branch of the institution named to serve three years for housebreaking, larceny and receiving stolen property.

From information submitted by the officials of the Tennessee Prison, it appears that Lewis escaped from the Brushy Mountain institution in July of 1933. This fact was published in the October, 1933 issue of the bulletin "Fugitives Wanted by Police", issued by the Division of Investigation monthly, to report the fugitive status of badly wanted criminals and distributed to approximately 6,500 law enforcement officials who contribute fingerprints to the files of the Division's Identification Unit.

It has been reported to the Division that on January 16, 1934 a person giving the name of James Bernard was arrested by Police Detectives at Tacoma, Washington, on a charge of investigation. When this person was fingerprinted, it was determined by the Tacoma officials that he was identical with Lewis, the escaped prisoner, wanted by the Tennessee officials. The authorities at Tacoma have advised the Division that this identification was effected solely through the medium of the wanted notice published in the fugitive bulletin described. It has been reported that the officials of the Tennessee State Penitentiary contemplate returning Lewis to the custody of that institution to serve the remainder of his term.

The Division of Investigation desires to encourage a more liberal use of the information contained in its fugitive bulletins, which are, of course, designed to permit officials to identify fugitives immediately after they are arrested, so there will be no delay or possibility of their evading identification and so they may be returned at once, if the conditions warrant, to the custody of the authorities by whom they are wanted.
