The Federal Bureau of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Bureau does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Federal Bureau of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act

Interstate transportation of stolen property valued at \$5,000 or more

National Bankruptcy Act

Interstate flight to avoid prosecution or testifying in certain cases

White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Killing or Assaulting Federal Officer

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnaped

Extortion cases in which interstate commerce or interstate communication is an element

Theft, Embezzlement or Illegal Possession of Government Property

Antitrust Laws

Robbery of National Banks and Member Banks of Federal Reserve System

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property

Neutrality violations, including the shipment of arms to friendly nations

Frauds against the Government

Crimes in connection with Federal Penal and Correctional Institutions

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

Federal Anti-Racketeering Statute

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Federal Bureau of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field Offices of this Bureau appears on the inside back cover of this bulletin.

Many officers identified with law enforcement or identification work are already beginning to look forward with anticipation to two events which will take place in the month of July, 1935. I refer to the Forty-Second Annual Convention of the International Association of Chiefs of Police which is to be held at Atlantic City, New Jersey from July eighth to eleventh, and the Twenty-First Annual Convention of the International Association for Identification to be held at Montreal, Quebec, Canada from July fifteenth to eighteenth.

As it is sometimes necessary for peace officers planning to attend conventions to make their arrangements far in advance, it would perhaps not be amiss to make the foreword of this issue of the bulletin of "Fugitives Wanted by Police" serve as a possible reminder to those officers that the time for these conventions is rapidly approaching.

Those who have been fortunate enough to attend previous meetings of these two important Associations need not be informed of their pleasant and worthwhile character. The constructive nature of the proceedings is well known, as is the fact that they have provided many valuable ideas which have been utilized in law enforcement.

Apart from the purely informative or technical side of the conventions, they present other worthwhile aspects. One of these is the pleasure experienced by those who attend in renewing personal acquaintance with those in other localities engaged in similar lines of endeavor.

But more important is the inspiration provided for the continuance and extension of cooperative methods. Representative groups, such as the International Association of Chiefs of Police and the International Association for Identification, are great influences in the welding together of peace officers everywhere into the unity of purpose so essential to high standards.

It is my hope and belief that the forthcoming conventions will serve to strengthen and coordinate still further the forces of law enforcement, and that they will add something to the knowledge of each of us in the problems with which we have to deal.

In this connection permit me to take the opportunity to extend a very cordial invitation to any law enforcement officials who find it possible to visit Washington en route to the forthcoming conventions to call at the offices of the Federal Bureau of Investigation in the new Department of Justice Building where it would afford us much pleasure to show such officials the various activities of the Federal Bureau of Investigation. It is felt that all members of the Associations would be interested in viewing the various phases of the Bureau's work here, particularly those in connection with the identification and crime laboratory facilities.

SPECIAL ANNOUNCEMENT

SYSTEM TO IDENTIFY EXTRADITION AGENTS

There is quoted below a portion of a letter recently forwarded to the Federal Bureau of Investigation by Chief of Police William J. Quinn of San Francisco, California, who has presented what the Bureau believes to be a very effective method to prevent impersonations of peace officers who are dispatched to distant cities as extradition agents:

"In order to frustrate the possibility of advantage being taken of our weaknesses, in so far as extradition is concerned, the following system has been inaugurated within this department:

"A copy of the fingerprints of the state agent proceeding to the city from which the prisoner is to be extradited is sent to the chief of police of that community, sufficiently in advance of the time of the arrival of the state agent. On the arrival of the state agent he identifies himself and is further identified by his fingerprints being compared with the copy previously forwarded.

"I believe the system as outlined above will prevent the possibility of any smart criminals impersonating any peace officers or state agent by forging documents, badges, cards or other means of identification, calling for and demanding a prisoner. While I have no knowledge of any attempt of this kind being made I feel that every possible precaution against clever criminals succeeding in such a coup should be taken.

"This system is being inaugurated in this department. Today one of our inspectors will leave for Portland, Oregon, for the purpose of returning a prisoner to this city. The agent has had his fingerprints taken on one of our form cards, to which he has registered his signature, which has already been sent to the chief of police there, with a suitable explanation to insure the identification at Portland, Oregon, of the extraditing officer when he makes a demand for his prisoner."

Chief of Police Quinn has suggested that possibly this procedure could be adopted to advantage by all police departments. His views are published herein for the information of law enforcement agencies. The Bureau at the same time desires to extend an invitation to other police administrators and officials having suggestions of a similar character who may wish to call them to the attention of their colleagues through the medium of this bulletin.

INTERESTING IDENTIFICATIONS

LOUIS PASTORE

RECIDIVIST USING FIFTY-THREE ALIASES ARRESTED EIGHTY-THREE
TIMES BY AUTHORITIES IN FORTY-NINE CITIES

When the fingerprints of Louis Pastore, which were received recently in the Identification Division of the Federal Bureau of Investigation from the State Police at Harrisburg, Pennsylvania, were searched against the fingerprint files of the Bureau it was noted that this individual has one of the most extensive records in the Bureau files. Pastore's criminal career commenced in the year 1906 when, at the age of eighteen, he was arrested five times by the Police Department in New York City on charges of grand larceny, robbery, disorderly conduct and as a pickpocket. From 1906 until the present time this person's criminal activities have caused his arrest on seventy-eight subsequent occasions.

A review of Pastore's record shows that he has been arrested in forty-nine different cities throughout this country and Canada. The extent and speed of his travelling while pursuing his criminal career are evidenced from even a cursory survey of his record. For example, in July 1926, he was arrested by the police at Seattle, Washington. On December 10th of that year the police at San Antonio, Texas, took him into custody on a charge of theft from persons. Approximately two weeks later he was under arrest by the police at Tampa, Florida.

It is understood that this individual's true name is Louis Pastore. However, the files of the Identification Division disclose that he has been known to police officials by fifty-three names in addition to his true name. Among the aliases appearing in his record are the following: "Boggie", "Gozzollo", "Dago Louie" and "Cockeyed Louie".

Although this person has been under arrest such an extraordinary number of times, in practically all cases small fines or minor sentences have been imposed. The most common charge against his record is that of pickpocket, and the usual penalty was a sentence of sixty or ninety days. The latest fingerprint card, however, which was received from the State Police at Harrisburg, Pennsylvania, indicates that he has been sentenced to a term of one to three years, commencing December 31, 1934, for the crime of attempted larceny.

The fact that Pastore was not discouraged from his criminal efforts by the numerous arrests is obvious in view of the record disclosed during 1934. In April of that year he was arrested by the Police Department in New York City for disorderly conduct and as a pickpocket. The Sheriff's Office in Newark, New Jersey, arrested him in August for larceny from person and he was given a two hundred dollar fine and sentenced to six months in jail. Apparently he was released prior to the natural expiration of this term, for he was arrested in New York City in October and sentenced to two months for disorderly conduct and as a "jostler" or pickpocket. The Police Department in Providence, Rhode Island, placed him under arrest in November as a pickpocket, and on December 19th he was arrested on a similar charge by the authorities in Elizabeth, New Jersey. The final episode of this banner year was his arrest by the Pennsylvania State Police as a result of which he received the sentence of one to three years set out above.

Although minor charges predominate in this person's record, the Bureau's facilities were obviously indispensable in that a central clearing house was provided whereby law enforcement officials in forty-nine cities were furnished information as to Pastore's extensive record and the numerous aliases that he had adopted.

TRANSMITTAL OF FINGERPRINTS TO BUREAU BY AIR MAIL ENABLES AUTHORITIES TO BE NOTIFIED OF ARREST OF FUGITIVE WITHIN ONE DAY FOLLOWING HIS ARREST IN WYOMING

An illustration of the value of forwarding fingerprints to the Bureau by air mail is found in the case of one Charley Rice, whose fingerprints were received in the Bureau on March 22, 1935, having been forwarded by air mail from the Police Department at Sheridan, Wyoming. This card indicated that Rice had been arrested by that Department on a charge of petty larceny on March 21, 1935, the day before his fingerprints were received in the Identification Division of the Federal Bureau of Investigation.

When Rice's fingerprints were searched against the files of the Identification Division it was found that he was identical with one Walter Davis, who was wanted as an escape from the State Penitentiary at Canon City, Colorado. He had been received at that institution in November, 1930, to serve a term of three to five years for grand larceny, and information was received in the Bureau on June 11, 1931, that he had escaped on June 7, 1931. Accordingly, at that time, a notice of his fugitive status was posted against his fingerprint record in the Bureau.

Shortly after this person's fingerprints were received from Sheridan, Wyoming, a telegram was dispatched to the authorities of the State Penitentiary at Canon City, Colorado, advising them of the fugitive's arrest at Sheridan on the day previous. Subsequent advice has been received that Davis was returned to the Colorado State Penitentiary on March 27, 1935.

The above case exemplifies very well the effective results that may be obtained by use of the air mail service. It has been pointed out in a recent issue of the bulletin "Fugitives Wanted by Police" that the Bureau has adopted the practice of using air mail in answering fingerprints in which identifications have been made on "arrest" fingerprint cards forwarded from the more distant points, and particularly by offices west of the Mississippi River. Moreover, regardless of the point of origin, when fingerprints are received by air mail or special delivery a similar medium is employed in answering these prints. Consequently, it is felt that, for the purpose of insuring the most expeditious action, it is desirable to utilize special mail service when forwarding any special matters to the Bureau.

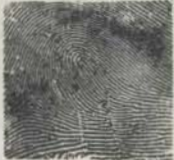

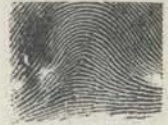

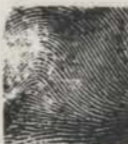
