The Division of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Division does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Division of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Division has investigative jurisdiction:-

National Motor Vehicle Theft Act

Interstate transportation of stolen property valued at \$5,000 or more

National Bankruptcy Act

Interstate flight to avoid prosecution or testifying in certain cases

White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Killing or Assaulting Federal Officer

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnaped

Extortion cases in which interstate commerce or interstate communication is an element

Theft, Embezzlement or Illegal Possession of Government Property

Antitrust Laws

Robbery of National Banks and Member Banks of Federal Reserve System

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property

Neutrality violations, including the shipment of arms to friendly nations

Frauds against the Government

Crimes in connection with Federal Penal and Correctional Institutions

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

Federal Anti-Racketeering Statute

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Division has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Division of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field Offices of this Division appears on the inside back cover of this bulletin.

On October 25, 1934, the Dedication Exercises for the new Department of Justice Building were held. The many distinguished guests attending included the President of the United States, Members of the Cabinet, the United States Supreme Court Justices, the Attorney General, the Solicitor General, and other officials of the Department and the Division.

Honorable Scott M. Loftin, President of the American Bar Association, in pledging the support of the Association and the public, said in part:

"Our National Government, through the initiative of the able and distinguished head of the Department of Justice, has demonstrated that a capably directed corps of honest, trained and determined officers, provided with the facilities which modern methods require, can and will detect serious crime and apprehend dangerous criminals.

"When necessary, they can and will exterminate groups of men who fatuously entertain the idea they can successfully defy government, terrorize communities and escape the consequences of their crime, take human life with impunity, kidnap, burglarize and rob in the foolish belief that crime can be made a profitable business."

The Attorney General, in his address, reviewed the history of that office and of the Department of Justice, pointing out that the Department, created as such in 1870, was dedicating the first real home it has ever had.

The new building, located on Constitution and Pennsylvania Avenues, between Ninth and Tenth Streets, contains seven floors with a total of twenty-three and one-half acres of floor space.

The office suites of the Attorney General and the Solicitor General, and the Department's Library occupy approximately one-half of the fifth floor, while the balance is occupied by the Division. The Director's suite of offices, the offices of the Assistant Directors and Inspectors, and the offices of all Administrative and Investigative Assistants in the Division, in addition to the Crime Statistics Section, the Division's training School and the offices of the local

Field office are also located on the fifth floor. On the sixth floor is located the Division's File Section, occupying approximately 20,000 square feet. The Division occupies the entire seventh floor which houses its Identification Unit, Single Fingerprint Section, Technical Laboratory, and Photographing, Photostating and Printing Section. The above Unit and Sections occupy a total of 72,000 square feet of floor space. In the basement of the building is a modern pistol range for the use of Division officials and employees.

For the first time all the Division's activities are housed under the same roof and I feel confident that this arrangement will enable the Division to better serve and render even closer cooperation to law enforcement officials throughout the country.

INTERESTING IDENTIFICATIONS

ESCAPED CONVICTS IDENTIFIED BY FINGERPRINTS WITHIN THREE WEEKS

On September 22, 1934, two fingerprint cards were received in the Division of Investigation from the Sheriff's Office at Winfield, Kansas, indicating that one Bert Pope and one Charley McClure had been arrested by the Sheriff on September 19, 1934, on bank robbery charges. When these fingerprints were searched through the Division's files it was found that Pope was wanted by the State Penitentiary, McAlester, Oklahoma. It was reported that he had escaped from that institution on September 7, 1934 while serving a term of 40 years for murder. It was also found that McClure had likewise escaped from the State Penitentiary, McAlester, Oklahoma, on September 7, 1934, where he had been serving a life sentence for murder under the name of Denzil Chastain. The Oklahoma authorities were advised immediately by telegraph of these identifications.

The above cases are illustrative of the effectiveness of the fingerprint method of identification and are especially interesting inasmuch as the identifications were effected less than three weeks after the individuals had escaped.

INTERESTING IDENTIFICATIONS

MISSING VETERANS IDENTIFIED BY
FINGERPRINTS DEFEATING PRESUMPTION OF DEATH

During the month of September, 1934, two interesting identifications were effected in the fingerprint files of the Division of Investigation which illustrate the value of this method of identification in other than criminal cases. On September 20, 1934, the fingerprints of a World War veteran were received in the Identification Unit of the Division of Investigation from the Veterans' Administration together with information that this individual was supposed to have been missing for more than seven years and that a claim was being made on the basis of his supposed death. Upon a search of the files of the Division, the fingerprints were identified as those of an individual whose extensive record included ten arrests in the years 1931 and 1932 in Kansas and California in addition to others dating as far back as 1920. On the occasion of each of the later arrests the veteran had given an alias. The latest record indicated the arrest of the veteran on March 16, 1934, at Oakland, California, where he was sentenced to sixty days in the county jail.

On the same day on which the fingerprints described above were received in the Division from the Veterans' Administration there were also received the fingerprints of another individual concerning whom a claim had been made alleging that the veteran had been missing for more than seven years. When these fingerprints were searched through the Division's files they were identified with those of an individual whose record showed several arrests in the years 1931 to 1934 in the State of New Jersey. The latest record reflected his receipt in the Essex County Penitentiary, Caldwell, New Jersey, on August 27, 1934, on a sixty day sentence which he was presumably serving at the time his fingerprints were received in the Division in connection with the current inquiry.

The identifications described above illustrate the value of this form of civil identification in assisting the Government in the defense of unwarranted claims as well as the location of missing veterans so interested relatives or friends could have knowledge of their whereabouts.

THE DEVELOPMENT OF LATENT FINGERPRINTS ON PAPER

Considerable attention has been given by the Technical Laboratory of the Division of Investigation to the study of the development of latent fingerprints appearing on paper. This research project is not complete but it is possible at this time to outline several processes which have been found satisfactory in making visible latent fingerprints several days to a number of weeks old. These do not necessarily involve newly invented formulae but are the results of checking, verifying, and experimenting with established practices in chemistry. The results will generally depend on the nature of the paper examined and will, of course, also vary to a lesser extent depending upon the chemical composition of the individual excretions making up the latent print and also depending on climatic conditions.

One of the most convenient methods found to develop latent fingerprints on paper when the latent prints are not older than six to ten days is to fume the paper in iodine gases. This is most conveniently accomplished by placing a number of crystals of iodine in an open evaporating dish and placing this dish in the bottom of a large glass container having an airtight cover. The iodine gases will in ordinary room temperature generate of their own volition and no additional heat is needed. Should the release of the gases be proceeding too slowly, however, the bottom of the container or of the evaporating dish may be gently warmed. The gases will be recognized by their violet color and as soon as the container has sufficient iodine vapor as indicated by the color, the document or paper upon which fingerprints are believed to appear is placed in the gas. The prints will become visible quite rapidly and the development may be viewed through the glass sides of the container. When removed from the gases the developed prints will be found to be quite fugitive and will disappear in ten or fifteen minutes, which, of course, necessitates the photographing of such prints for record purposes in the interim. Of course, the prints may be again developed after the gases have left by again placing the document in the fumes. With regard to photographing no difficulty has been experienced in the Division and photographs of prints so developed have been successfully made without the necessity of filters.

A method of fuming paper for the development of latent fingerprints so that the fingerprints are made permanently visible involves the use of osmic acid in a small evaporating dish containing absorbent cotton. A drop or two of 1% osmic acid is placed on the cotton and the evaporating dish placed in the bottom of a glass jar, the same as used for iodine fuming, the document then being placed within the jar. The fumes will generate of their own volition in normal room temperature. These fumes are obnoxious and should not be breathed. Development of fingerprints is somewhat slow and may take from one to twelve hours depending upon the age of the paper and other factors. The latent fingerprints developed are of a silver color, quite sharp in outline, and remain fixed or permanent.

Fingerprints on many kinds of paper under certain conditions may be successfully developed up to six months of age by treating the paper with silver

nitrate. The paper is allowed to float momentarily on a bath consisting of a 3% solution of silver nitrate, both sides of the document being treated in this manner. The moisture may then be removed with clean blotters and the paper exposed to a brilliant light, such as a 500 watt blue or daylight photographer's lamp, a mercury arc or carbon arc light. Where fingerprints have been deposited the silver chloride will darken and the prints will be made visible as dark brown outlines against the light background. The paper should be removed from the light as soon as the characteristic detail of the fingerprints has been sufficiently developed, otherwise the silver nitrate on the paper will continue to darken and the background contrast will be lost. Paper so treated will continue to slowly darken unless kept in absolute darkness which will serve to somewhat deter the darkening action. The stain, however, together with the fingerprints, of course, may be removed from the paper by immersing the document in a bath of 3% potassium cyanide. After such treatment the paper should be thoroughly rinsed to remove the cyanide and then dried. It must be remembered that potassium cyanide is a deadly poison and every precaution should be taken in its use to prevent accidents. It is also well to use care in the use of the silver nitrate as contact with the skin will leave brown stains which are not readily removable.
