The Division of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Division does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Division of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Division has investigative jurisdiction:-

National Motor Vehicle Theft Act National Bankruptcy Act White Slave Traffic Act Impersonation of Government Officials Larceny of Goods in Interstate Commerce

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnapped

Theft, Embezzlement or Illegal Possession of Government Property Antitrust Laws

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property Neutrality violations, including the shipment of arms to friendly nations Frauds against the Government

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Division has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Division of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field offices of this Division appears on the inside back cover of this bulletin.

DISPOSAL BY POLICE OF EXPLOSIVES

In the course of a series of conferences with members of the Metropolitan Police Department of Omaha, Nebraska, March 6 to 17, 1933, it was brought out that Police Officers may run across explosives, such as dynamite, blasting caps, nitro glycerine, war relics (shells, grenades, etc.) and bombs. The problem which arose was how to dispose safely of such dangerous explosives. Upon his return to Washington, D. C., Mr. C. F. Klinefelter, of the staff of the Federal Board for Vocational Education, who had conducted the conferences in Omaha, interviewed Dr. C. E. Munroe, Chief Explosives Chemist, Explosives Division, of the U. S. Bureau of Mines, with reference to the problems presented. During the conversation with Dr. Munroe, he made the following points:

- 1. SAFEST DISPOSAL. The safest disposal of explosives such as powder, dynamite, blasting caps, and nitro glycerine is to <u>put them to legitimate use</u>. When the Police come into possession of explosives, they should, first of all, endeavor to find some reliable explosives man, blasting expert, or construction contractor whom they can trust to use the explosives in his regular work. A contractor who is blasting with dynamite, can dispose of old or partially decomposed dynamite by mixing it with the charges of his own regular supply, the good dynamite exploding the bad.
- 2. DYNAMITE. If occasion arises where the police must dispose of dynamite, themselves, the safest procedure is to burn it, under proper precautions.

Some suitable place should be chosen, out in the open, where a barricade of earth, timbers, etc., can be thrown up to protect the officers who are burning the dynamite, in case any explosions do occur.

If the dynamite is in boxes, it should be removed from the boxes and be burned separately from the boxes.

One should never attempt to burn dynamite and boxes together. The nails in the boxes become heated quickly and if hot metal comes in contact with dynamite, it will cause it to explode. The box also, of itself, partially confines the dynamite, which greatly increases the hazard if an explosion occurs. Dynamite boxes, if nailed shut, should be opened by the use of wooden wedges and a wooden mallet.

In proceeding to burn the dynamite, the cartridges or sticks should be opened and the dynamite spread out thin on the ground. In opening the cartridges or sticks, care should be used to prevent the dynamite getting on the bare hands in order to guard against the danger of nitro glycerine poisoning.

With the dynamite spread out thin, it may then be sprinkled lightly with kerosene (coal oil) and set on fire with a train leading from behind the barricade at a safe distance. The train is made of rolled up newspapers, wet with kerosene.

In arranging train, consideration should be given the wind so that the fire will be carried toward the dynamite from the person behind the barricade.

The boxes, if any, should be set on fire and burned from behind the barricade in like manner, by themselves. Even so, there is a definite hazard of explosion in burning boxes, due to the dynamite having soaked into the wood, hence the full protection of the barricade must be used.

- 3. BLASTING CAPS. Blasting caps, (dynamite caps or detonators), are especially hazardous, due to the fact that they are a constant potential menace until actually destroyed, and because their bright shiny appearance makes them most alluring, not only to children but to many adults as well. The only safe way to dispose of them is to burn them out in the open, from behind a barricade at a safe distance, out of range of flying particles of metal, using the same general procedure as in burning dynamite, but even greater precautions.
- 4. NITRO GLYCERINE. Nitro glycerine should <u>Never</u> be poured down a toilet or sink. As it is much heavier than water, it will stay in the trap and not be carried through by flushing with water, and might be set off at any time through sudden shock or jarring.

The proper way to dispose of it is to chemically decompose it with an alcoholic solution of sodium sulphide, mixed according to the following proportions:

One-half gallon of water
One-half gallon of methanol
Two pounds of sodium sulphide.

In a case described by Captain Robert Munch of the Omaha Police Department, detectives found a safe with outer door blown, but inner door still charged with nitro glycerine. (The second charge had not gone off as a wet mattress hung over the safe to deaden the sound had extinguished the fuse.) The charge of nitro glycerine was dissolved out by the detectives with the use of denatured alcohol. Dr. Munroe stated that this was a proper procedure to use under the circumstances, provided that a large quantity of alcohol was used in diluting and dissolving the nitro glycerine.

He emphasized however that where the nitro can be handled in bulk, as in bottles or other containers or where spilled in the open as on floors, where it can be washed down, the safest and best procedure is to chemically decompose it by using the sodium sulphide solution.

5. WAR RELICS AND BOMBS. The safest disposition by the police of war relics and bombs is to sink them in the river in some deep hole, if possible. A second choice would be to bury them deep in the ground, but here they would constitute a potential menace or hazard, as excavating operations might bring them to light at some future time.
