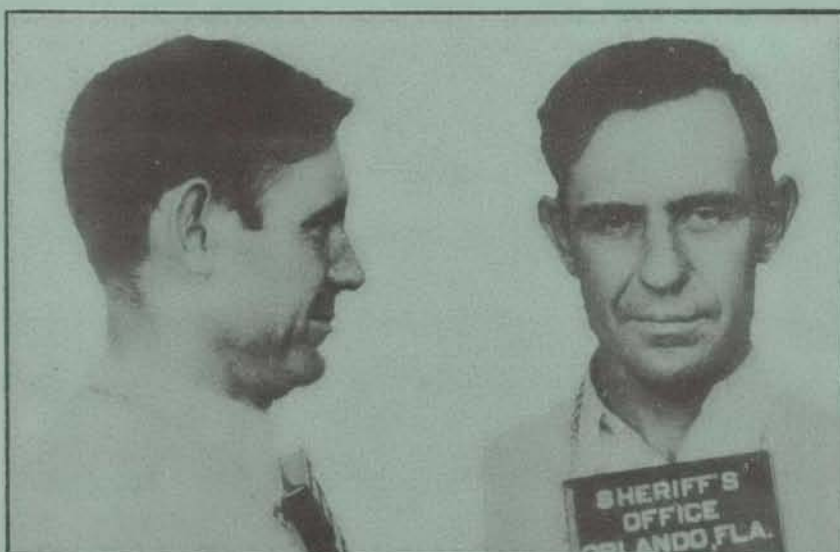

The Federal Bureau of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The following list indicates some of the major violations over which the Bureau has investigative jurisdiction:-

National Motor Vehicle Theft Act
Interstate transportation of stolen property valued at \$5,000 or more
National Bankruptcy Act
Interstate flight to avoid prosecution or testifying in certain cases
White Slave Traffic Act
Impersonation of Government Officials
Larceny of Goods in Interstate Commerce
Killing or Assaulting Federal Officer
Cases involving transportation in interstate or foreign commerce of any persons who have been kidnaped
Extortion cases in which interstate commerce or interstate communication is an element
Theft, Embezzlement or Illegal Possession of Government Property
Antitrust Laws
Robbery of National Banks and Member Banks of Federal Reserve System
National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds
Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property
Neutrality violations, including the shipment of arms to friendly nations
Frauds against the Government
Crimes in connection with Federal Penal and Correctional Institutions
Perjury, embezzlement, or bribery in connection with Federal Statutes or officials
Crimes on the high seas
Federal Anti-Racketeering Statute
The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Bureau has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

The Bureau does not have investigative jurisdiction over the violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

Law enforcement officials possessing information concerning violations over which the Bureau has investigative jurisdiction are requested to promptly forward the same to the Special Agent in Charge of the nearest field office of the Federal Bureau of Investigation, U. S. Department of Justice. The address of each field office of this Bureau appears on the inside back cover of this bulletin. Government Rate Collect telegrams or telephone calls will be accepted if information indicates that immediate action is necessary.



The Identification Division of the Federal Bureau of Investigation through the cooperation of contributing law enforcement agencies has developed the greatest compilation of criminal data in the world. The facilities of this vast clearing house are well realized by peace officers throughout the country who daily avail themselves of the aids offered them.

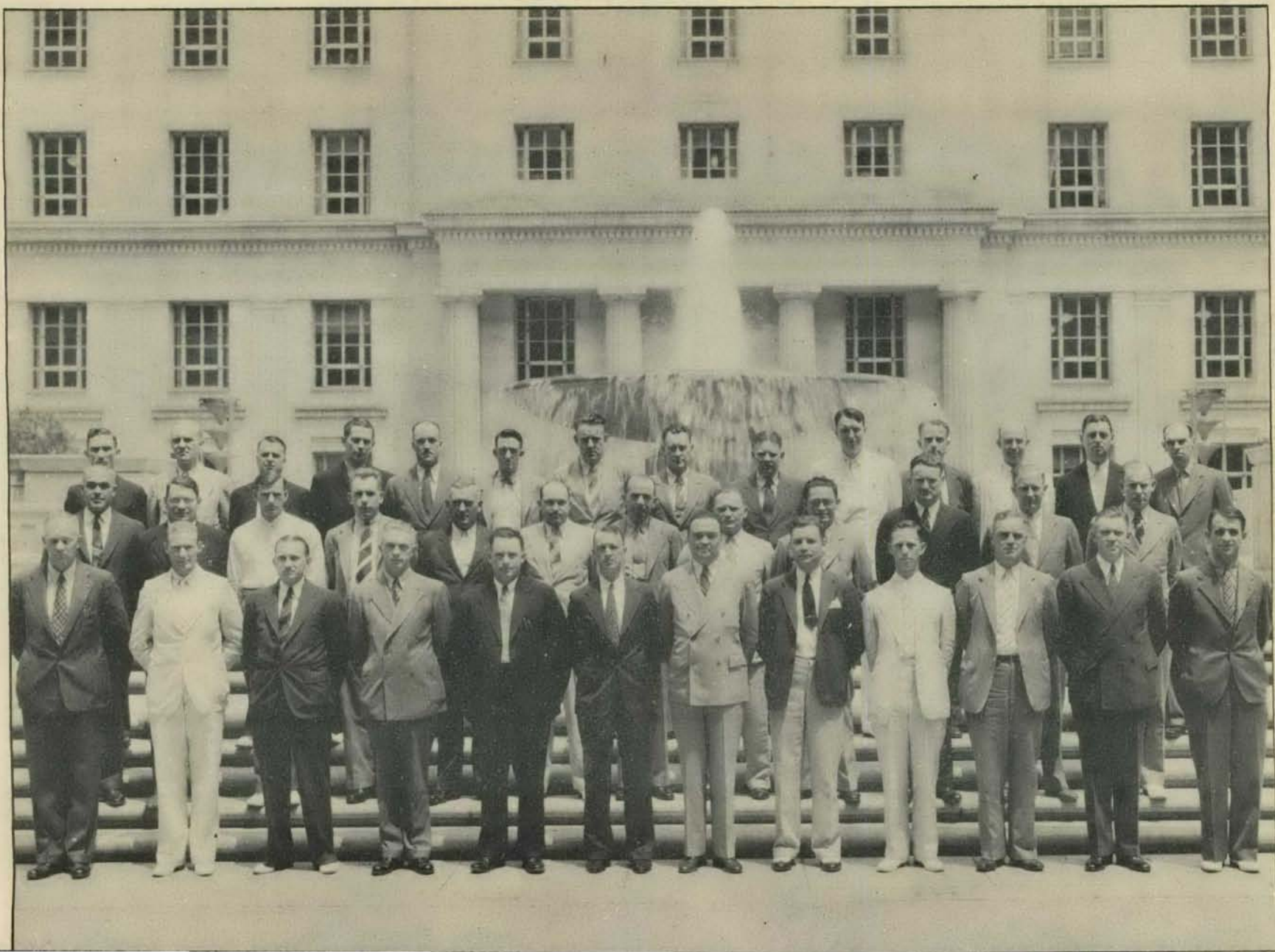
The centralization of records makes available a positive source of information relative to the identity and past activities of an individual in custody. This information is of immediate importance to an inquiring law enforcement agency and it is, therefore, necessary that the data contained in the files be transmitted to that agency immediately. In an effort to expedite the receipt of information desired in any case many law enforcement officers make use of air mail facilities.

It is the earnest desire of the FBI to furnish the best possible service in connection with such cases since it is realized that speed is essential, and I would, therefore, like to invite the attention of those departments which are not using the air mail to the possible desirability of forwarding certain records of an emergency nature to the FBI in this manner.

The transmittal of prints by the air mail expedites their arrival in Washington. Further, the use of special delivery postage insures delivery by the Post Office Department at night, on Saturday afternoons, on Sundays, and on holidays. Air mail postage without special delivery postage does not guarantee delivery after regular postal service hours. It is to be noted in this connection that all fingerprints received in the Identification Division, regardless of their point of origin, are answered by the Identification Division in the same manner in which they are received, i. e., prints received by air mail are answered by air mail and those received by special delivery are answered by special delivery. The Bureau in each instance provides for the return postage. It is felt that it would be desirable to forward any special matters by special mail to the Bureau. Such action with the aid of the reply in like manner would insure the most expeditious handling.

ANNOUNCEMENT--22D ANNUAL CONVENTION
INTERNATIONAL ASSOCIATION FOR IDENTIFICATION

Dallas, Texas, July 13, 1936.

My dear Mr. Hoover:

I am very gratified to know that you hope to be able to so arrange your commitments that you will be enabled to address the 22d Annual Convention of the International Association for Identification to be held in Dallas, Texas, from September 28 to October 1st, in the Adolphus Hotel.

Your presence, with one of your usual fine papers, will act favorably toward increasing interest in the enforcement of the law and in the program of crime prevention in this and other Nations. As you probably know, the Dominion of Canada, the Republics of Mexico and Cuba will be represented by outstanding officials of these countries. Many other fine speakers of the United States will be in attendance. We have assurances from several of the most capable criminologists in this country of their intentions to attend this meeting. Our President, Franklin D. Roosevelt has been asked to prepare a message over his signature to be read at the convention. Inspector E. A. Parker of Memphis, Tennessee, will have a most interesting exhibit of equipment and enlarged photographs of criminal cases.

There will be an elaborate entertainment program carried out in addition to the usual business activities of our annual meeting. Texas has a twenty five million dollar Centennial Exposition in Dallas with the most unique Lighting effect of any exposition to offer, in addition to routine convention entertainment. Sue Hastings will give a special showing of her marionettes in Chrysler Hall for our group, on IAI day at the Exposition. A luncheon, a banquet and the usual refreshments will be enjoyed by all. The ladies' program will, I believe, excell those of the conventions in the past.

A headquarters building is being maintained in the Centennial Exposition grounds for the use of Texas Rangers. Adjoining this building there is a replica of the "Law West of the Pecos." The Court is re-enacted on the front porch in the traditional manner.

May I request that if consistent with the policies of your Bureau the contents of this letter be reproduced in the next issue of the FBI Law Enforcement Bulletin.

ADDRESS OF HONORABLE JOHN EDGAR HOOVER, DIRECTOR,
FEDERAL BUREAU OF INVESTIGATION, AT OPENING OF
THIRD SESSION OF FBI NATIONAL POLICE ACADEMY,
JULY 20, 1936.

I just wanted to say a few words of greeting to you police officers who have come here this morning to attend the Third Police Academy of the Federal Bureau of Investigation.

I think it is needless for me to point out the opportunities which face you here in the matter of obtaining information which may be of assistance and help to you when you go back to your organizations. We do feel that we have some information, some training, some instruction, which will be helpful in your work in the future.

However, I do want to point out this morning that we do not expect to here make you police officers. You are already that. This is really a training school of police instructors. It is particularly gratifying to look back to the first and second Police Training Schools that were held. A year ago this month the first school of its kind ever held in this country convened here at Washington. That was followed five months later by the second school. Out of those 48 officers, 38 of them are today instructing in their individual police departments their own men in advanced methods of crime detection.

I think it is well-recognized in the field of law enforcement that it is no longer brawn that counts, but it is to a great extent brains, plus a proper proportion of brawn. I feel that you gentlemen here this morning have the opportunity before you to acquire in the next three months that you are with us all the information you can concerning scientific crime detection work, so that you, in turn, can go back to your respective communities as instructors and as missionaries of good will.

We hear a great deal in the public press from some misinformed speakers about a national police force. I think it is pretty well established by those of us who have been in law enforcement work for many years that such a suggestion is entirely unfounded in so far as its workability is concerned. This country has no place for a national police organization, and certainly those of us in the Federal Bureau of Investigation distinctly understand its impracticability and the fact that it would not work in these United States. The only kind of system that has ever worked in law enforcement, in our observation, has been one where you can get the local law enforcement agencies working shoulder to shoulder with each other, and they in turn with the Federal agencies. That is what we are trying to do in the FBI and what we hope to accomplish, in a larger measure, through training groups of this type.

While we are glad to have you come here and glad to make available to you all of the facilities of our Bureau for training and instruction, a more important element, in my personal opinion, is that we will get to know you and you will get to know us. You will learn that we are not a bunch of "stuffed shirts," that we have much to learn in the Federal Bureau

of Investigation, and that we will continue to learn as time goes on. We will get to know your problems. I want you gentlemen who are to participate in this training course to feel that it is an open forum. No lecturer who comes before you comes before you without the distinct understanding that he must answer all and any questions that you propound. I want you to feel free to ask questions of all lecturers who come upon this platform. I want you to enter into a full and free discussion of all your problems, not only for your individual benefit, but for the benefit of the other men here with you and for our benefit.

From the last two training schools of this type, we of the Federal Bureau of Investigation have learned a great deal. We have learned many of the problems with which you are faced, of which we have had no cognizance. As each group comes in to us, we will continue to learn, and you in turn will learn also from our discussions. I want you to therefore approach these next three months with this attitude in mind.

I do want to also point out to you another factor. You are here for three months of intensive training and intensive study. It is not a soft job; it is not a vacation. The men who appear here this morning have been carefully selected. You are representing something more than your own individual self. Each one of you comes as a representative of an efficient, outstanding law enforcement organization. Therefore, you come here to carry forth the traditions and prestige of your own department. You come, I believe, willing to sacrifice a great deal in the way of time and effort and energy in order to carry back to your department something which you in turn can give to them. In one of the previous schools, I believe, some criticism was made at the end of it because the work was too hard. I don't think that type of criticism comes with good taste from any law enforcement officer. Those of us who are dedicated to the work of law enforcement know when we enter it, or at least we should know, that we are to give our life and our time and every bit of energy that is in us for the proper carrying on of that work. You gentlemen this morning are coming for three months of a hard, stiff grind, but it is a grind for the purpose of enabling you to go back and carry on a real crusade with an idealism and an enthusiasm without which law enforcement cannot succeed. And so I do want to urge that you approach it with that attitude in mind.

I know that when you leave here three months from now, you will of course have a broader scope in your work; you will have acquired some information which will be helpful to you. But you are going to go back, I hope, to carry on, as I have said, a crusade. You are going to be faced with all kinds of obstacles. You have already been faced with many. But you are going to have the obstacles of crooked politics to contend with; you are going to have the obstacles of shyster lawyers to contend with; you are going to have the obstacle of jealousy within your own department to contend with, because you are blazing a new trail; you are going to have criticism directed against you. The only suggestion which I can offer to you along that line is to approach your work with a clear conscience, and with energy and vigor, so that you can carry back that idealism and that enthusiasm which is necessary; then no obstacle, irrespective of what it is, can permanently block you. For that reason, I do want to urge that the next

three months be dedicated to a real, serious, diligent application upon the part of each and every one of you.

We want to get to know you intimately and personally while you are here. I am particularly proud of the thought and the knowledge that those other 48 men who came from the various police organizations of the country in the last two training schools are constantly in touch with us, writing in informally and telling us of their problems, their trials and tribulations, of their disappointments, and of their advancements. Most of them have gone ahead to higher positions in their departments. All of them are fighting a great cause, and you gentlemen coming in are to augment that group.

We want you to feel that we are here for the next three months to help you, to know you, so that you will go back, not only as collateral aids of the Federal Bureau of Investigation in its work, but as personal friends of each and every one of us.

I thank you sincerely.

NATIONAL STOLEN PROPERTY FILE

The Federal Bureau of Investigation desires to express its pleasure at the enthusiastic support which the National Stolen Property File has received from the law enforcement officers of the entire country. The Bureau is pleased to announce that it is now recording descriptive data concerning stolen property at the rate of approximately 2,000 such descriptions each and every week. It is expected, of course, that marked further progress will be made as soon as the practical value of this plan becomes obvious to law enforcement officers and organizations everywhere.

As an instance of the law enforcement value of this national repository for information relative to stolen property, the following case is cited: Early in April of this year over \$20,000 in securities were stolen from a large bank in a southern section of the country. Investigative efforts failed to disclose any definite clues, but descriptive data relative to these stolen securities were recorded in the National Stolen Property File. Approximately a month later an inquiry was received from a New England source concerning certain securities, and a search of this file disclosed that these were, in fact, the same securities as those stolen from the southern bank. This is only an instance of the accomplishments which can be attained by the widespread extension of the National Stolen Property File to include a substantial portion, at least, of the thefts of this type occurring in this country. More and more will the Bureau be able to afford similar assistance in identifying stolen property as its files continue to receive information of the theft of property valued at \$5,000 or more or possessing definite descriptive data, such as serial numbers.

NOTICE TO CONTRIBUTORS OF FINGERPRINTS

The Bureau, in an effort to withdraw the fingerprint cards of deceased persons, which no longer serve a useful purpose, from the files of the Identification Division, requests the cooperation of all law enforcement agencies to furnish information in connection with cases of this type. As you are aware, this Bureau furnishes "Record of Death" forms upon request to contributors to be used in reporting the death of persons who have previously been fingerprinted by them and whose prints were forwarded to the Bureau. The form provided is reproduced below:

Full cooperation in forwarding these notifications to the Bureau will be appreciated and will be of great assistance in removing inactive records from the files of the Identification Division, thereby reducing the number of fingerprint cards in some of the groups which are growing quite rapidly. In the event forms are not available regular fingerprint cards with a single impression and a statement to the effect that the subject is deceased will be sufficient.

"FLUORESCENT PHOTOGRAPHY OF LATENT FINGERPRINTS"

Under date of October 16, 1933, the Federal Bureau of Investigation distributed to law enforcement bodies an article by Detective Inspector Alan Evans of the Derbyshire, England, Constabulary, in which a process for the photography of fingerprints on multi-colored objects was described. Inspector Evans' technique, as outlined in this pamphlet, called for the use of anthracene as a developing powder, filtered ultra-violet light as the illuminating source, and a lead glass filter on the camera to eliminate the ultra-violet and near ultra-violet rays reflected from the object.

This announcement added a valuable technique for the use of the fingerprint man in difficult cases, but actual application of the method revealed that it has certain defects. While anthracene is an excellent fluorescent material, its physical properties are not the best for dusting purposes. Anthracene powder tends to clump and lacks the tenacity of other materials commonly used as fingerprint powders.

Recognizing the merit of fluorescent photography as a means of recording latent fingerprints, the Pasadena Police Department Identification Bureau staff has conducted, during the past few months, numerous experiments in an effort to overcome the difficulties that have become apparent through actual application of the method. The results achieved to date by no means are complete and final; much exploratory work remains to be done. Certain findings, however, are presented in this paper in the hope that they may be of assistance to other investigators in the same field, and that they may evoke discussion, criticism, and suggestions that might be helpful to us as we continue this study.

Thus far, effort has been directed along two lines. First, to discover a substance with fluorescent qualities similar to anthracene, and, at the same time, physical and dusting properties equal to commonly used powders. Second, to develop a single universal powder satisfactory for photography, both in the ordinary manner and by ultra-violet light. In this latter connection we were, of course, also interested in obtaining information respecting filters, films and exposure times yielding best results.

A review of existing data on the fluorescent efficiency of various materials showed the uranyl salts to offer promising possibilities. Of the salts tested, uranyl phosphate gave the most brilliant fluorescence under ultra-violet excitation.

Uranyl phosphate is a lemon-yellow compound of uranium which fluoresces a brilliant yellow-green, slightly stronger in the yellow than anthracene. Its physical properties were found to be very satisfactory and far superior to anthracene. A considerable quantity of the phosphate

was prepared for our experiments by sieving the powdered substance through a hundred-mesh screen, thus producing a fine, dry, fairly heavy powder that did not cake but rather behaved very much as mercury and chalk when applied to latent fingerprints. Over a considerable period of time it did not absorb moisture to any appreciable degree.

A visual comparison of uranyl phosphate and anthracene indicated the intensity of the fluorescence from both to be very similar. Photographic tests with various films and filters revealed, however, that anthracene produced a slightly denser image on the negative under identical conditions of illumination. This difference is perhaps caused by the difference in the color of the fluorescence of the two substances, the photographic materials being less sensitive to the deeper yellow of the uranyl phosphate. This difference, however, was not serious in view of the greatly superior physical properties of uranyl phosphate.

Following this we made various mixtures of anthracene and of uranyl phosphate with various commercial fingerprint powders, chalk, acacia, lamp black and other materials. A universal powder, we felt, would be of value because it would give the fingerprint man two alternatives. If poor contrast or a mottled background presented difficulties in photographing the print by usual methods, he could immediately resort to the fluorescent method. It was found that uranyl phosphate mixed well with commonly used powders and in no way reduced their good dusting qualities. The same was also found to be true of anthracene. Of course, the addition of fingerprint powder to the fluorescent materials cuts down their brilliance to varying extents. There was, however, one exception that should be noted. A mixture of anthracene and pulverized blackboard chalk gave a greater brilliance than pure anthracene alone. This mixture, however, proved to be very poor in dusting quality. Further experimentation may provide a remedy for this condition.

The above findings, particularly the excellent physical properties of uranyl phosphate and the superiority of the fluorescent properties of anthracene, led us to try mixtures of the two. The result was a grayish yellow powder that had a fluorescence very similar, visually and photographically, to pure anthracene alone. Instead of the brilliance of anthracene being dulled by a non-fluorescing material, in these mixtures it was maintained to its original degree by the uranyl phosphate. A particular mixture which we made of about two-thirds anthracene and one-third uranyl phosphate, moreover, possessed excellent dusting qualities.

Finding this powder to perform to our satisfaction, we subsequently applied it in a number of photographic tests with a variety of filters. Spectrum charts were employed for color standardization.

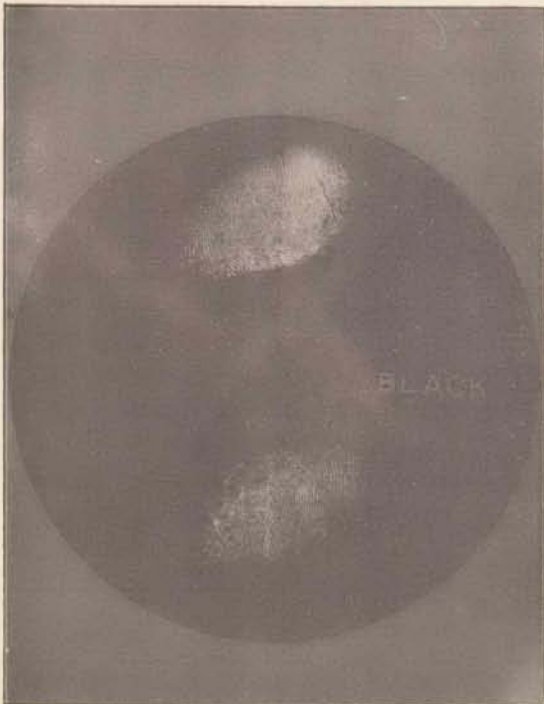
Protex lead glass being the only filter mentioned in Inspector Alan Evan's article, we requested Eastman Kodak Company to furnish us information regarding filters more suitable for the purpose. They informed us that the Wratten filter, Series 2A, would perform as well as the Protex filter. In our first series of tests, it became evident that the 2A filter would permit a considerable amount of the white background to affect the photographic plate. Although this might not often be a seriously dis-

turbing factor in those cases where the maximum of contrast was required it certainly would cause trouble. Evidently some other filter should either replace or be added to the 2A for achieving the very greatest contrast. By experiment we found the addition of a Wratten B filter to the 2A to be extremely effective. Thus, with the combination of the 2A with the B filter, fingerprints appearing on colored or reflecting surfaces could be photographed with the assurance that the backgrounds would be practically completely eliminated. Data showed, however, that to achieve this desired result, an exposure increase of some twenty-eight times that of a single 2A filter would be needed. In some cases this might turn out to be an excessively long exposure. In an attempt to shorten the exposure time, we turned to a combination of two 2A filters. Colored and white backgrounds were found to be highly suppressed without increasing to any significant extent the exposure time over that of a single 2A filter.

The results of our experiments can be expressed in a few words. A double-purpose dusting powder suitable to ordinary photography as well as photography by ultra-violet illumination has been prepared. Filters suitable to various types of backgrounds have been examined. Any one filter is not necessarily best for all possible subjects. Thus in describing their applications, subjects might, for simplicity, be divided into three groups. Subjects made up of the darker colors with no white present may be photographed through a single 2A filter. Objects of many colors but with a small amount of white might require a double 2A filter. White and reflecting surfaces like tinfoil would probably require the combination of the 2A plus the B filter.

It is, of course, understood that to achieve the best results with the methods we have described, the operator should possess a portable, well-filtered ultra-violet lamp which can be brought within a few inches of the area being examined without interfering with the manipulation of the camera. For reasons which need not be explained here, best results will be achieved with Commercial Ortho or similar film. With practice it is felt that even an investigator who has never used this technique should quickly achieve good results.

FOREIGN FINGERPRINT CONTRIBUTORS

There are at the present time seventy five foreign countries co-operating with the Identification Division of the FBI in the International Exchange of fingerprints.

The two latest countries to become contributors are Costa Rica and British Guiana.

FBI TECHNICAL LABORATORY ASSISTS IN NUMEROUS POLICE CASES

It has been gratifying to note the frequency with which the various state, municipal, and county law enforcement agencies throughout the country have consulted with the Bureau in connection with difficult problems in cases under their investigation involving evidence which required the expert scrutiny of laboratory technicians. The Bureau has been more than pleased to make available to these various police agencies the full facilities and the experienced staff of its Technical Laboratory located in Washington, D. C.

During the fiscal year ending June 30, 1936, out of a total of 3,495 examinations of evidence conducted in this Laboratory, a total of 583 of such were made at the request of and for the benefit of investigating agencies other than the FBI itself. This assistance was rendered to investigators in all parts of the country and wherever the local prosecuting officials deemed it advisable the Laboratory technician who made the examination gave testimony in the state courts in support of the opinions which he had rendered in the case to the police authorities. Usually such assistance is sought because the police or prosecuting officials handling the case do not have adequate laboratory facilities available within their own departments and fully appreciate the necessity of the proper appraisal of such evidence by qualified experts. On other occasions, however, the advice and opinions of the FBI Technical Laboratory have been requested by organizations having qualified laboratory technicians on their staff, in such instances the desire being to confirm and check their own findings, or perhaps to obtain an opinion in a matter which because of extraordinary complications they preferred not to reach a definite and final conclusion thereon until the advice of other experts with more experience had been obtained.

The examinations made were widely varied in kind. They constituted examinations of questioned documents, including anonymous extortion, or threatening letters, suicide notes, alibi letters and entries in records, as well as all kinds of forgeries and fraudulent documents; microscopic examinations of debris, hairs, fibres, and the like found at the scene of crime or concerned with the investigation; chemical analyses of various kinds, including the examination of blood stains for the determination of species origin and subsequently type grouping; the study of firearms evidence, particularly the expended projectile and exploded cartridge case for the purpose of determining the weapon from which such evidence was fired; the deciphering of coded messages; geological and petrographical examinations; metallurgical analyses; spectrographic analyses; reproductions in moulage and many studies of a miscellaneous nature.

In addition to having its highly trained and experienced staff of technicians, the FBI Laboratory has assembled a number of remarkable reference collections which frequently facilitate rapid and positive identification of unknown evidence material submitted with a view to determining the type. 1800 samples of different types and sizes of small arms ammunition have been assembled and 311 firearms of different kinds have

been collected for test purposes. A total of 1900 automobile tire tread designs are arranged in a reference collection in order that automobile tire marks left at the scene of crime may be readily identified as to kind. Typewriting standards have been collected on all makes and models of currently used machines and a total of 633 different standards of these various models are available. In a special index file there have been assembled over 36,000 descriptions of watermarks used to brand paper by the manufacturers. Other detailed collections of a similar nature assembled as a result of previous experiences in the scientific examination of evidence supplement the above.

Demonstrative of the wide field of service offered by the laboratory several cases have been chosen particularly to emphasize the possibilities in other than the more commonly known types of examination such as document, handwriting, and ballistic examinations:

Clay Hoke, two and a half years old, was the victim of a hit-and-run driver in Albemarle County near Charlottesville, Virginia on May 9, 1936. The Commonwealth's Attorney sought the assistance of the Bureau to the extent of examining hair specimens taken from the door hinge of an automobile supposedly operated by one Earl Nightingale on the day of the crime. In his letter the prosecutor advised that the child was then suffering from a fractured skull and recovery was not certain and that aggravating circumstances attended the crime. The Bureau's Technical Laboratory experts were able to report that the hair specimen of the victim was similar to the hair removed from the door of the automobile in so far as color, fineness of scale structure, thickness of cuticle and cortex, diameter of medulla and distribution of pigment and air cells were concerned and this information was telegraphed to the prosecutor. In response to the Commonwealth's Attorney's request, the Bureau's Laboratory expert who made the examination proceeded to Charlottesville, Virginia on June 12, for the trial of Nightingale in the State Courts. He testified that although generally it was not scientifically possible to identify two strands of human hair as having come from the same head beyond any question of doubt, nevertheless this case presented such marked similarities in various comparable factors, that not only could the hair have come from the same head, but it was most reasonable to conclude that it did.

The prosecuting attorney has since advised the Bureau that not only was the testimony of the Laboratory expert favorably received by the Jury, but the presiding Judge expressed satisfaction with the analysis and subsequent testimony of the expert. The defendant was convicted on the hit-and-run charge and sentenced to two years in the penitentiary.

The scientific examination of evidence uncovered during a criminal investigation, as stated before, should be arranged for by the investigators as a necessary part of their procedure. However, in the event that an examination is overlooked during the preliminary investigation or in the event a sudden turn of events during the course of the prosecution of the criminal defendant brings new evidence to light, it is still possible in many instances for the skilled technician of the crime laboratory to be of tremendous assistance to the prosecution.

There was received in the Bureau on June 25, 1936 a special delivery letter from Nicholas F. Nolan, Prosecuting Attorney of Dayton, Ohio, advising that he was then engaged in the trial of one Charles Rickman charged with murder. The prosecutor had learned that the defense counsel planned to introduce letters purported to have been written to the wife of the defendant by the murdered victim before his death. The letters were coached in affectionate terms and the prosecutor suspected that they might be forgeries. Reproductions of these letters together with samples of the known handwriting of the murdered victim accompanied the cover letter and the assistance of the Bureau's Technical Laboratory was requested. Three document experts of the Bureau, each working independently, reached the conclusion that the writings were not those of Loy Bodine, the victim. On receiving this report on June 26, 1936, the prosecutor immediately wired the Bureau and asked if a Bureau expert could immediately proceed to Dayton and substantiate these findings before the trial ended. One of our document examiners was instructed to respond to this request and arrived in Dayton in time to take the stand as the last rebuttal witness for the prosecution. A telegram has been received from Prosecutor Nolan, "Thanks to you verdict guilty murder first degree with mercy."

One morning the officials of the Sweet Clover Dairy Company on entering their premises discovered that all that was left of the safe which had been in the office the night before was a battered dial and a brass knob, which clearly showed indications of having been battered off of the safe. The remainder of the safe had been removed from the premises. Members of the Police Department at Wooster, Ohio, later found the safe about two miles from town. The door had been pried loose and, of course, the contents were missing.

When Harry Pinnick, Archie Dye, and Alonzo Mays, three men then on parole, and Edward Rowland were questioned in connection with this robbery, the police officers found a large pair of pinchers, a drift punch, and several other tools in the rear seat of the automobile in which they were apprehended. The officers on looking at the pinchers found in the automobile recalled that there were some very peculiar marks on the dial and the brass knob which might have been made by the pinchers. Accordingly, this material, together with scrapings from the fingernails of Harry Pinnick and bits of paint removed from the safe, were transmitted to the Technical Laboratory of the Federal Bureau of Investigation for examination purposes.

A microscopic examination of the pinchers revealed peculiar defects in the cutting edge of the tool which matched the markings found on the brass knob and the dial of the safe, thereby indicating that these marks had been made by the pinchers submitted. Similarly, a microscopic examination of the scrapings from the fingernails of the subject Pinnick revealed fragments of paint which were found to be similar to the paint taken from the safe door. The identification of the metal markings was illustrated by the use of two microphotographs enlarged 400 times, one showing a comparison of the test specimen with the dial of the safe, and the other a comparison with a test specimen of the brass knob removed from the safe.

The examiner who effected the identifications furnished testi-

mony at the trial of this case on Tuesday, June 2, 1936. The jury returned a unanimous verdict of guilty on all defendants.

Occasionally the examination of evidence in the Technical Laboratory results in such essential information that the crime under investigation is immediately solved. More often, however, the study of the submitted evidence in a case under investigation discloses pertinent accurate information which could not be determined without the aid of skilled technicians and which information, together with other pertinent facts developed by the field investigator, results ultimately in the solution of the crime.

Police authorities of the various states, counties, and municipalities confronted with problems of an unusual nature involving evidence collected in criminal investigations conducted by them and who do not have available within their own departments adequate facilities or qualified technicians to study and appraise such evidence, are invited to make use of the facilities of the FBI Technical Laboratory. Such evidence may generally be forwarded by registered mail or express depending on the bulk and should be accompanied by a letter outlining in detail the nature of the evidence, the information desired or kind of examination being sought, and pertinent data concerning the names of the victims and suspects involved in the crime. There is no charge to the requesting department for utilizing these laboratory facilities and the FBI is pleased to offer them as a reciprocity for the excellent cooperation obtained by the Bureau's representatives in the field from the police authorities of the country.

POLICE MANUALS

During the past year the Federal Bureau of Investigation has collected a total of 206 manuals from police departments in cities which are divided by population as follows:

1,000,000 and up	- 3
500,000 to 1,000,000	- 7

50,000 to 100,000	- 49
25,000 to 50,000	- 93

These manuals are maintained as a part of the FBI Training School facilities, thus affording members of the FBI National Police Academy an opportunity to use them as a reference guide in the preparation of a manual for their own department, if they so desire.

The collection also includes the manuals from 13 state police and state patrol organizations and is believed to be the most complete set of police manuals in this country.

IDENTIFYING UNKNOWN DEAD BY FINGERPRINTS

In the May 1, 1936, issue of the FBI Law Enforcement Bulletin there was given an account of an unusual identification made possible by fingerprints in the case of a skeleton found in the High Sierras of Yosemite National Park, California. In that case although the body had lain over five months, exposed to animals and the elements there remained sufficient flesh on the hands to obtain fingerprints after a rejuvenation, through soaking the hands in a strong caustic solution.

Recently Captain J. M. Keeley of Troop G, New York State Police, Troy, New York, through Sergeant W. E. Cashin, Identification Officer of that troop, brought to the attention of the FBI an equally interesting case of identification by fingerprints when it would have been impossible to determine the individual's identity by other means.

This identification concerns an unidentified white man found floating in the Hudson River, on August 4, 1935, at a point about four miles south of the city of Rensselaers. It was estimated that the body had been in the water from three to four weeks. The descriptive data, based upon appearances only, sent out at the time over teletype was that the person appeared to be 40-45 years of age, 5' 9", 160 pounds, black hair, left eye entirely gone and right eye bulging from the socket. The epidermis on the left hand was entirely gone and an identification seemed rather remote.

An examination of the fingers by Sergeant Cashin disclosed that there was a possibility of obtaining legible fingerprints photographically and it was deemed advisable to amputate the hands at the wrist for this purpose. The hands were taken to Troy where they were dried to some extent by the use of ether. Examination of the shoes worn by the subject revealed an additional lift on the left sole which led the examining officers to believe that the individual had been lame.

Sufficient ridge counts having been developed by the process described, the identification officers were enabled to photographically obtain sufficient ridge characteristics to make an identification of the subject. The finger impressions when searched were identified as being those of one John Henry Fisher who had been arrested September 21, 1934, by the Albany Police Department for intoxication. The description revealed him to be 19 years of age, 5' 6", 135 pounds, brown eyes and hair, dark complexion, small build, 3" rectangular scar on forehead, scar through right ear, right arm stiff, and lame in left leg. It is interesting to note the vast difference in the descriptive data sent out over the teletype and the actual description of the man when he was alive.

As in the case of the skeleton heretofore mentioned, this case exemplifies the possibilities in making identification by fingerprints, despite the fact that at first glance the task appears unlikely to be executed successfully. The circumstances necessarily will govern the methods used by the identification officer in enabling him to obtain legible fingerprints. The technique in the identification of dead persons has been ably

set out in an article by Dr. Israel Castellanos, entitled "Dactyloscopic Identification of Cadavers" and should be an aid to identification officers. This article was reproduced in the October, 1935, issue of the FBI Law Enforcement Bulletin. Because of the importance of this phase of an identification officer's work, it is believed that it might be well to set out some further suggestions as to technique which has been employed by officials.

Generally speaking, fingerprint operatives find it necessary to take the impressions of three classes of deceased persons; i. e., those who have died recently, when the process is relatively simple; those where considerable difficulty is experienced either because of pronounced stiffening of the 10 digits, or the early stages of decomposition or both; and those where great difficulty is met because of advanced stages of disintegration, maceration, decomposition, or putrefaction. The problems are discussed separately, as follows:

1. Sometimes when the fingers are entirely flexible it is possible for the experienced operative to secure impressions of a deceased person through the regular inking process on a standard card. However, it is usually found to be more convenient to cut from one card the 10 "squares" of paper pertaining to the 10 digits so each may be "rolled" separately around each digit, thus securing complete impressions without "slipping" or blurring. The back of each square should be numbered carefully to indicate the finger to which it pertains. When the 10 squares are filled, they should be pasted or glued to another card, in their proper positions. The "simultaneous" impressions may be placed on the completed card, if believed to be helpful. Of course, the fingers must be cleaned before the printing operation, as is the case when the subject is alive. It is considered helpful, also, to improvise a tool, similar in appearance to a wide, blunt knife or spatula, and roll thereon a thin film of ink, evenly spread and to use this tool to ink the fingers. While many good impressions are prepared by inking with an ordinary rubber roller, it is believed that better, and more uniform results attend this work when each finger is inked by passing the inked tool around the finger. Use of the tool, of course, eliminates inking from a glass slab or plate, a practice rendered extremely difficult or awkward when pronounced stiffening is developing.

2. This brings our attention to the second phase of our problem. Frequently, the subject's hands are stiff and clenched. Surgical attention, such as the cutting of controlling tendons, may be required to release them, but usually it is possible to insert the squares described under the fingers and thus secure the impressions. This action is aided greatly by means of the employment of another spatula or spoon-shaped tool in which each square is inserted, in turn, in its proper order, the square of paper being held in place by a groove or slot. The "spoon", of course, should have a handle and it should be semicircular in its shape, resembling a piece of three-fourths inch lead pipe about 1 inch long, cut diagonally from end to end. The square thus affixed in the spoon should be impressed gently against the finger, held firmly by the other hand. As the square assumes a semicircular position, since it conforms to the shape of the spoon, a "rolled" impression is easily obtained.

A different problem arises when decay has started. The technique of treating the fingers in such cases varies greatly, depending on the surrounding conditions. It is suggested that the services of a surgeon or embalmer be procured to assist in this work, where, of course, the operative may lack the proper facilities. Frequently, the skin on the corpse is peeling or shrunken, and only pieces or fragments may be had. Soaking in a solution of caustic potash causes the skin to swell. When it seems to have attained its regular appearance, it should be washed quickly in water to prevent possible rupture, and then preserved in an alcohol or formalin solution. Often, the injection of paraffin into the fingers, when the skin is intact and sufficiently firm, will "round out" the bulbs again so they may be inked and printed. In many cases the fingers are amputated for the treating and printing action. These usually require surgical operations, also, and care must be taken in their performance.

3. The third group of cases is the most difficult to handle. Frequently, the skin tissue is so badly decomposed and is so softened that, regardless of careful treatment, particles would adhere to any inking instrument, or only blurred results would follow. The tissue may even be peeling because of decomposition. Such cases may be solved most effectively by forensic radiography or dactyloscopic radiography as it is sometimes called; i. e., photographing by means of X-rays. Briefly, the inner surface of the fingers is covered with heavy salts, such as bismuth or lead carbonate, or a white lead mixture, which fills the depressions only. A radiograph taken of the fingers reflects these depressions as white lines while the friction ridges appear to be black. The characteristic details of the ridges show very plainly in these photographs. The pictures should be mounted on an 8 by 8 card in the usual manner.

It is hoped that the foregoing will be helpful, in particular to operatives to whom fingerprinting of deceased persons represents a new field of endeavor.

THE FACTOR OF AGE IN RELATION TO CRIME

The seriousness of the problem of juvenile delinquency is manifested by records which show that 17 out of every 100 persons arrested during the first seven months of 1936 were under 21 years of age. This fact was gained from the examination of 257,574 arrest records of persons whose fingerprints were forwarded to the Federal Bureau of Investigation during the first seven months of 1936 by State and municipal law enforcement agencies.

During the past four years the Bureau has been making an analysis of fingerprint records covering arrests and throughout this period, until the last half of the calendar year, 1935, arrests of individuals 19 years of age outnumbered those for any other single age group. The arrest records received since June, 1935, reveal a shift in the majority of individuals arrested to the ages of 21, 22, and 23 years. Whether this is attributable to the nineteen-year-old age group continuing their criminal tendencies and becoming second offenders, to the effectiveness of the concerted drive against crime, or to an improvement of economic factors is matter for speculation.

A QUESTIONABLE PATTERN

It is thought that a discussion of the methods of classifying scarred fingerprint patterns may be of particular interest to law enforcement officials at this time. For convenience, scarred patterns have been divided into three general types, one of which is discussed below. The other two are to appear in subsequent issues of the FBI Law Enforcement Bulletin.



Discussion at this time is limited to those patterns when the ridges are so completely scarred as to prevent even approximate classification. Such a pattern is presented above.

Whenever the pattern is so scarred that neither the general type (whorl, loop, arch or tented arch) nor the ridge tracing or counting into the I-O, I-M-O, or S-M-L groups can be determined with reasonable accuracy, the impression is given both the general type and value, and the sub-classification value of the corresponding finger of the other hand. In cases where the opposite finger has been amputated or is itself completely scarred, the patterns are classified arbitrarily as meet whorls, thus making for a higher degree of uniformity in interpretation.

The pattern presented here would of course be given the same classification as the corresponding finger of the other hand. If this finger were itself similarly scarred or amputated then both fingers would be classified as meeting whorls. These patterns should be given appropriate reference searches before filing.

FBI NATIONAL POLICE STATISTICS SHOW DECREASE IN CRIME

Statistics compiled by the FBI covering the calendar years 1933, 1934, and 1935, based upon reports received from the police departments of 1,127 cities with a combined population of 43,920,736, reflect a decrease in the amount of crime committed in those cities.

The most marked decrease occurred in robberies and automobile thefts. For robbery, the figures decreased from 45,925 offenses in 1933 to 33,747 in 1935, a decrease of 12,178, or 26.5%. The daily average of 125.8 robberies in 1933 was cut to 92.5 in 1935. The automobile theft figures show a decrease from 141,603 stolen cars in 1933 to 104,434 in 1935, a decrease of 37,169, or 26.2%. In 1933 in these cities, automobiles were stolen at the rate of 388 per day. In 1935, the daily average was 286.1.

Substantial reductions were also shown for homicide, aggravated assault, and burglary in these cities. In 1933, there were 3,131 murders reported in these cities. In 1935, there were 2,704, representing a decrease of 13.6%. There was a decrease in the number of aggravated assaults of 8.5%, and burglaries were reduced from 167,573 in 1933 to 153,430 in 1935, a decrease of 8.4%. The decrease in larceny was so slight as to be without particular significance. The figures for rape, however, indicate an increase of 15.7% in the reported number of offenses.

The statistics indicate in general that the major portion of the reduction in crime during the years 1933, 1934, and 1935 occurred in cities with more than 100,000 population. However, substantial reductions were also found in many of the smaller communities.

The figures for the first six months of the year 1936 indicate trends which, in general, are similar to those for the year 1935.

Notwithstanding the substantial decrease reflected by the above figures during the past three years, it is estimated that approximately 1,500,000 serious crimes are committed annually in the United States.

OFFENSE AND ARREST RECORD FORMS

In response to numerous inquiries received by the Bureau from local police agencies, there are presented on the following pages forms of the types which may be used in maintaining records of offenses and of persons arrested. The forms presented on the succeeding pages were designed by the Committee on Uniform Crime Records of the International Association of Chiefs of Police and were adopted by that organization in 1929. The forms are shown in Chapter 3 of the manual entitled "Uniform Crime Reporting" where detailed comments concerning their use may be found. Furthermore, that publication includes illustrations of additional record forms such as Supplementary Offense Report, Homicide Report, Report of Stolen Automobile, Detective Assignment Record, Tally Sheets, and Tabulating Cards.

The specimen offense report form presented on the following pages is letter-size (8" x 10½") and the arrest record form is one-half as large (5" x 8"). They are suggested because they are standard sizes and most police agencies already have available filing cabinets which will handle such records. However, the forms can readily be modified both as to size and content so as to suit the needs of the individual agency.

Since the major part of the work of the police department consists in handling complaints of criminal violations, and in arresting criminals, the offense reports and the arrest records naturally constitute a very important part of the police records. However, there are additional records of great importance maintained by police organizations, such as identification records, stolen property records, and a variety of others. Experts in the field of police administration recommend that all records maintained by a police department be centralized in a single Bureau of Records, which should be in charge of a capable and experienced officer. In the Record Bureau there should also be the central complaint desk where complaints may be received from private citizens appearing in person and where individual officers of the department may have access to the information on file in the Record Bureau. The telephone switchboard and the radio transmitter of the department should be located in the Record Bureau so that all telephonic complaints may be received in the central record room and so that emergency matters received over the telephone may be promptly broadcast. The centralization of all records and all communication facilities in the Record Bureau will mean that it will have available all information concerning the activities of the department. This is desirable in order that the activities of all divisions of the organization may be properly directed and coordinated.

The Bureau will be glad to receive inquiries and suggestions concerning this problem.

EVASION OF RAILROAD FARE PRECIPITATES FUGITIVE'S CAPTURE

It is sometimes surprising to see what small things lead to the apprehension of badly wanted fugitives. For instance, take the case of Edward Burke, alias E. J. Miller, alias Edward J. Mulcahy. Burke's known criminal career began in Massachusetts on March 19, 1925, when he was received at the Springfield House of Correction for larceny and possession of a stolen automobile. After being transferred to the Prison Camp and Hospital, he succeeded in effecting his escape on May 14, 1926. However, he was arrested in Philadelphia, Pennsylvania, on July 3, 1926, as a suspicious character and a fugitive, and was returned to the Springfield House of Correction.

A few months later, on September 8, 1926, he again escaped from the Prison Camp and Hospital. Burke next appeared in Tucson, Arizona, on January 22, 1927, where he was arrested as E. J. Miller for the offense of burglary. The Massachusetts authorities were advised of Burke's arrest, but he was not returned due to the fact that he received a sentence of from three to five years to be served in the Arizona State Penitentiary at Florence for the offense of burglary, being received at this institution on January 25, 1927.

On August 8, 1930, information was received in the Bureau that Burke, as E. J. Miller, had escaped once more, this time on August 4, 1930. After this escape, Burke succeeded in avoiding detection for several years and no information concerning him was obtained until the fingerprints of Edward J. Mulcahy were received in the Identification Division on July 28, 1936, from the Police Department at Los Angeles, California. The card reflected that Mulcahy had been taken into custody on July 24, 1936, for evading railroad fare. When searched through the files these fingerprints were found to be identical with those of Miller, wanted as an escape from the Arizona State Penitentiary and a wire was promptly dispatched to the Warden of that institution notifying him of this person's arrest in Los Angeles.

VICTIM OF HIT AND RUN DRIVER IDENTIFIED BY FINGERPRINTS

The fingerprints of an unknown dead person were received in the Identification Division of the Bureau on July 7, 1936, from the Coroner of Weld County, Eaton, Colorado. Information appearing on the card indicated that the deceased had been killed by a hit-and-run driver and had nothing on his person by which he could be identified.

These prints were searched through the files of the Identification Division and found to be identical with those of Charles W. Wenzel, whose criminal record dated back to 1916, when he was arrested on June 30th by the Police Department at Fort Wayne, Indiana, on charges of loitering and suspicion. As Charles Webber he was arrested by the police at South Bend, Indiana, on April 2, 1930, for the offense of forgery. He was turned over to the authorities of Rome City, Indiana, for trial and subsequently received at the State Penitentiary, Michigan City, Indiana, on June 22, 1920, to

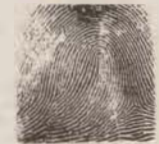

On March 6, 1924, he was received at the State House of Correction and Branch Prison at Marquette, Michigan, to serve from fifteen to thirty years for armed robbery. He was transferred to the State Penitentiary at Jackson, Michigan, on November 21, 1929.

Wenzel's last contact with the law before his death was at Jamestown, North Dakota, where he was arrested by the Sheriff on April 24, 1936, for vagrancy and given a sentence of fifteen days. It will be noted that Wenzel had nothing on his person to identify him at the time of his death and would probably have been buried as an unknown but for the fact that his fingerprints were on file in the Identification Division of the Bureau.

FINGERPRINTS TAKEN AS RESULT OF SERIOUS AUTOMOBILE ACCIDENT IDENTIFY ESCAPED CONVICT

But for the fact that he was struck and critically injured by an automobile, Timothy Burke, escaped convict, might still have been at large today. Burke was received at Auburn Prison, Auburn, New York, on April 5, 1923, to serve from ten to twenty years for first degree robbery. His record in the Identification Division of the Bureau disclosed one prior arrest by the police at Hoboken, New Jersey, on March 23, 1922, as a disorderly person, for which offense he received a sentence of sixty days in the Hudson County Penitentiary.

On July 29, 1928, Burke succeeded in effecting his escape from the Prison Road Camp at Great Meadow Prison, to which he had been transferred. A circular was published offering a reward of \$50.00 for his arrest. A wanted notice was also placed against his file in the Bureau. However, Burke managed to remain under cover until July 22, 1936. On that day, the fingerprints of an unidentified injured man were received in the Bureau from the Hudson County Police Department of Jersey City, New Jersey. A notation appearing on the card indicated that the unidentified man had been struck and critically injured by an automobile and was being treated at the Jersey City Medical Center, Jersey City, New Jersey.

When searched through the files of the Identification Division, these fingerprints were found to be identical with those of Timothy Burke, escaped convict. Wires were promptly directed to the chief of the Hudson County Police and to the Commissioner of the Department of Correction at Albany, New York, advising them of the identity of the injured man.

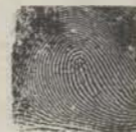

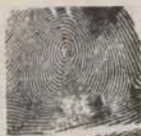

OFFENSES KNOWN TO THE POLICE, JUNE AND JULY, 1936

In order to make available current information regarding fluctuation in the amount of crime in the United States, there is presented in the following tabulation the number of major offenses reported for June and July 1936, by the police departments of 65 cities with more than 100,000 inhabitants, having a combined population of 20,206,012. The figures are also presented in the form of daily averages. In view of the difference in the number of days in those two months, it is recommended that the daily averages be used in making comparisons in the amount of crime reported for those two months.

The compilation discloses decreases during July in the daily average number of offenses of murder, manslaughter by negligence, robbery, assault, larceny and auto theft. A slight increase was shown during July for rape and burglary.

FBI SURVEY OF PRACTICABILITY OF SOUND MOTION PICTURES IN CRIMINAL IDENTIFICATION.

On May 27, 1936, Colonel H. Norman Schwarzkopf, the then Superintendent of the New Jersey State Police, arranged for a demonstration of sound moving pictures as a means of identifying criminals. The demonstration was witnessed by a group of local, state, and Federal law-enforcement officials and executives, including representatives of the Federal Bureau of Investigation.

Following the demonstration, Colonel Schwarzkopf suggested that the Federal Bureau of Investigation conduct further inquiries relative to the practicability of the use of the sound motion picture identification system in crime detection. Prior to conducting any elaborate technical tests to determine the adaptability of this system for the purpose indicated, the Federal Bureau of Investigation requested the views of a number of law-enforcement officials who attended the demonstration, for the purpose of ascertaining whether such a system was considered by them to be applicable to police work. These inquiries have been concluded and with very few exceptions the experienced law-enforcement officials contacted have indicated that in their opinion the system is not a practicable one because of the costs involved and also because of certain mechanical and other objections to this method of identification.

At the demonstration at Trenton, New Jersey, it was publicly stated that the cost to an individual police department of the equipment required for initiating the sound motion picture method of identifying criminals would amount to approximately \$15,000 and that the cost of photographing each individual criminal in connection with the system would be approximately \$50. This cost would not include the necessary facilities for maintenance and storage purposes and the cost indicated would not include extra copies of the film in any individual case.

Several of the law-enforcement officials contacted by the Federal Bureau of Investigation pointed out that the proposed pictures would materially diminish in value after a period of years; others pointed out that the failure of cooperation on the part of the criminal being photographed would serve to reduce the value of the picture for identification purposes, due to his unwillingness to assume natural poses and to speak in a natural tone of voice; others stated they would much prefer to have still photographs of a fugitive so that individual officers might carry such photographs rather than to trust to memory of a motion picture reflecting the appearance of the individual criminal; practically all of the law-enforcement officials referred to the cost as entirely prohibitive for practically all police departments. None of the police officials with whom the Federal Bureau of Investigation communicated is willing at this time to state that he would recommend the installation of this equipment for his own department.

In view of the foregoing information which has been developed concerning this sound identification project, the Federal Bureau of Investigation does not consider it advisable to incur the expense necessary for further experimentation at this time.
